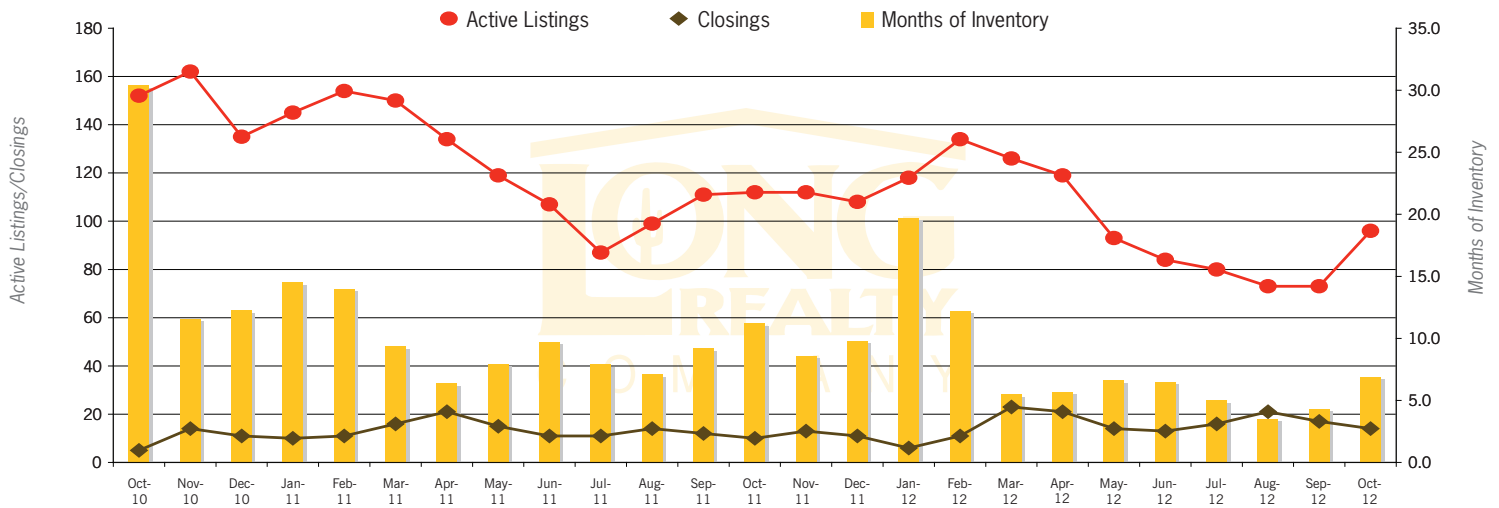

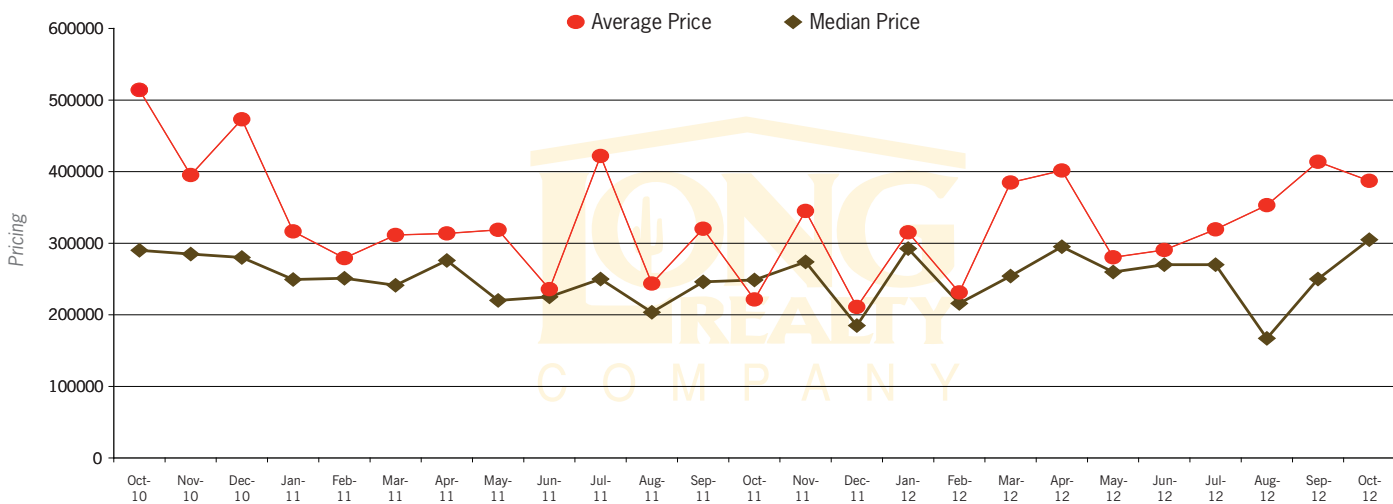
As of October 2012 active inventory was 96, a 14% decrease from October 2011. There were 14 closings in October 2012, 40% above October 2011. Months of Inventory was 6.9, down from 11.2 in October 2011. Median price of sold homes was \$305,000 for the month of October 2012, up 23% from October 2011. The Dove Mountain area had 19 new properties under contract in October 2012, up 36% from October 2011.

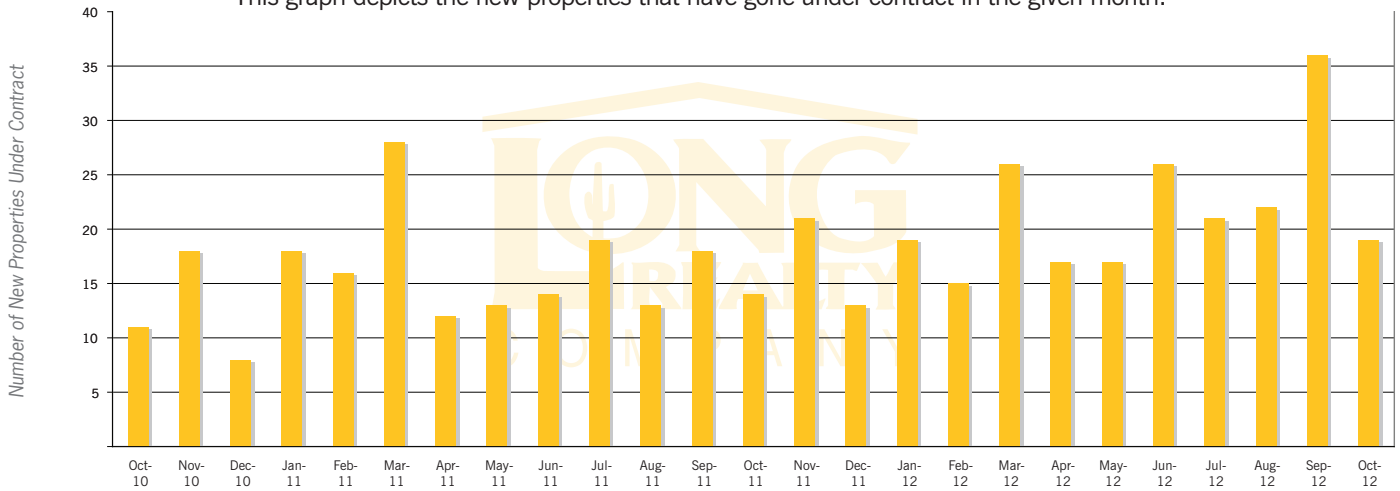

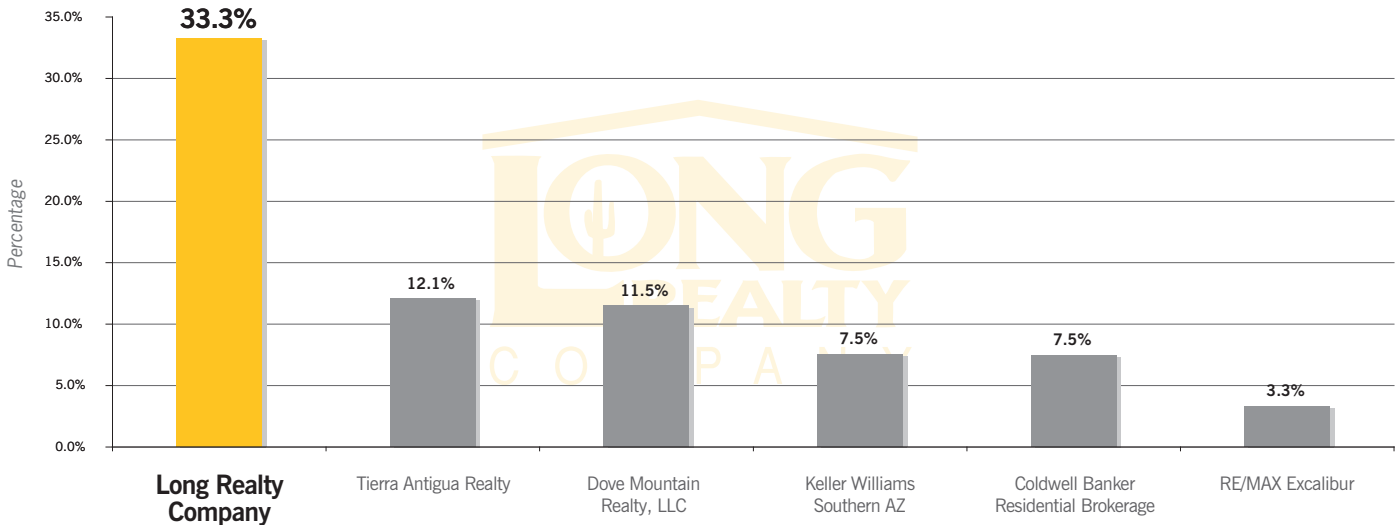
New Properties Under Contract

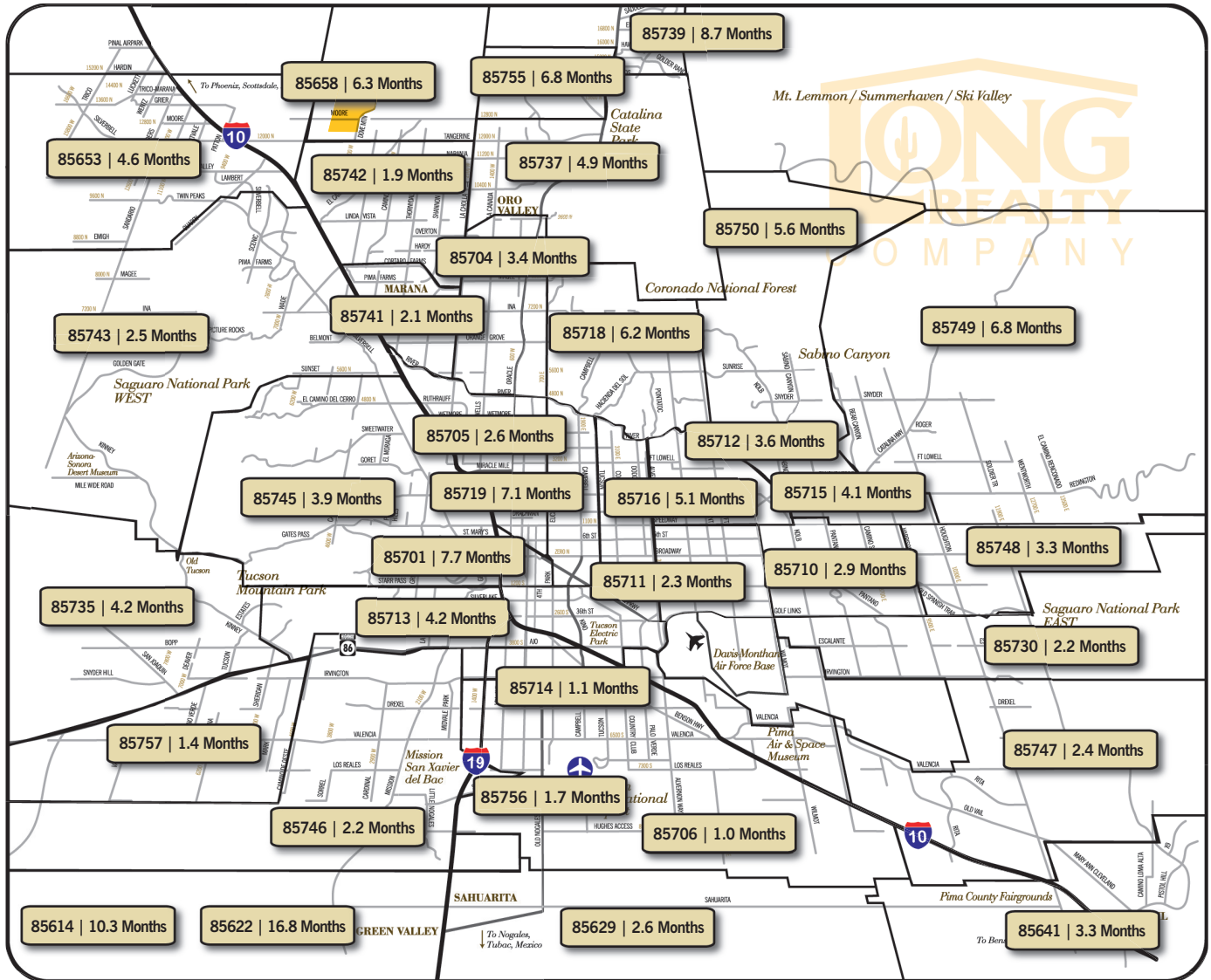

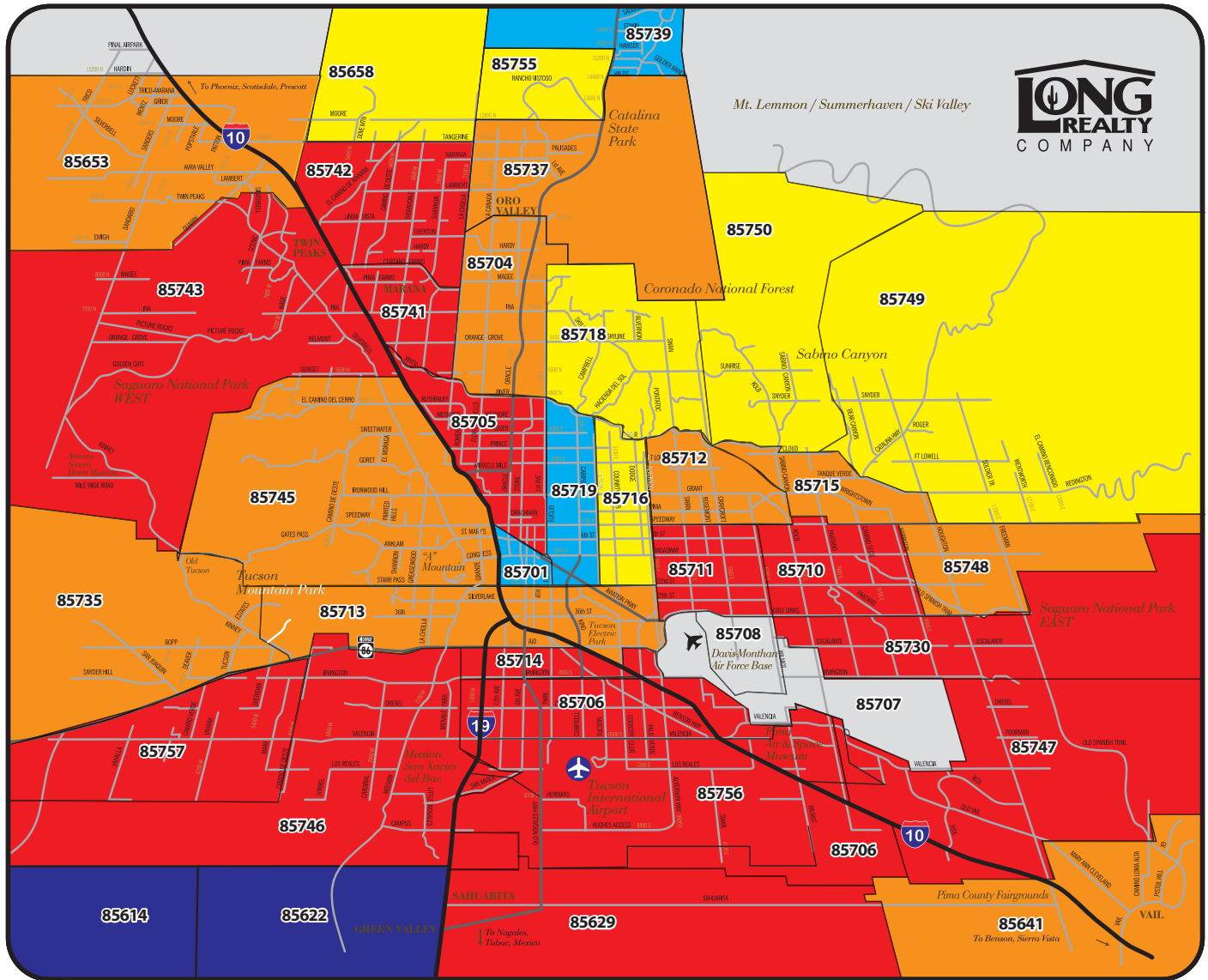
