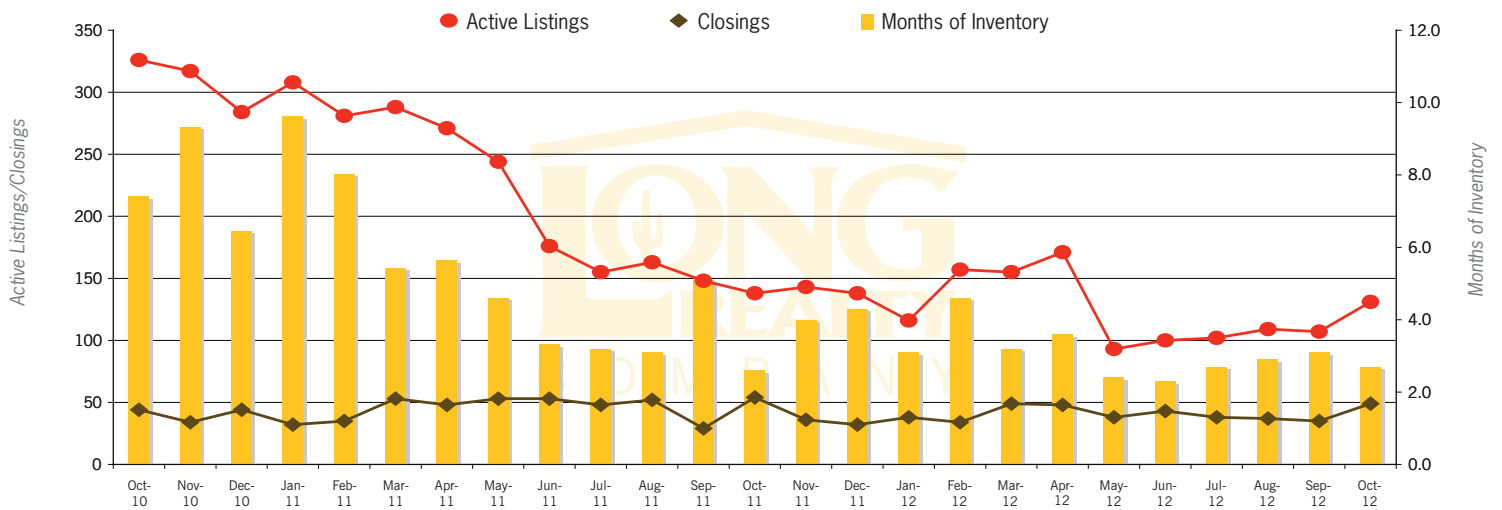

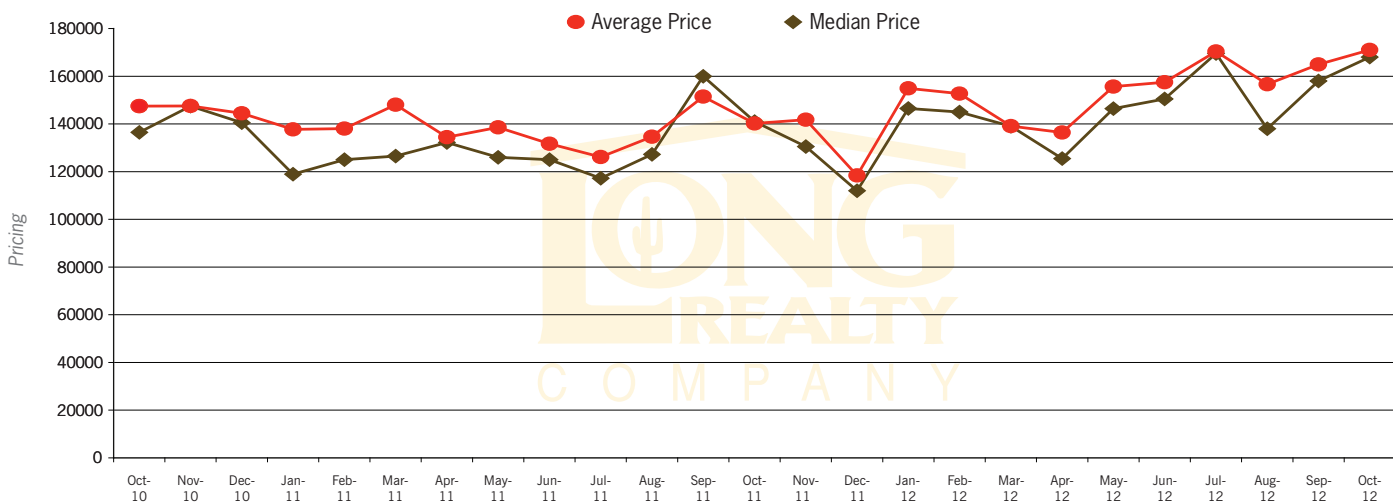
As of October 2012 active inventory was 131, a 5% decrease from October 2011. There were 49 closings in October 2012, 9% below October 2011. Months of Inventory was 2.7, up from 2.6 in October 2011. Median price of sold homes was \$168,000 for the month of October 2012, up 19% from October 2011. Sahuarita had 50 new properties under contract in October 2012, down 25% from October 2011.

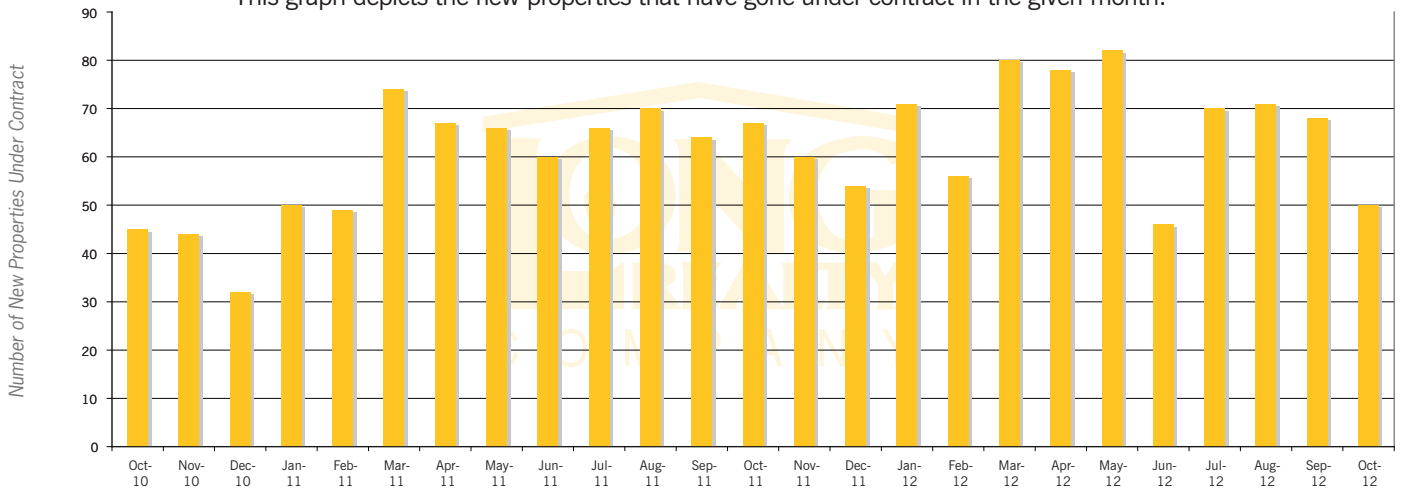

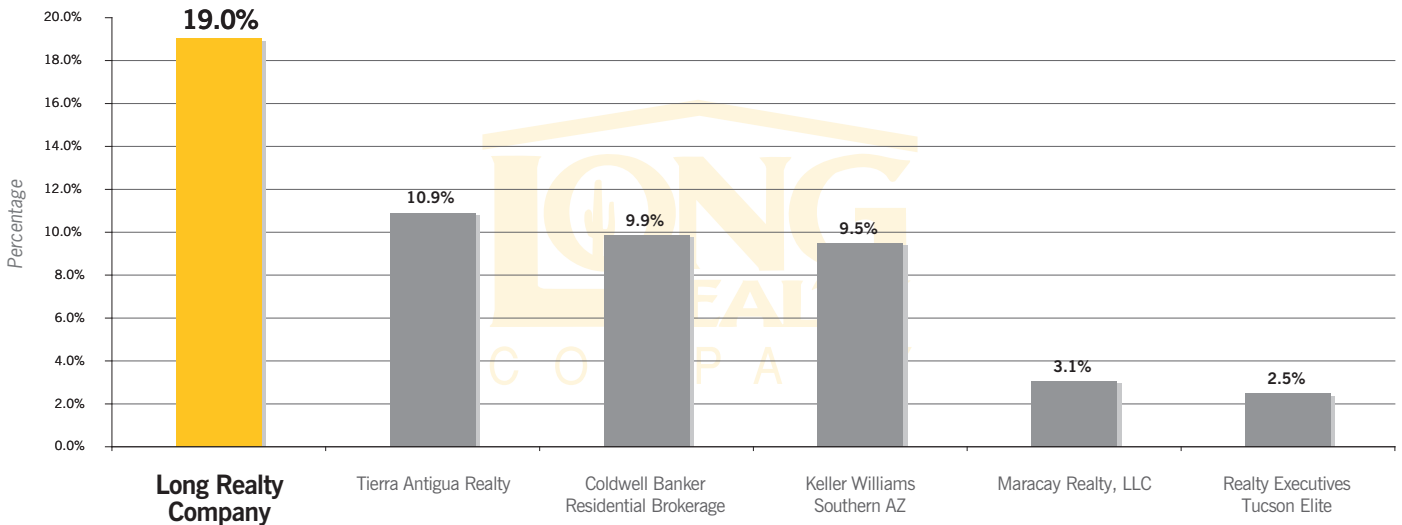
New Properties Under Contract

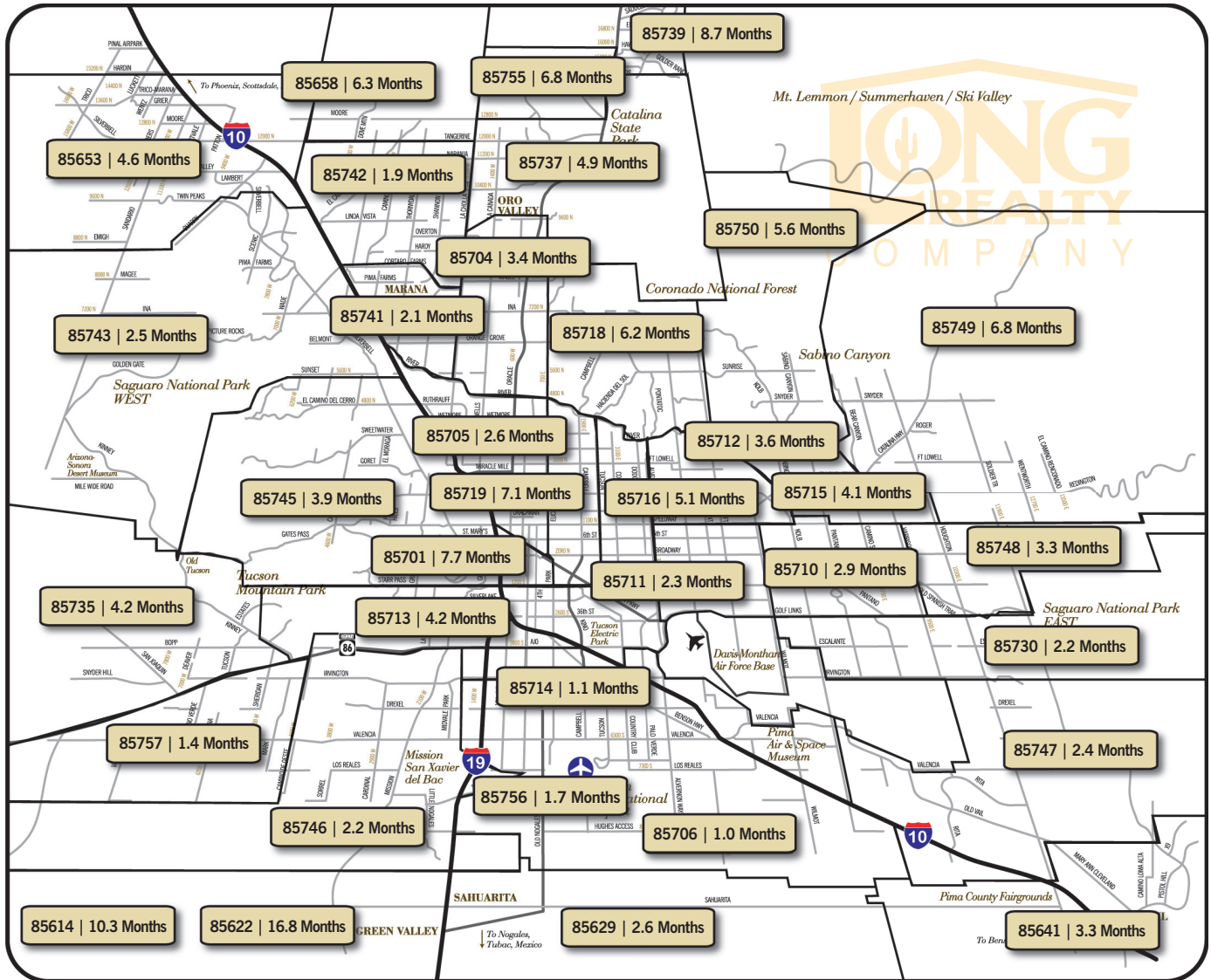

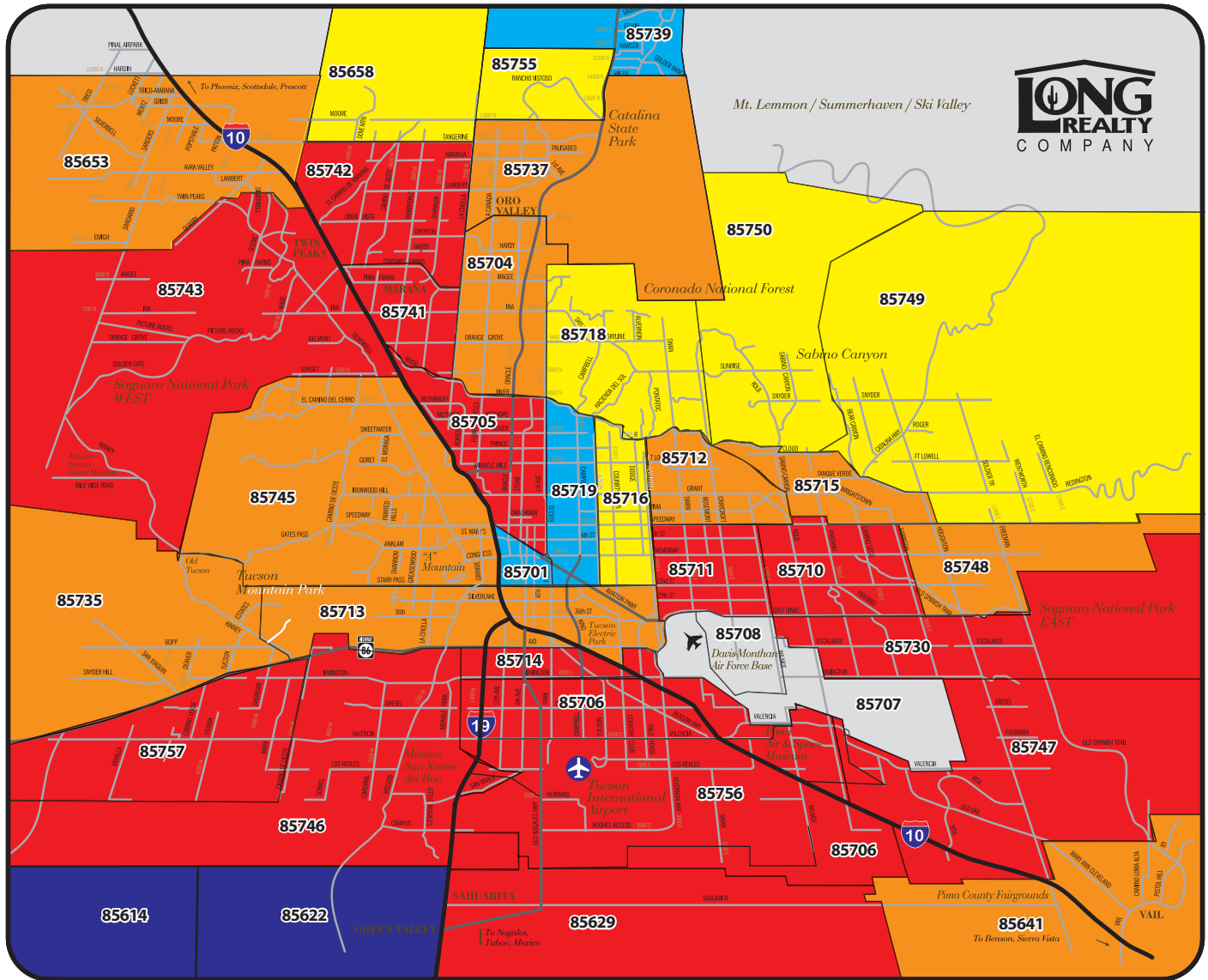
