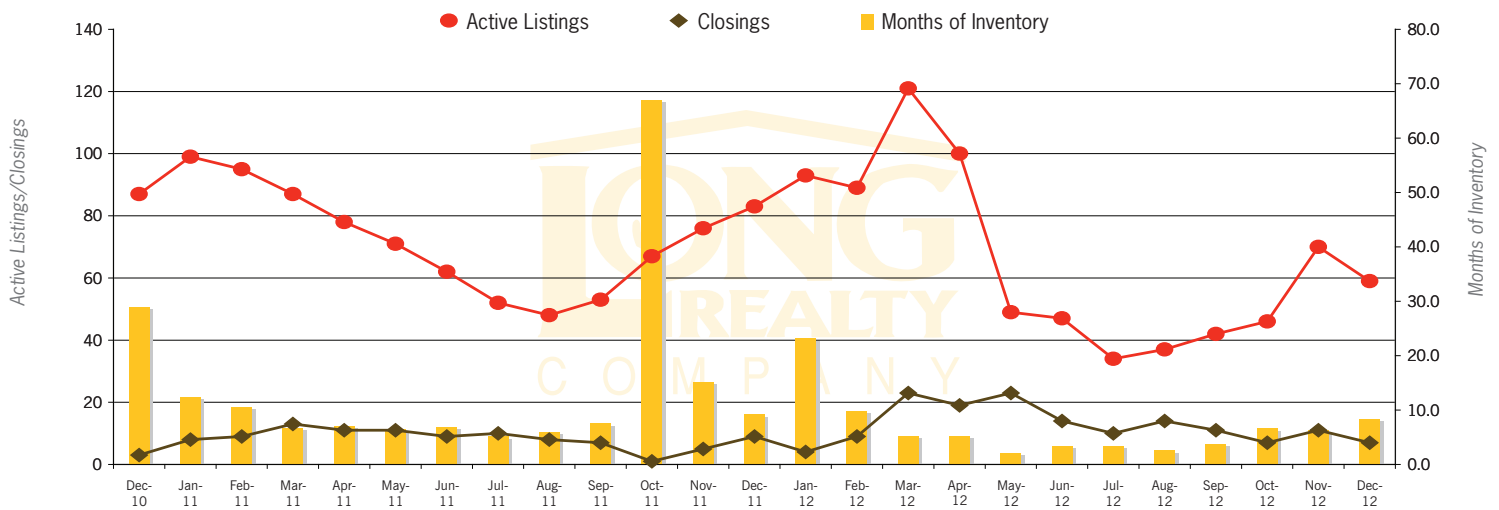

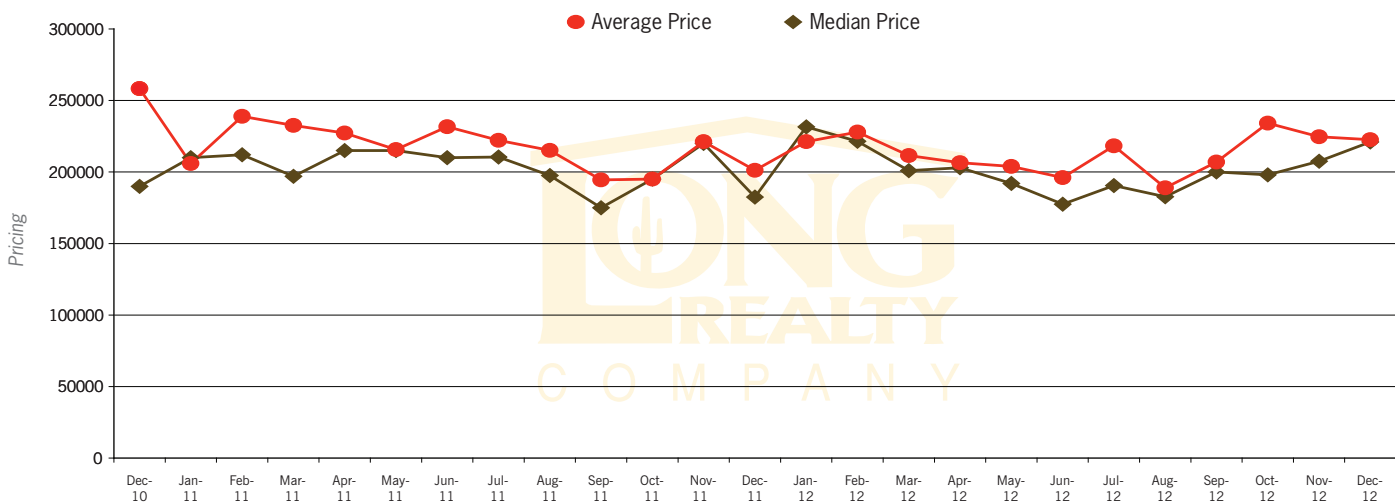
As of December 2012 active inventory was 59, a 29% decrease from December 2011. There were 7 closings in December 2012, 22% below December 2011. Months of Inventory was 8.6, down from 9.2 in December 2011. Median price of sold homes was \$221,000 for the month of December 2012, up 21% from December 2011. Sun City Oro Valley had 16 new properties under contract in December 2012, up 167% from December 2011.

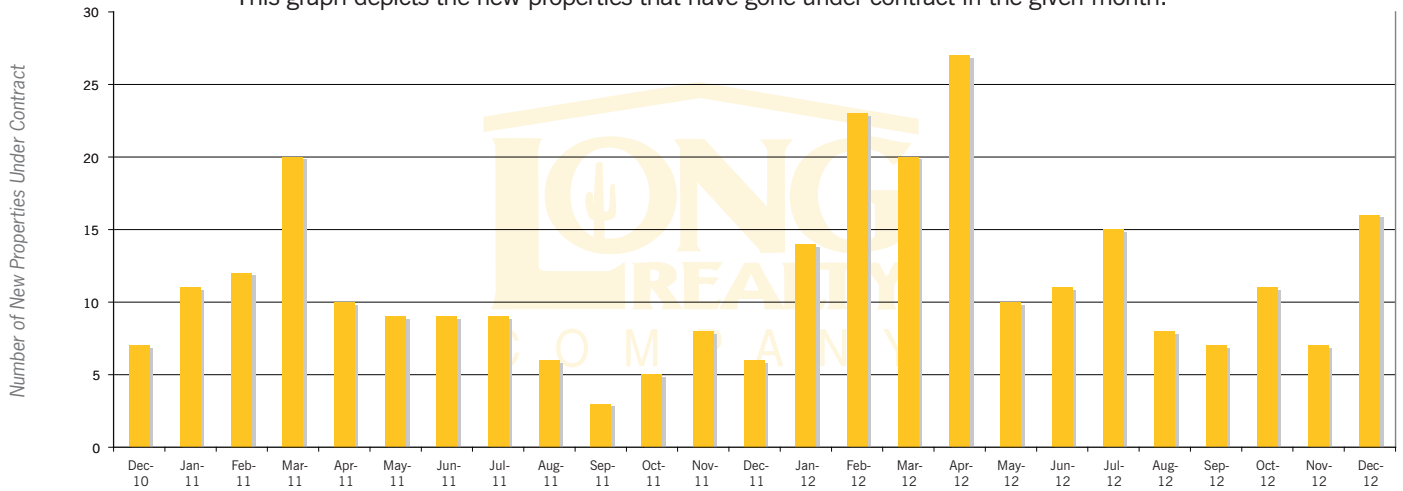

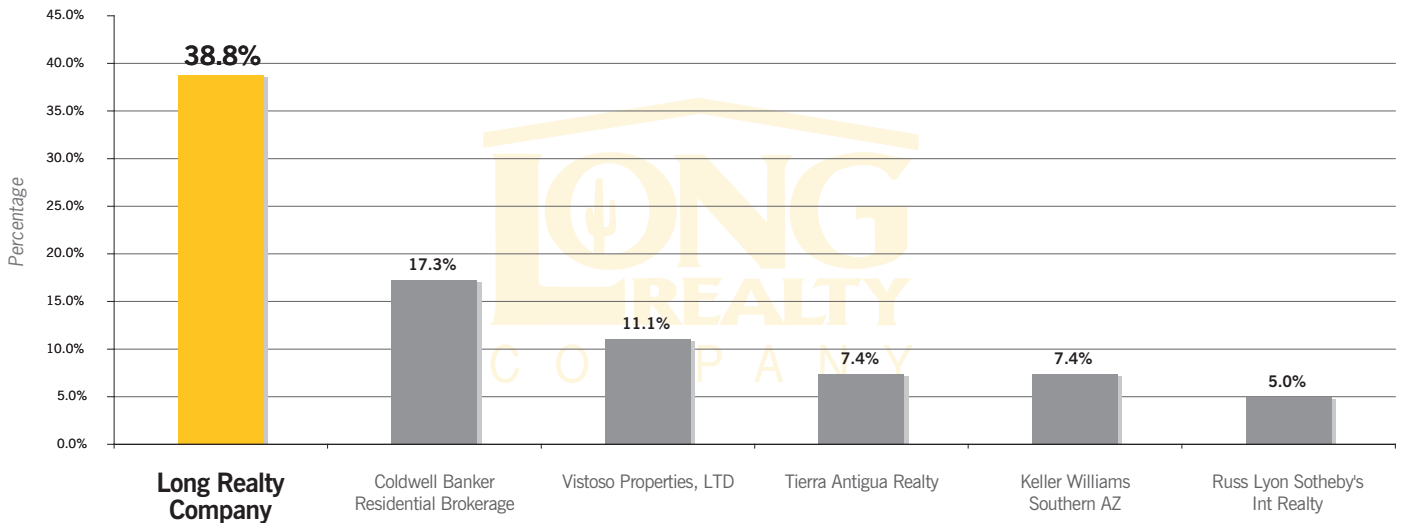
New Properties Under Contract

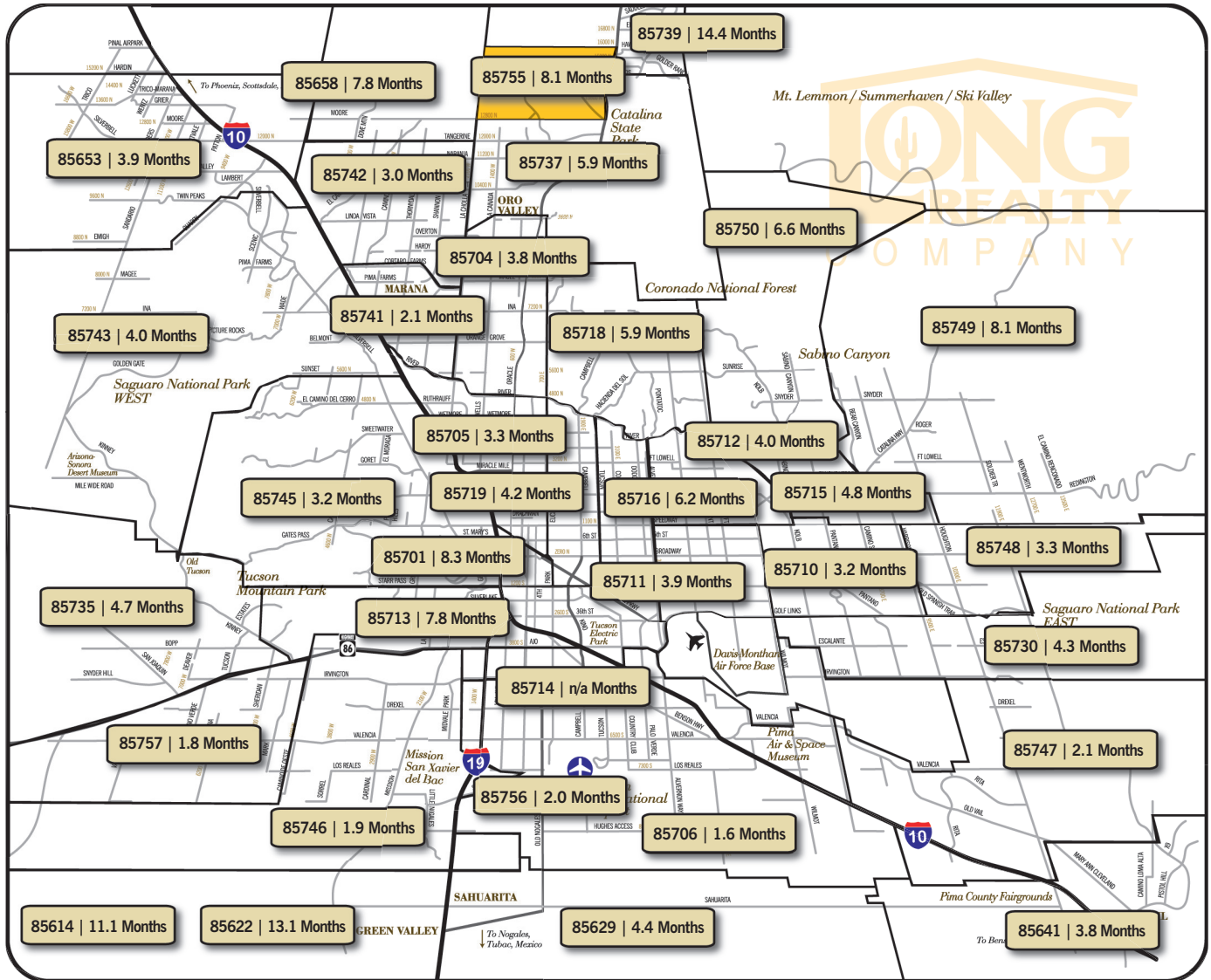

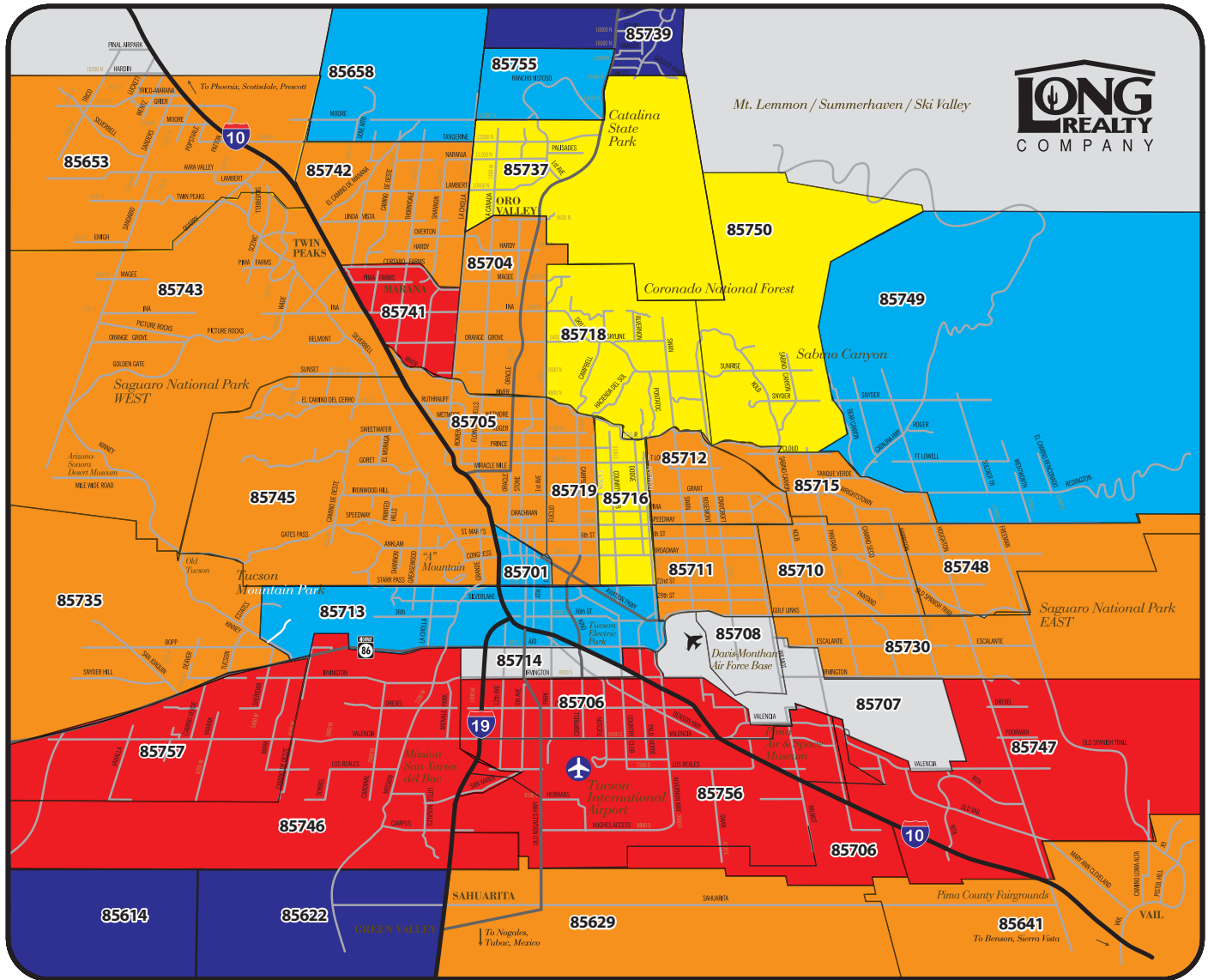
