

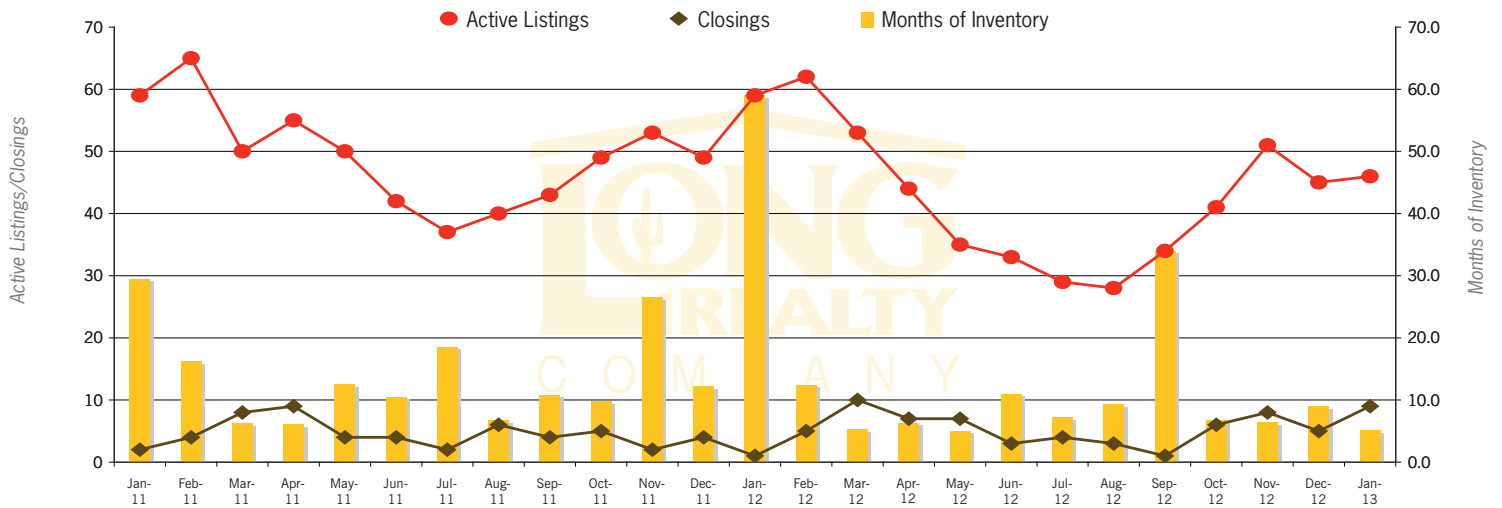

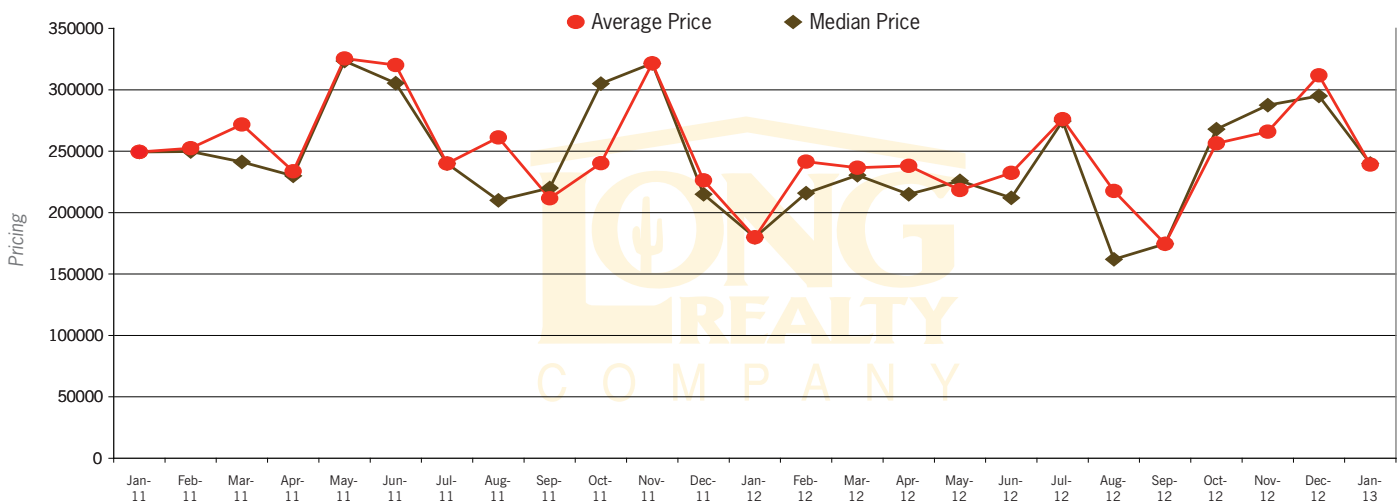
As of January 2013 active inventory was 46, a 22% decrease from January 2012. There were 9 closings in January 2013, 800% above January 2012. Months of Inventory was 5.1, down from 59.0 in January 2012. Median price of sold homes was \$240,000 for the month of January 2013, up 33% from January 2012. Heritage Highlands had 11 new properties under contract in January 2013, up 120% from January 2012.

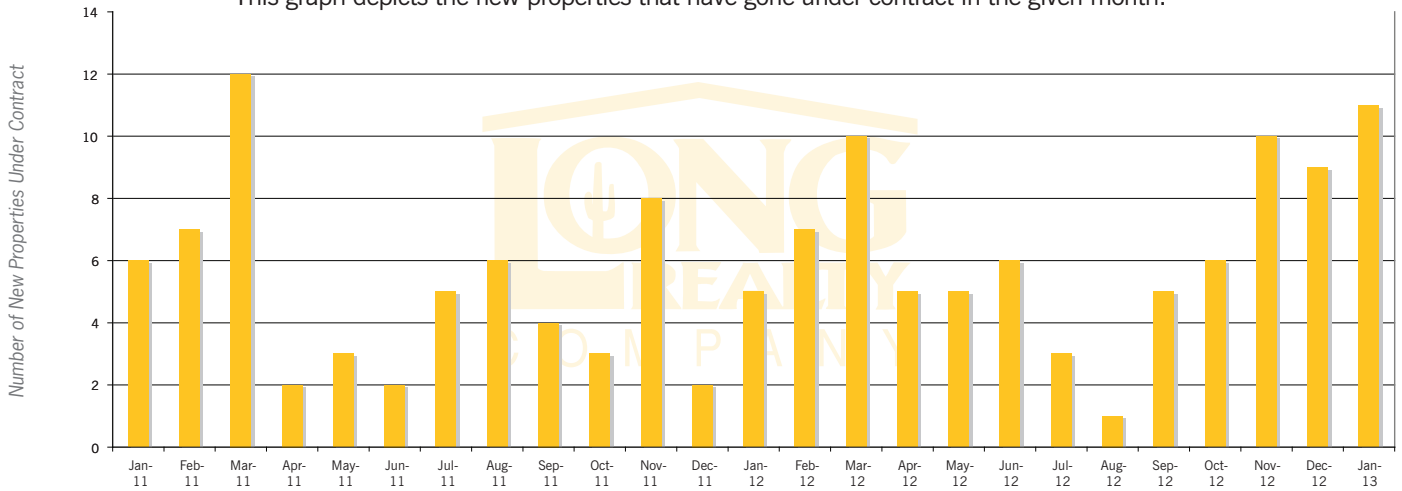

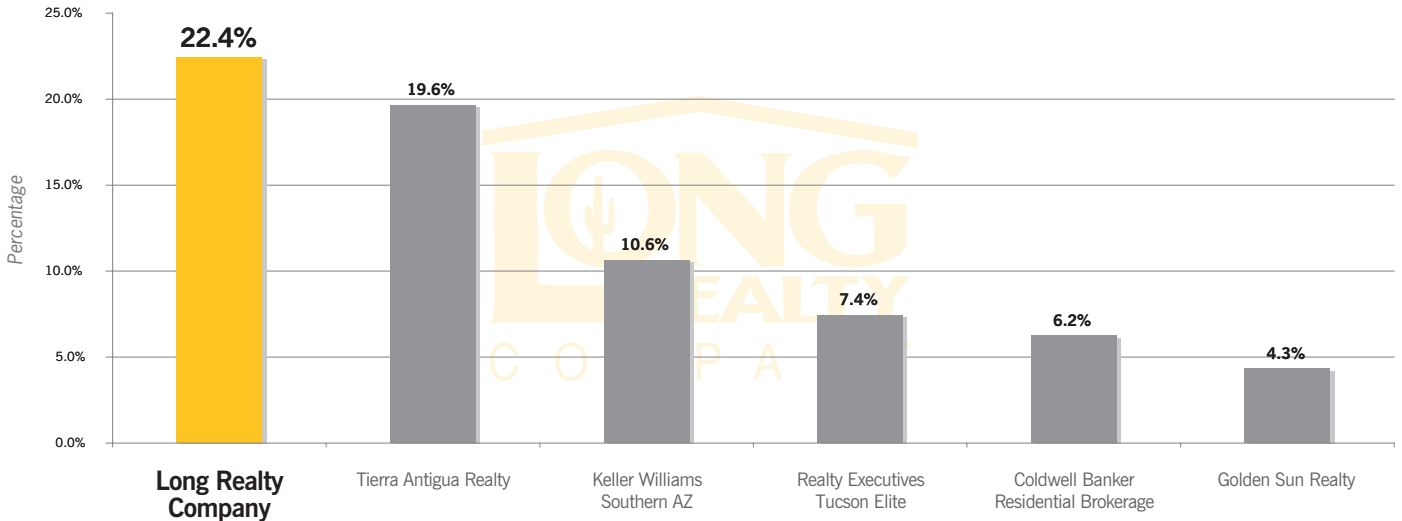
New Properties Under Contract

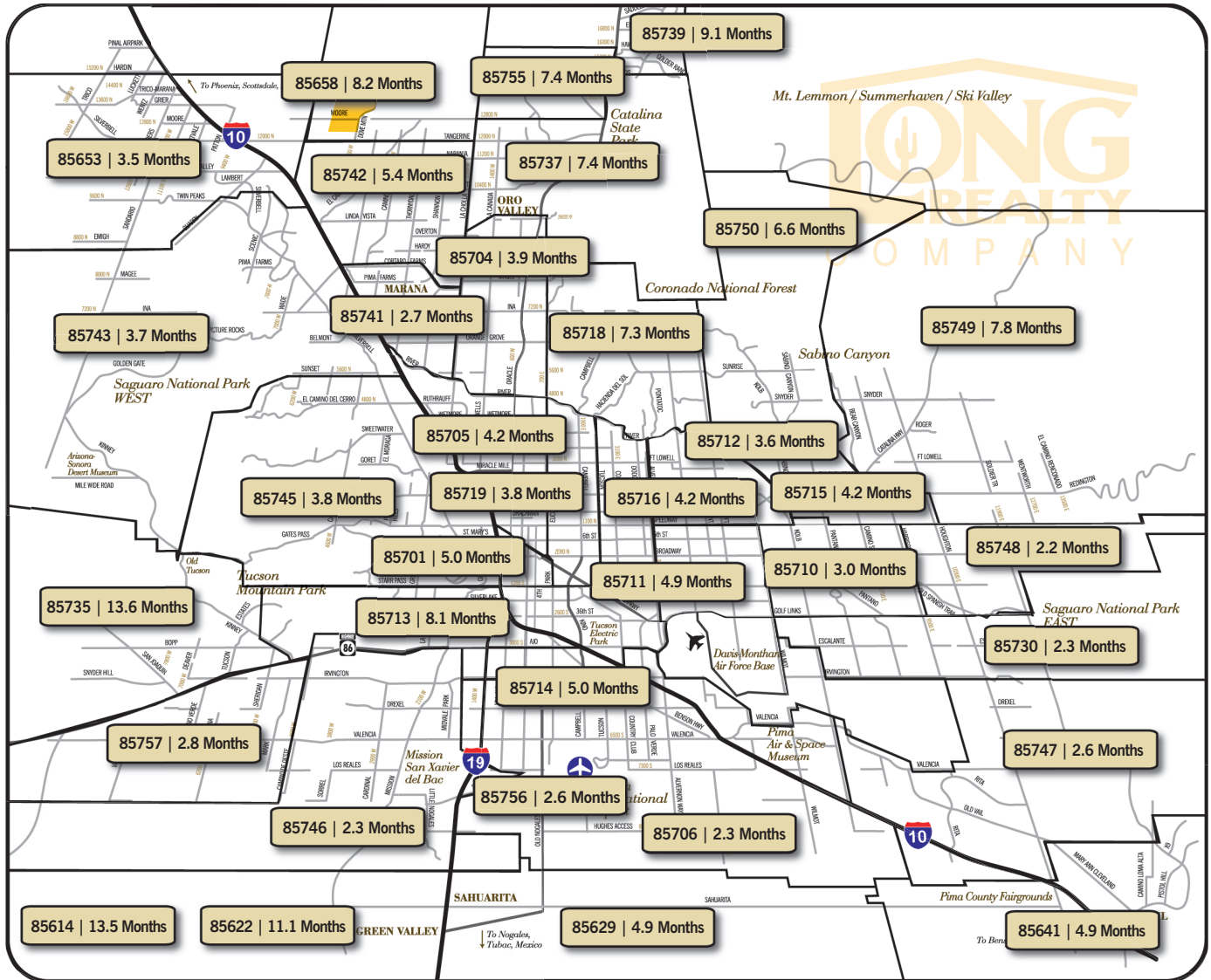

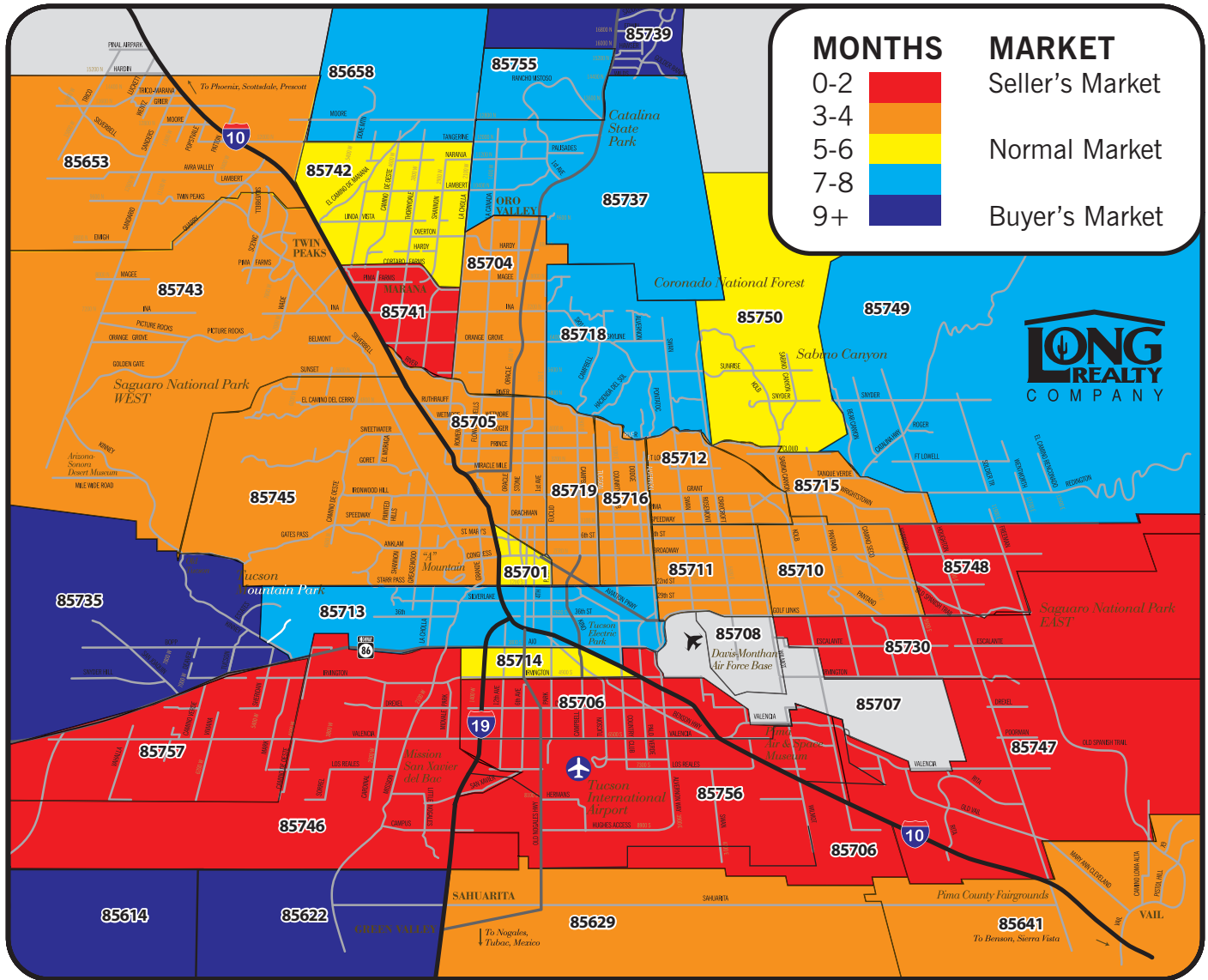
