

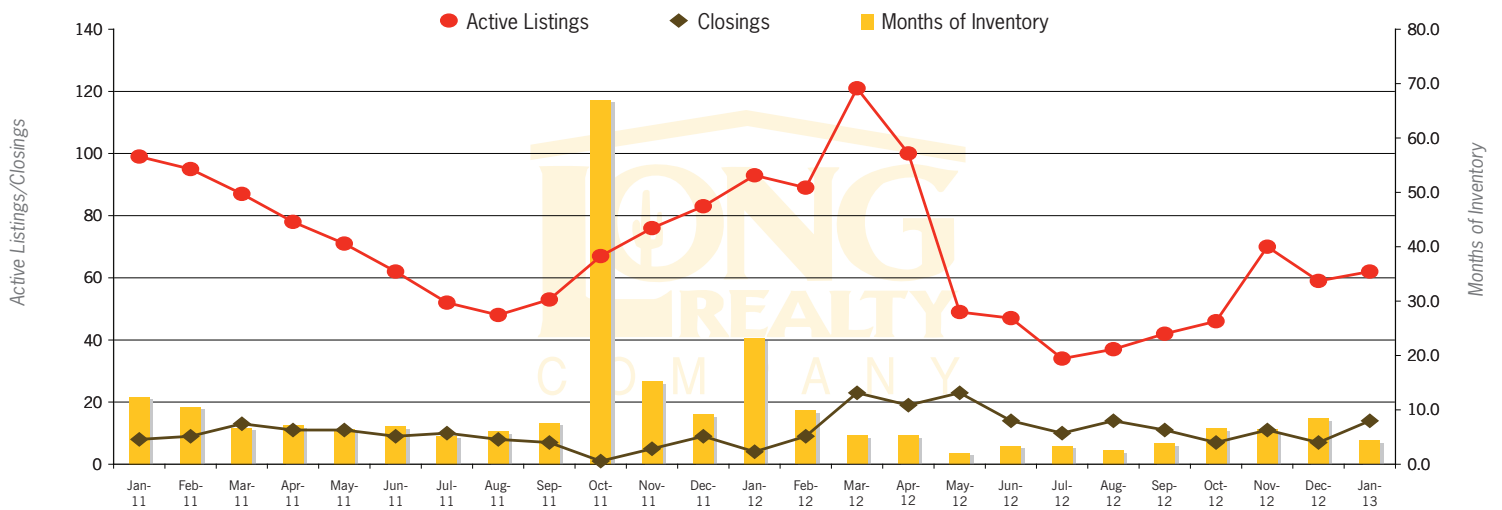

## Sun City Oro Valley | February 2013

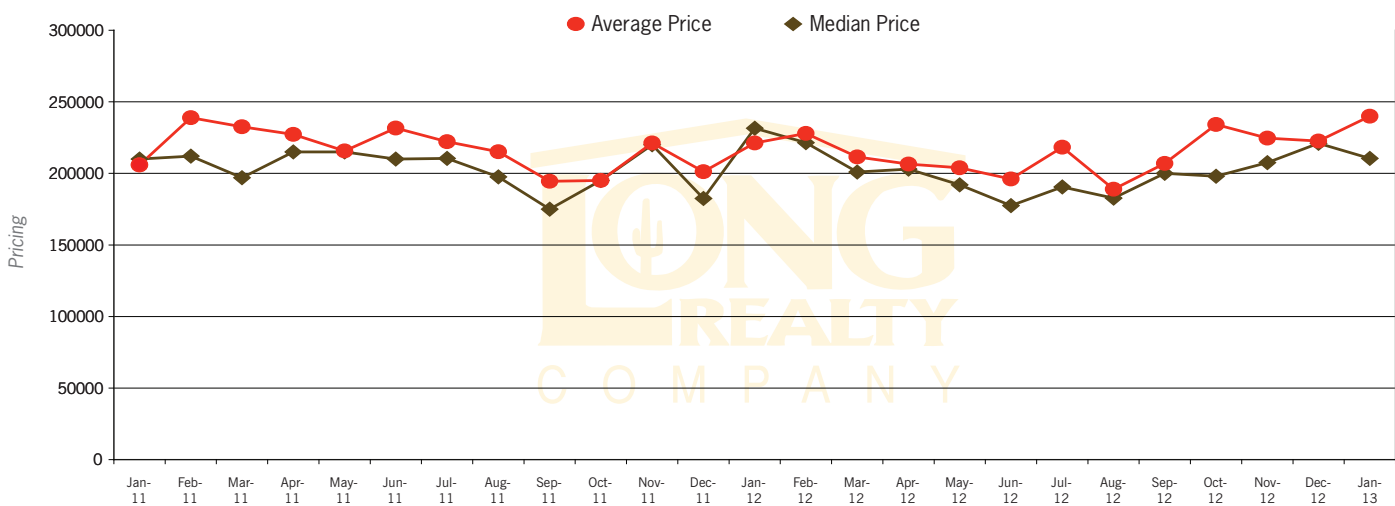
As of January 2013 active inventory was 62, a 33% decrease from January 2012. There were 14 closings in January 2013, 250% above January 2012. Months of Inventory was 4.4, down from 23.2 in January 2012. Median price of sold homes was \$210,500 for the month of January 2013, down 9% from January 2012. Sun City Oro Valley had 18 new properties under contract in January 2013, up 29% from January 2012.

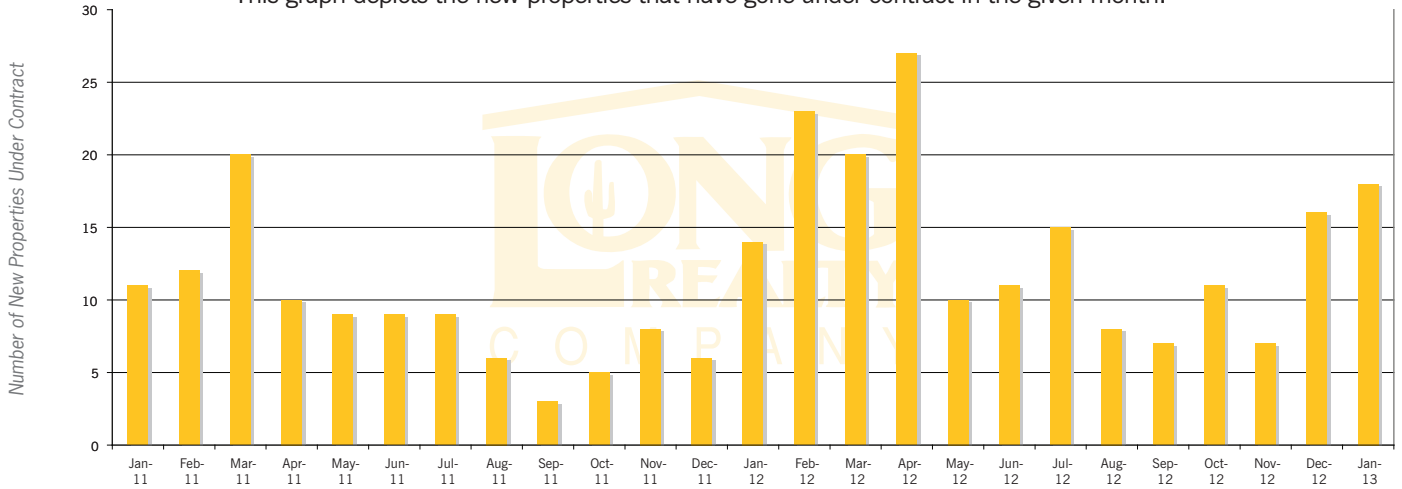

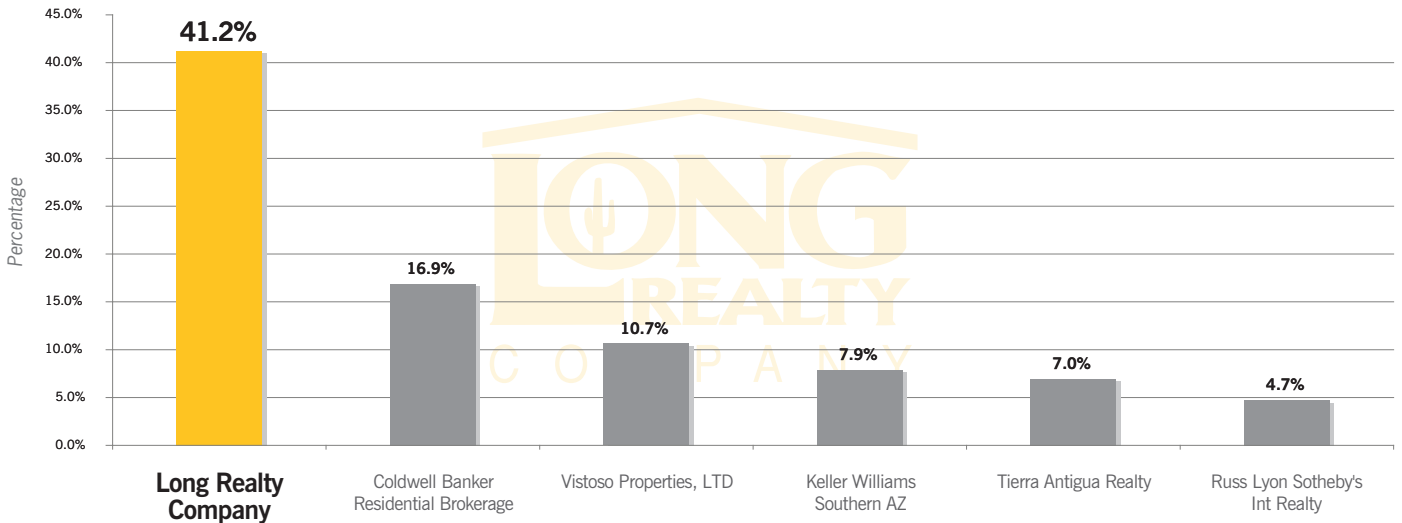
## New Properties Under Contract

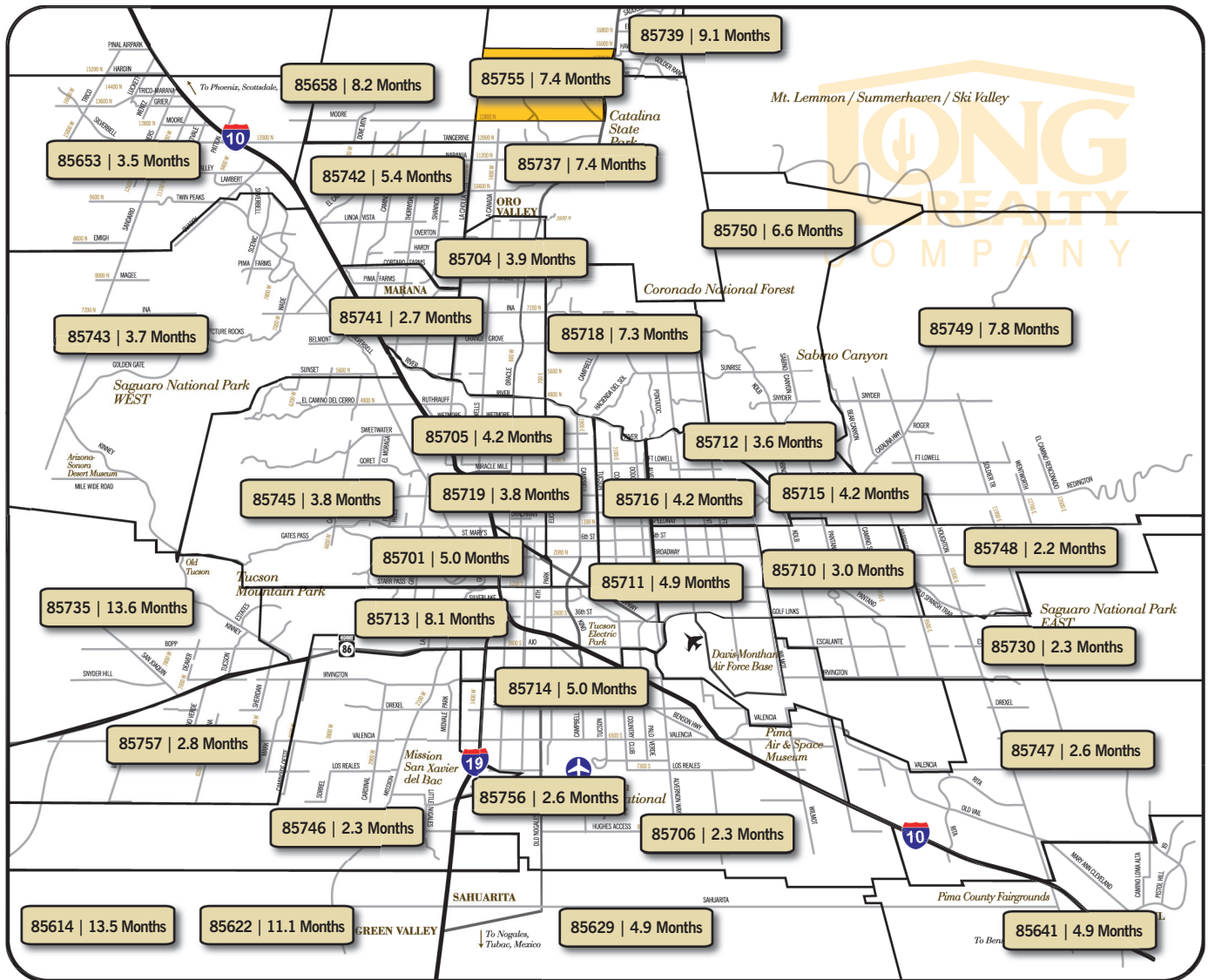

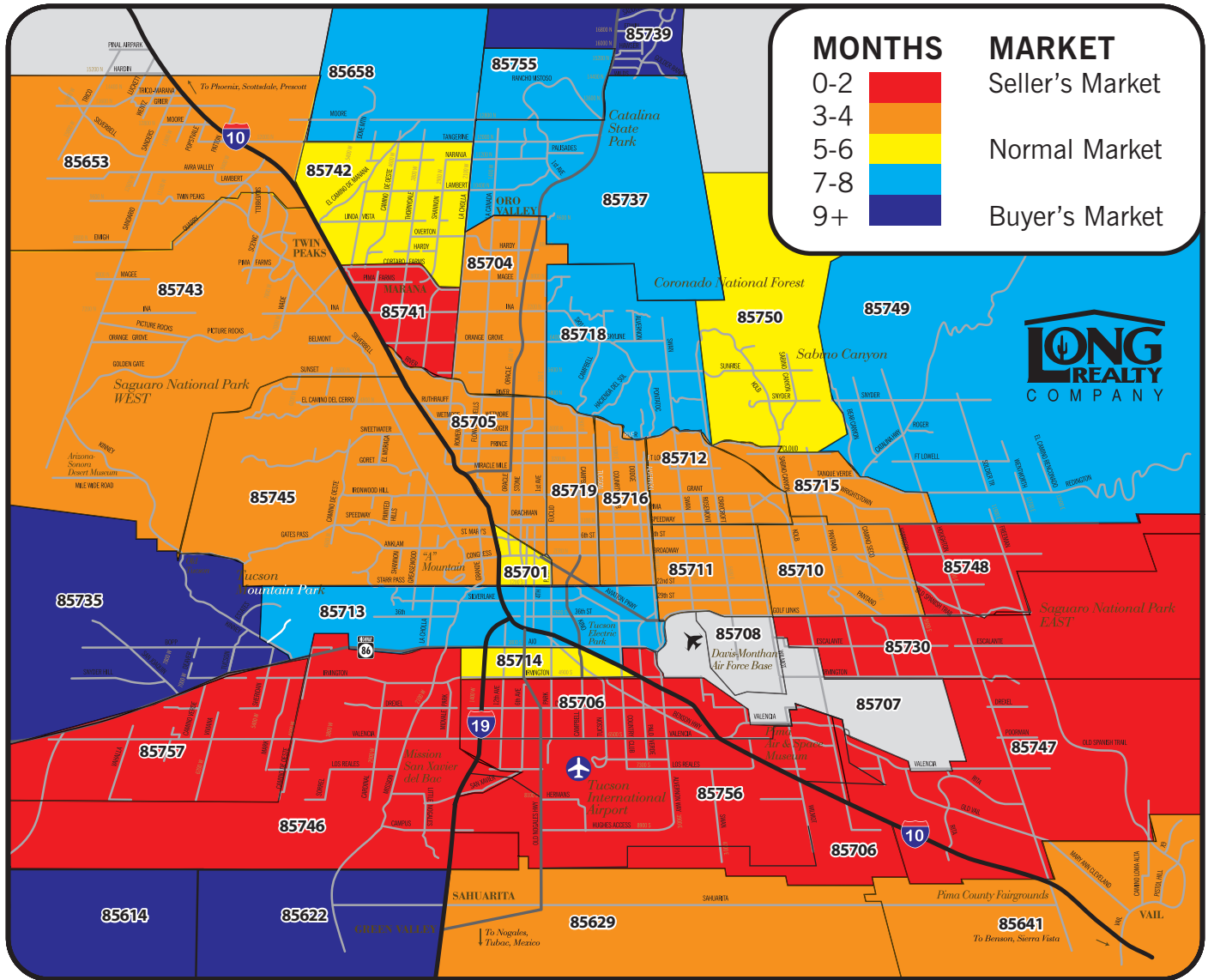
