

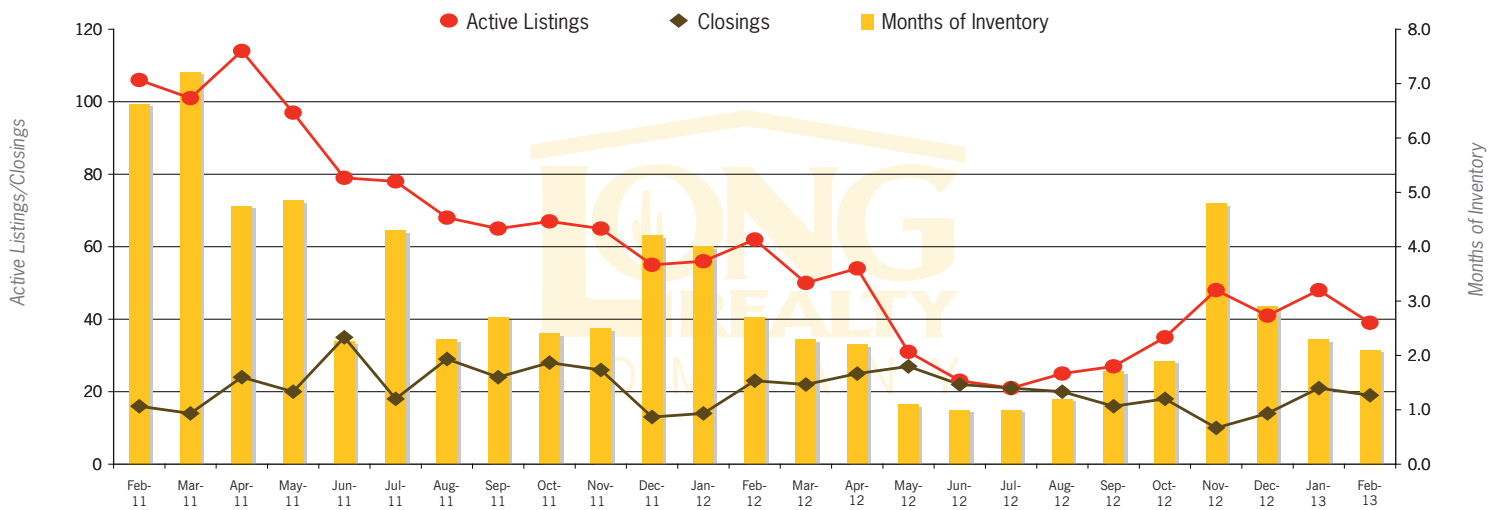

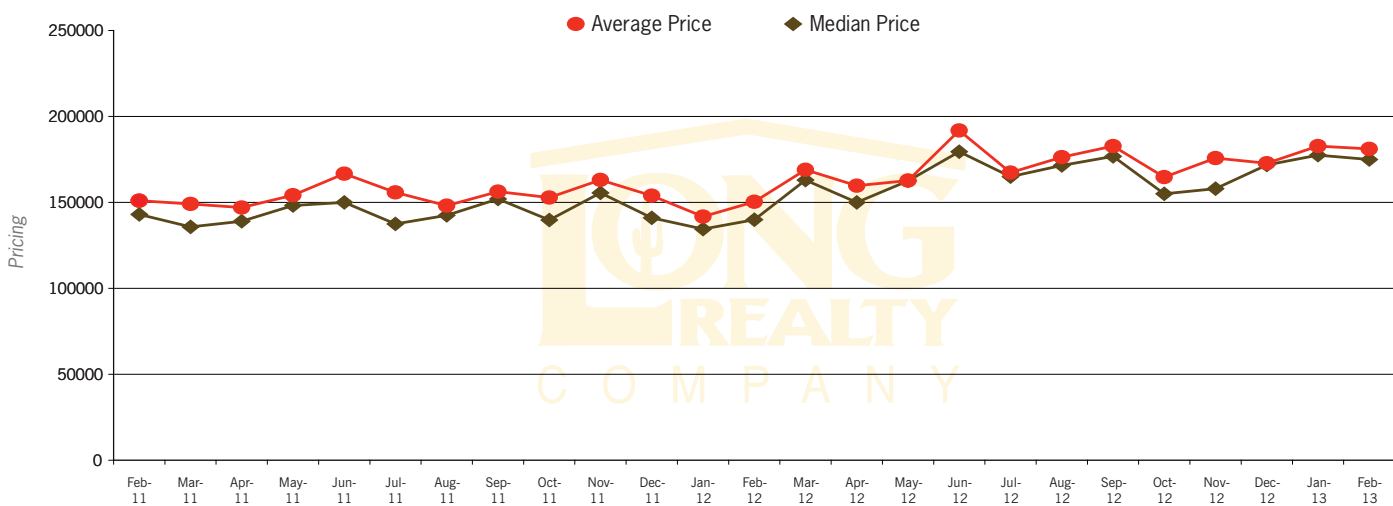
As of February 2013 active inventory was 39, a 37% decrease from February 2012. There were 19 closings in February 2013, 17% below February 2012. Months of Inventory was 2.1 down from 2.7 in February 2012. Median price of sold homes was \$175,000 for the month of February 2013, up 25% from February 2012. The Continental Ranch area had 35 new properties under contract in February 2013, up 21% from February 2012.

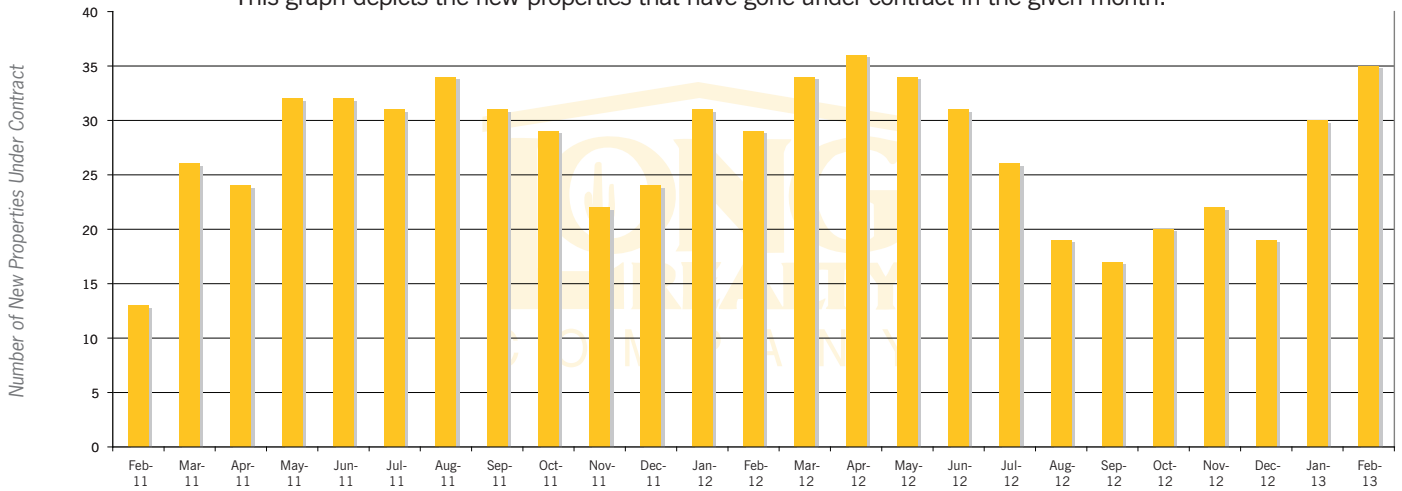

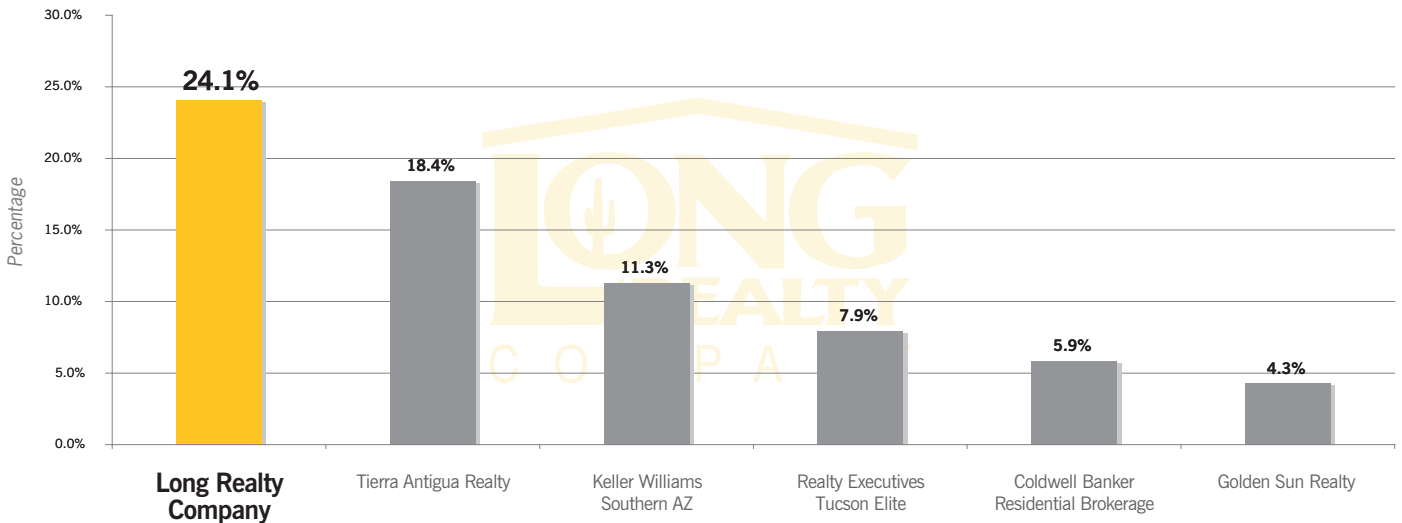
New Properties Under Contract

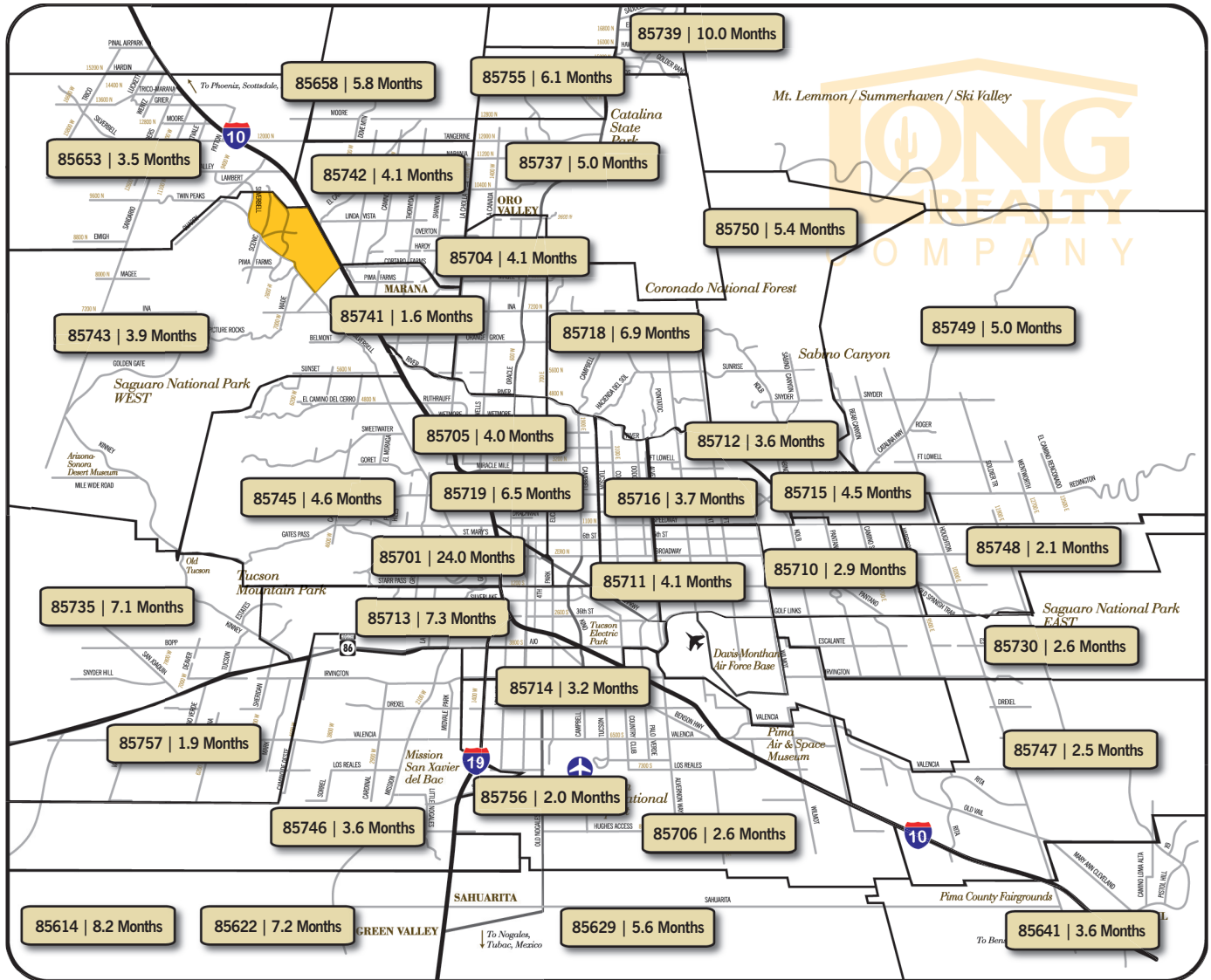

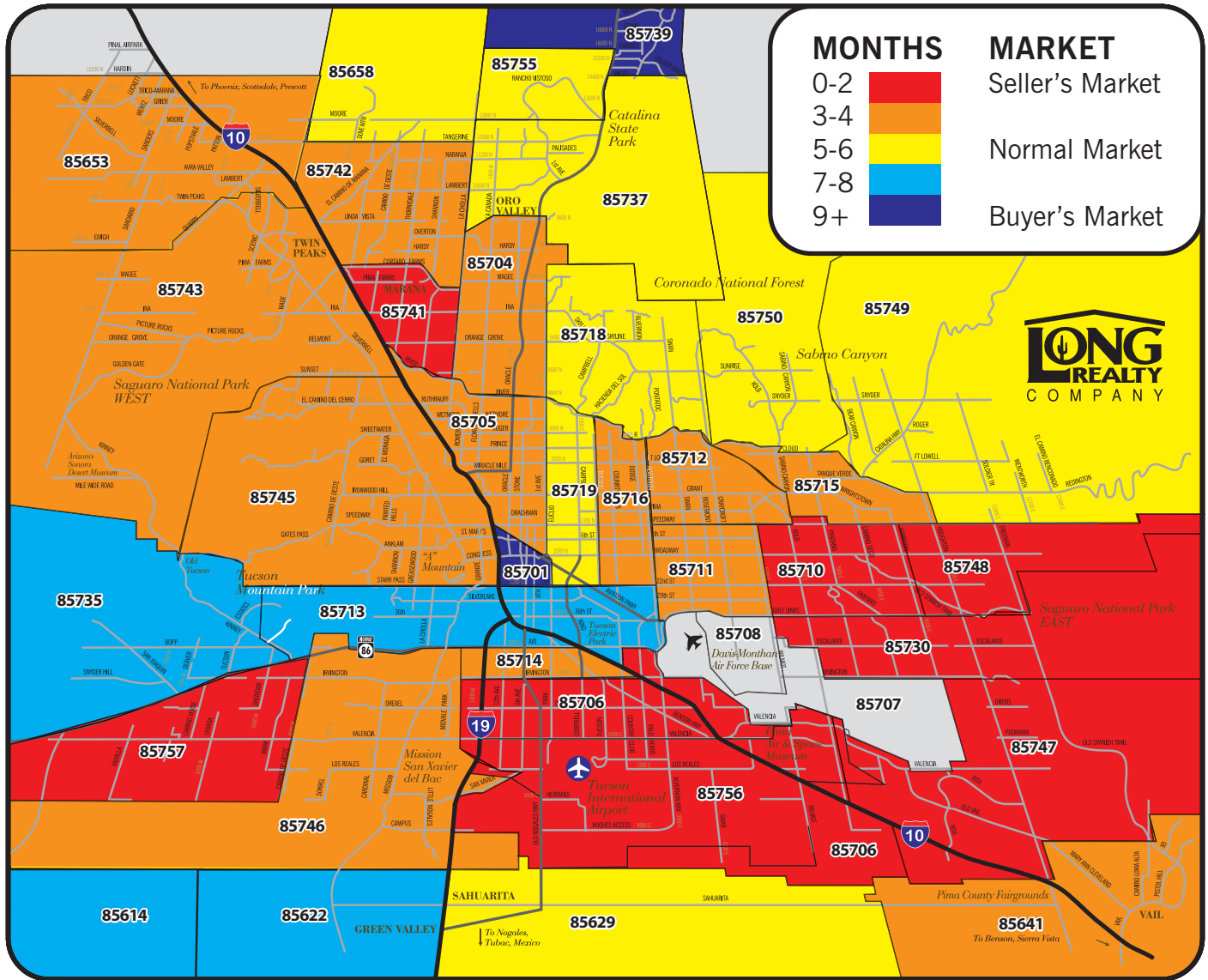
