

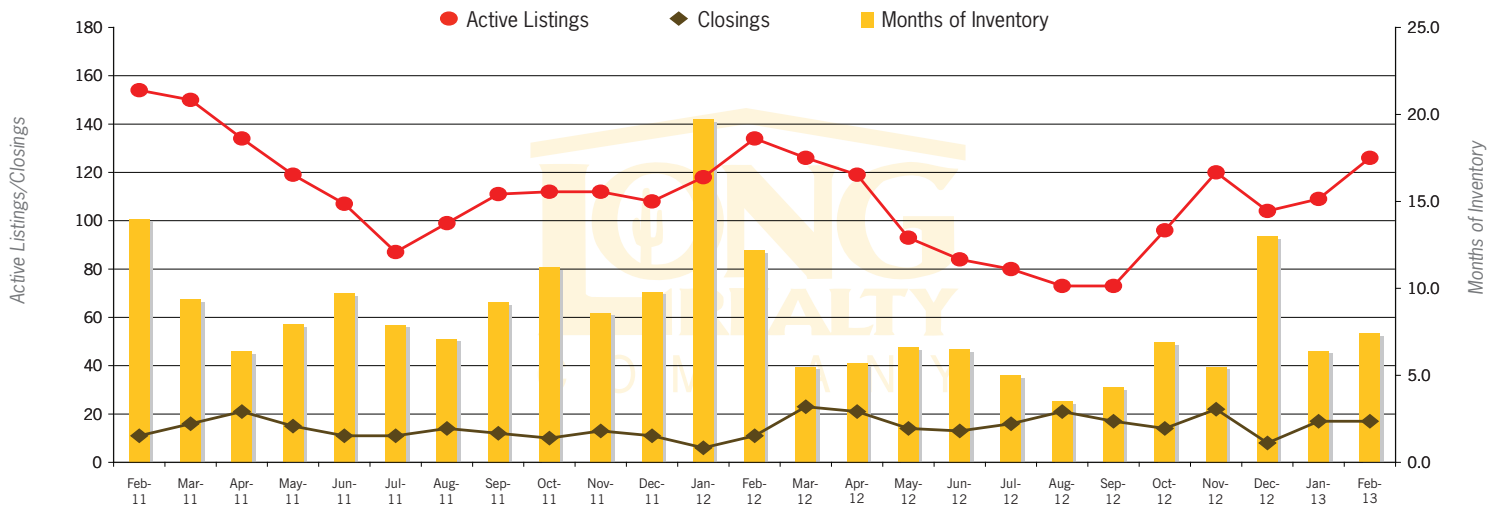

**Dove Mountain | March 2013**

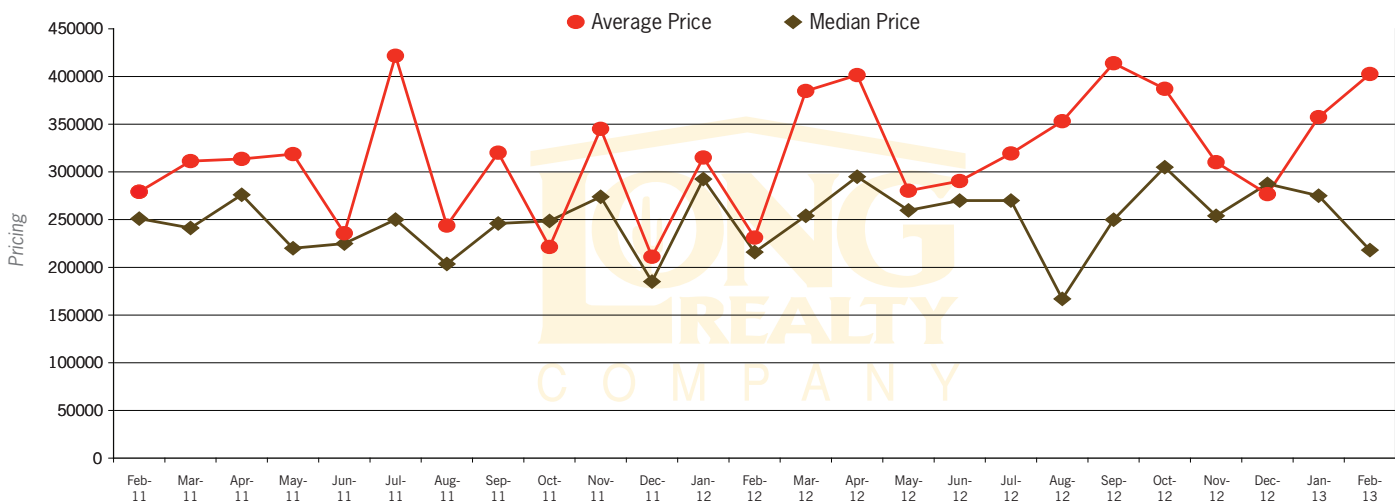
As of February 2013 active inventory was 126, a 6% decrease from February 2012. There were 17 closings in February 2013, 55% above February 2012. Months of Inventory was 7.4, down from 12.2 in February 2012. Median price of sold homes was \$218,000 for the month of February 2013, up 1% from February 2012. The Dove Mountain area had 17 new properties under contract in February 2013, up 13% from February 2012.

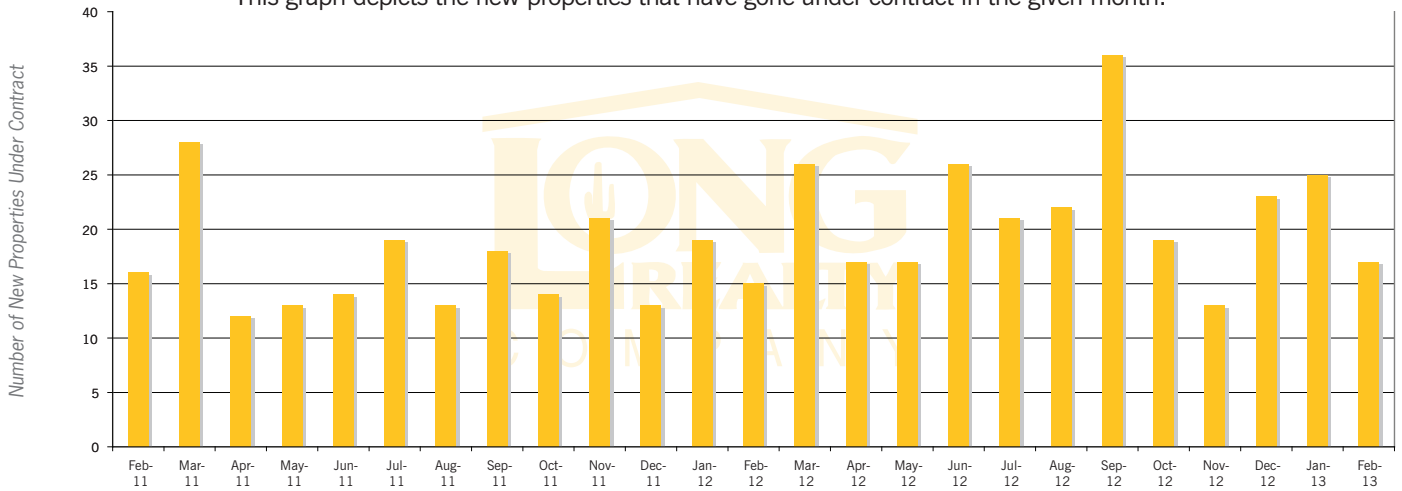

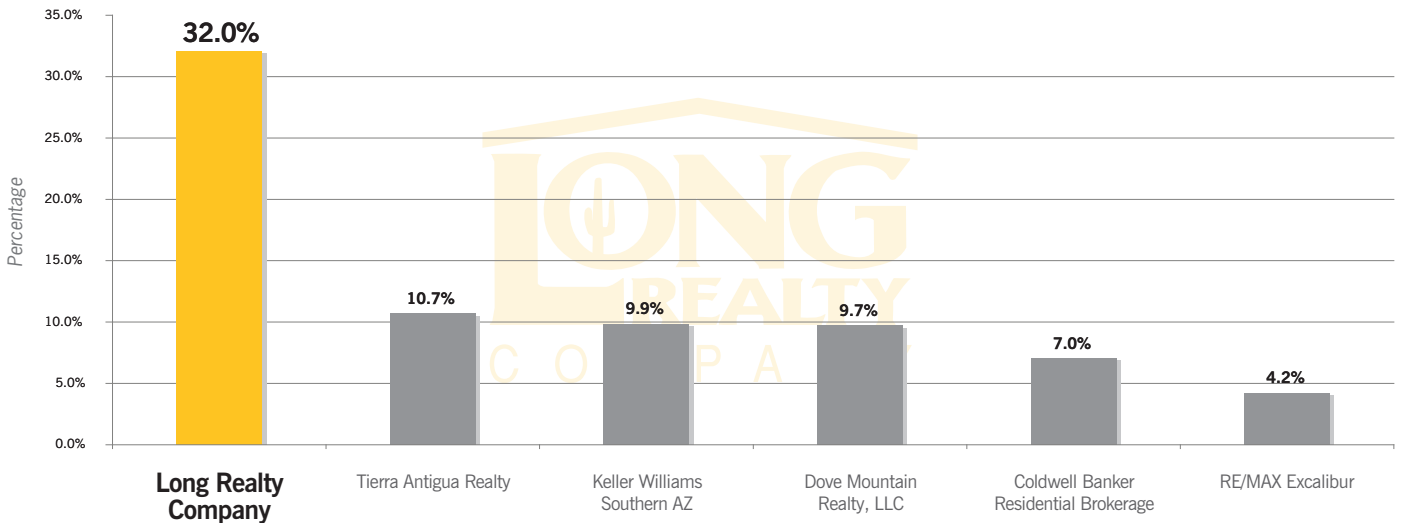
## New Properties Under Contract

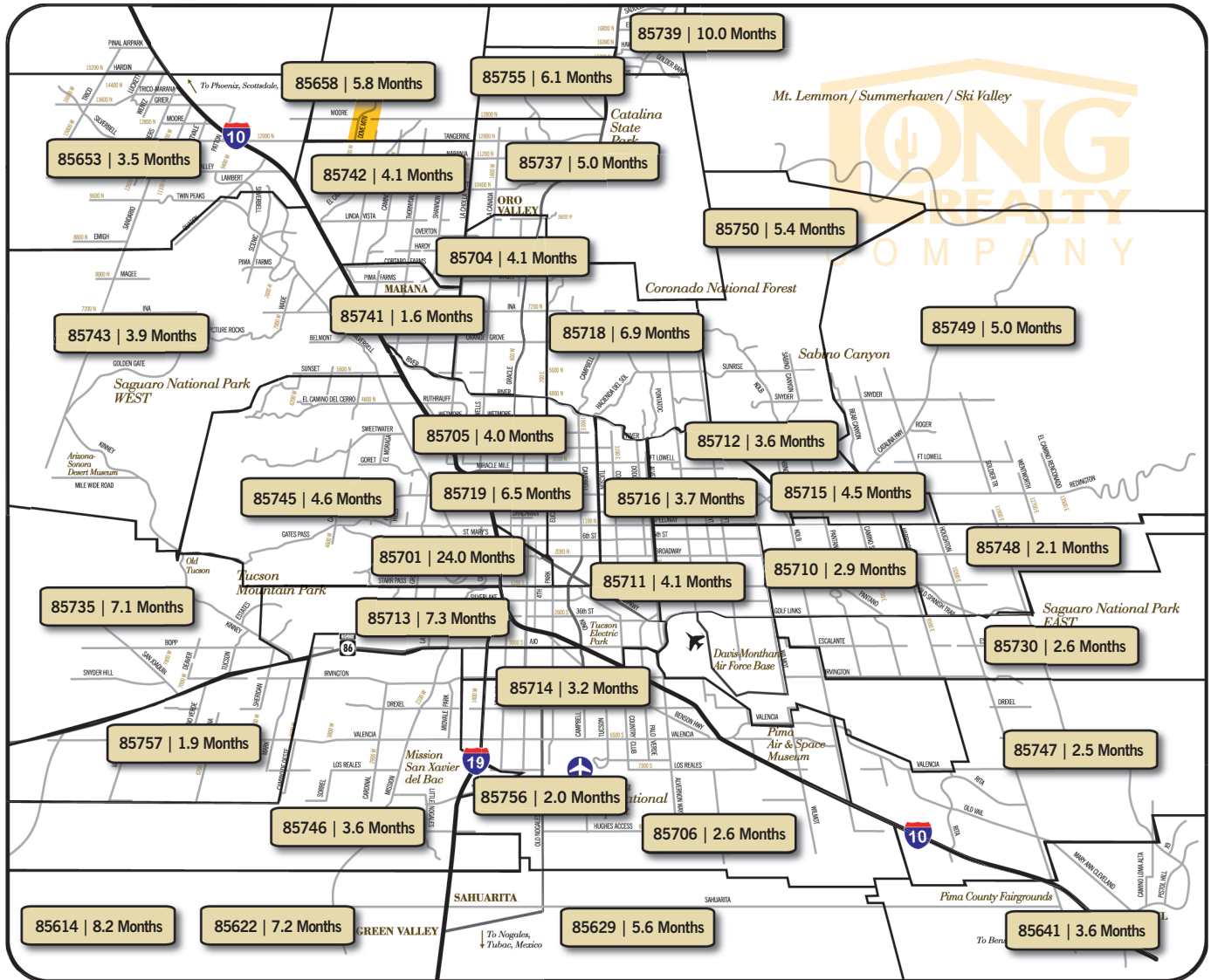

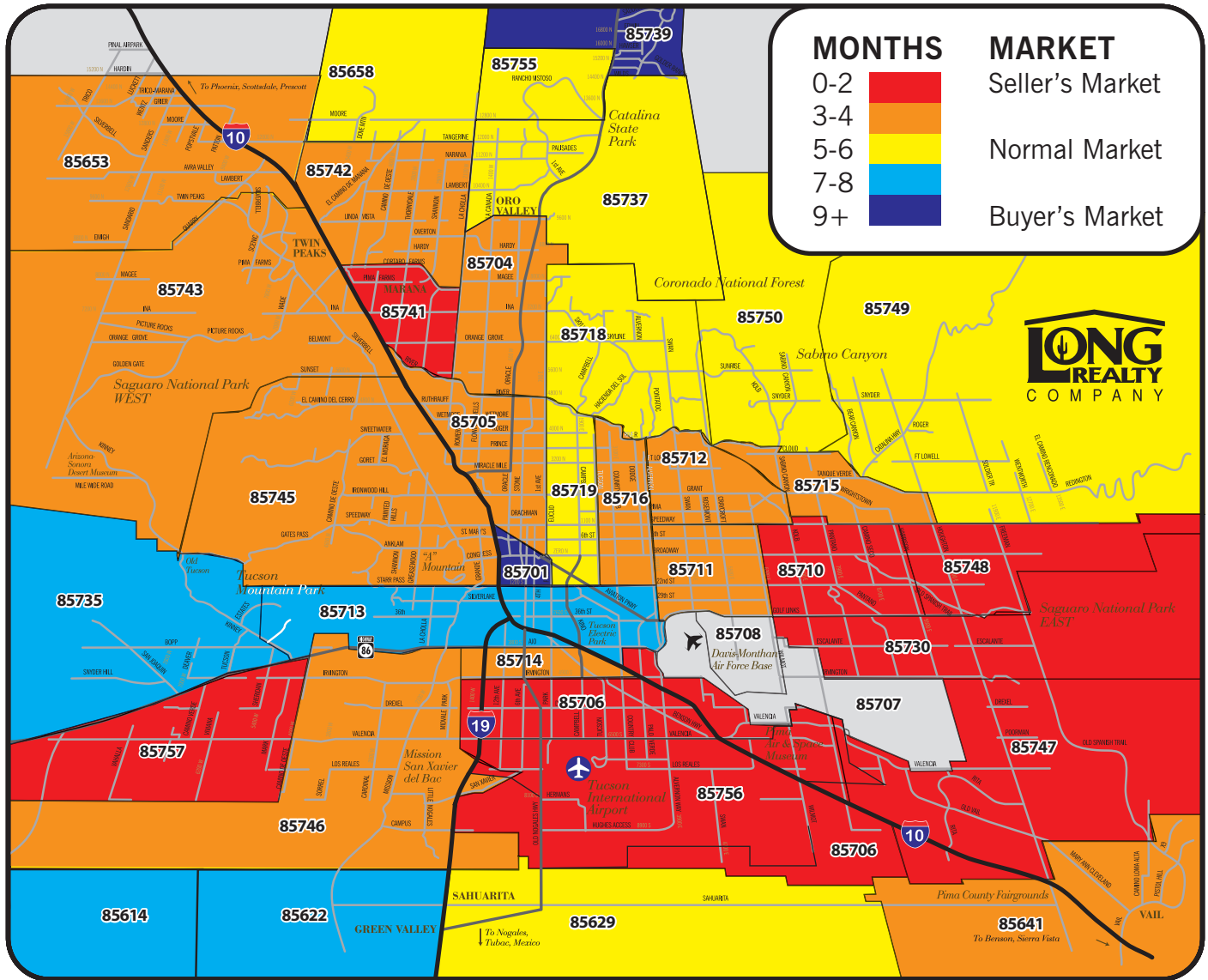
