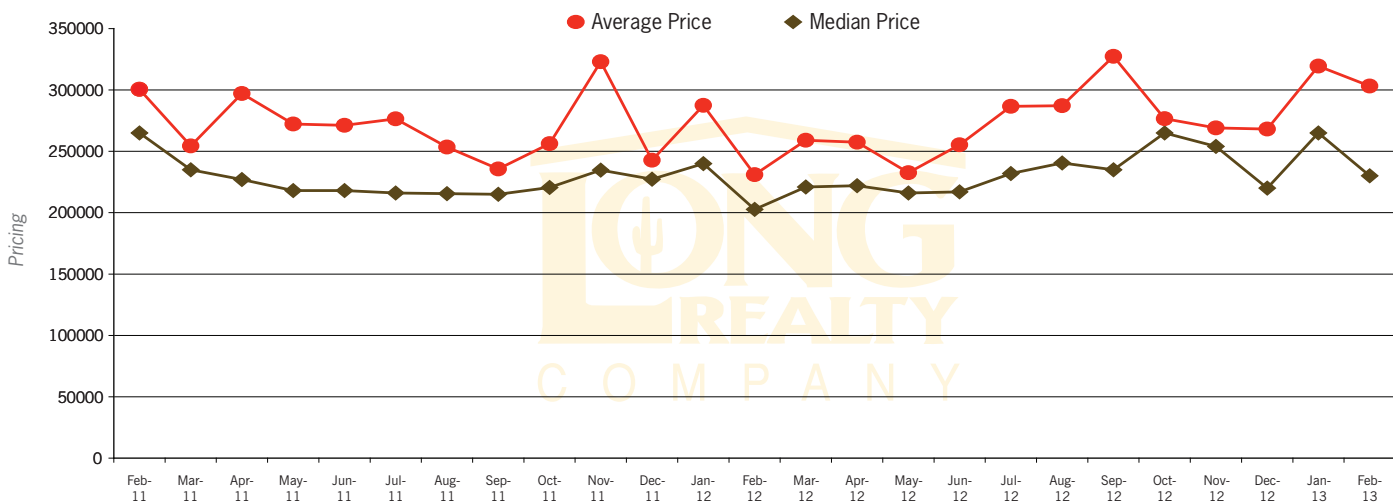
As of February 2013 active inventory was 286, a 30% decrease from February 2012. There were 50 closings in February 2013, 17% below February 2012. Months of Inventory was 5.7, down from 6.8 in February 2012. Median price of sold homes was \$230,125 for the month of February 2013, up 14% since February 2012. Oro Valley had 74 new properties under contract in February 2013, down 20% from February 2012.

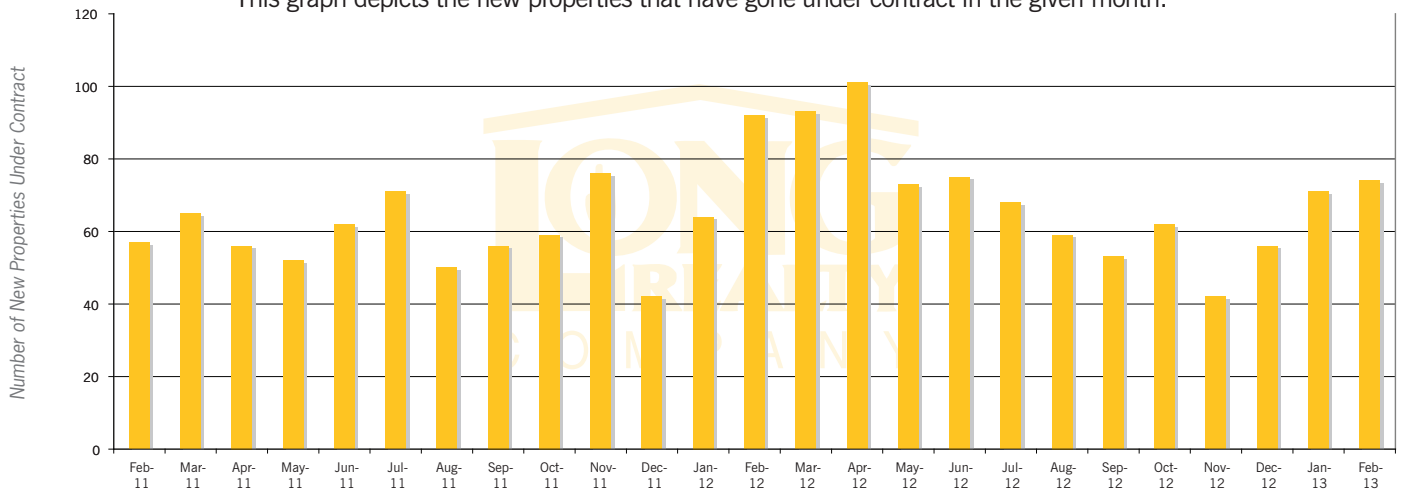

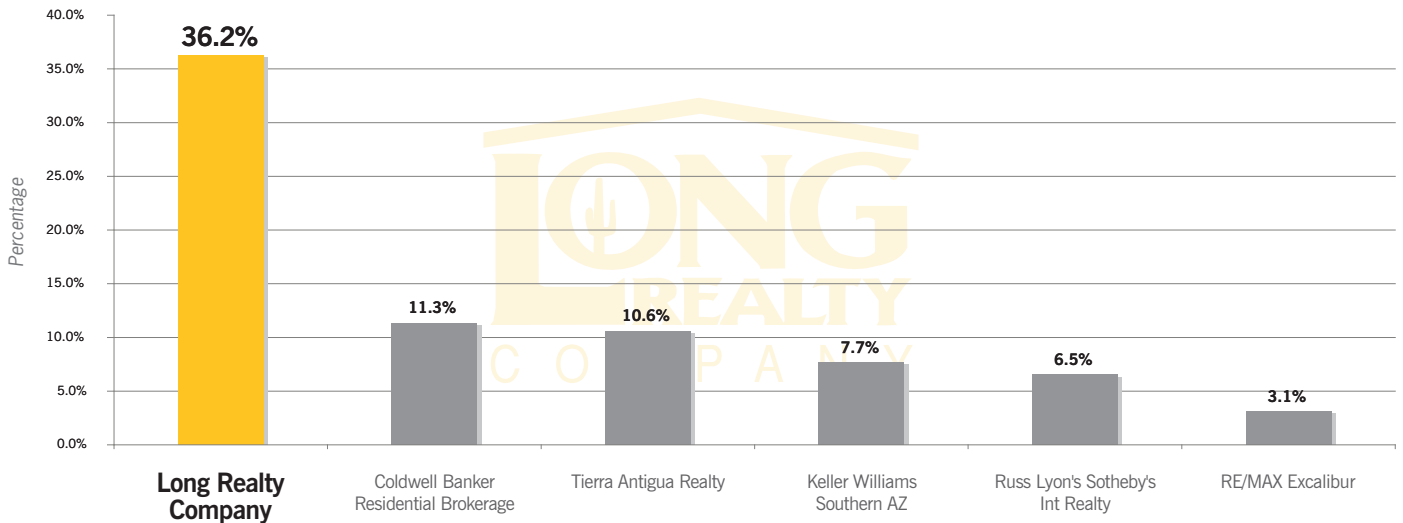
## New Properties Under Contract

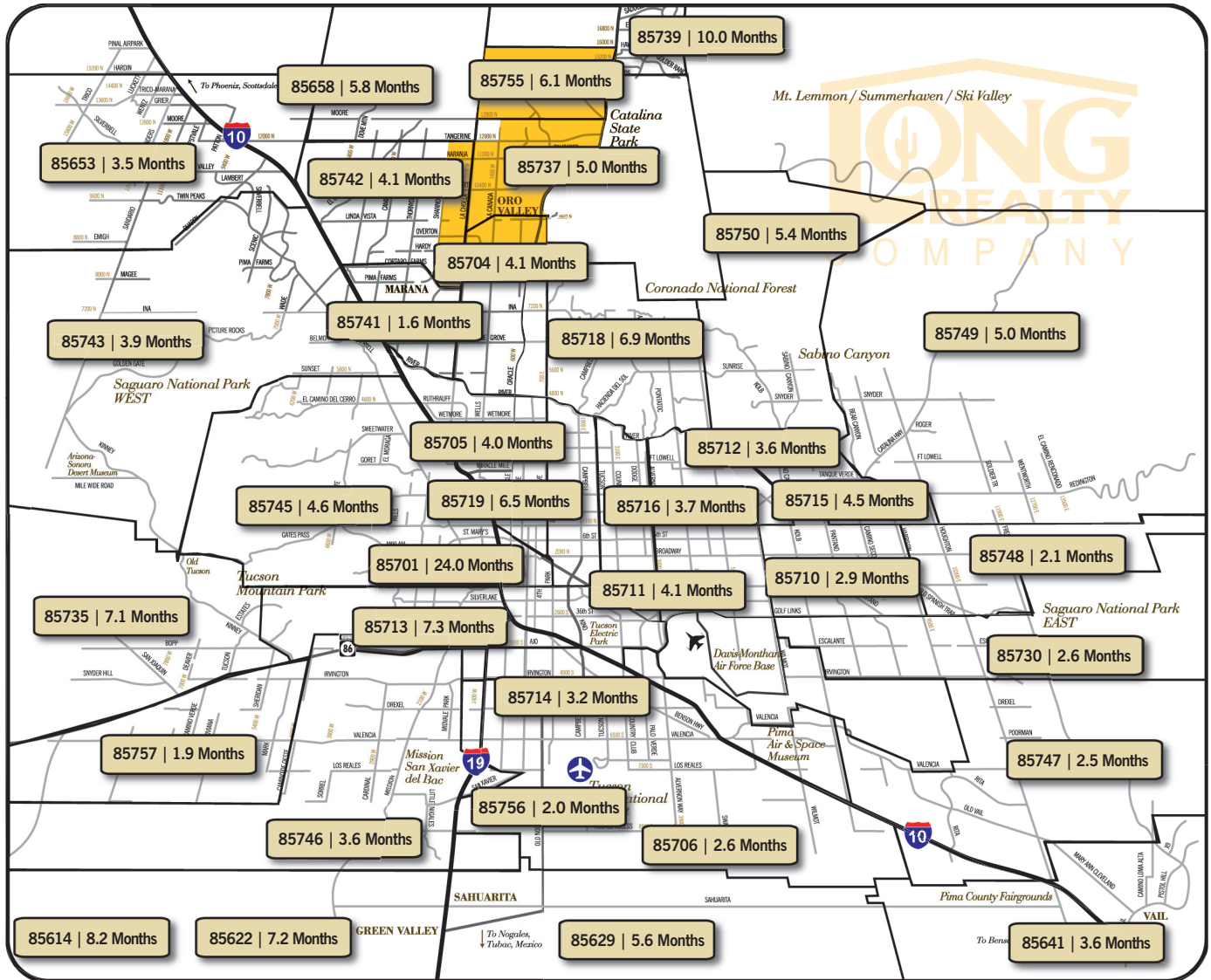

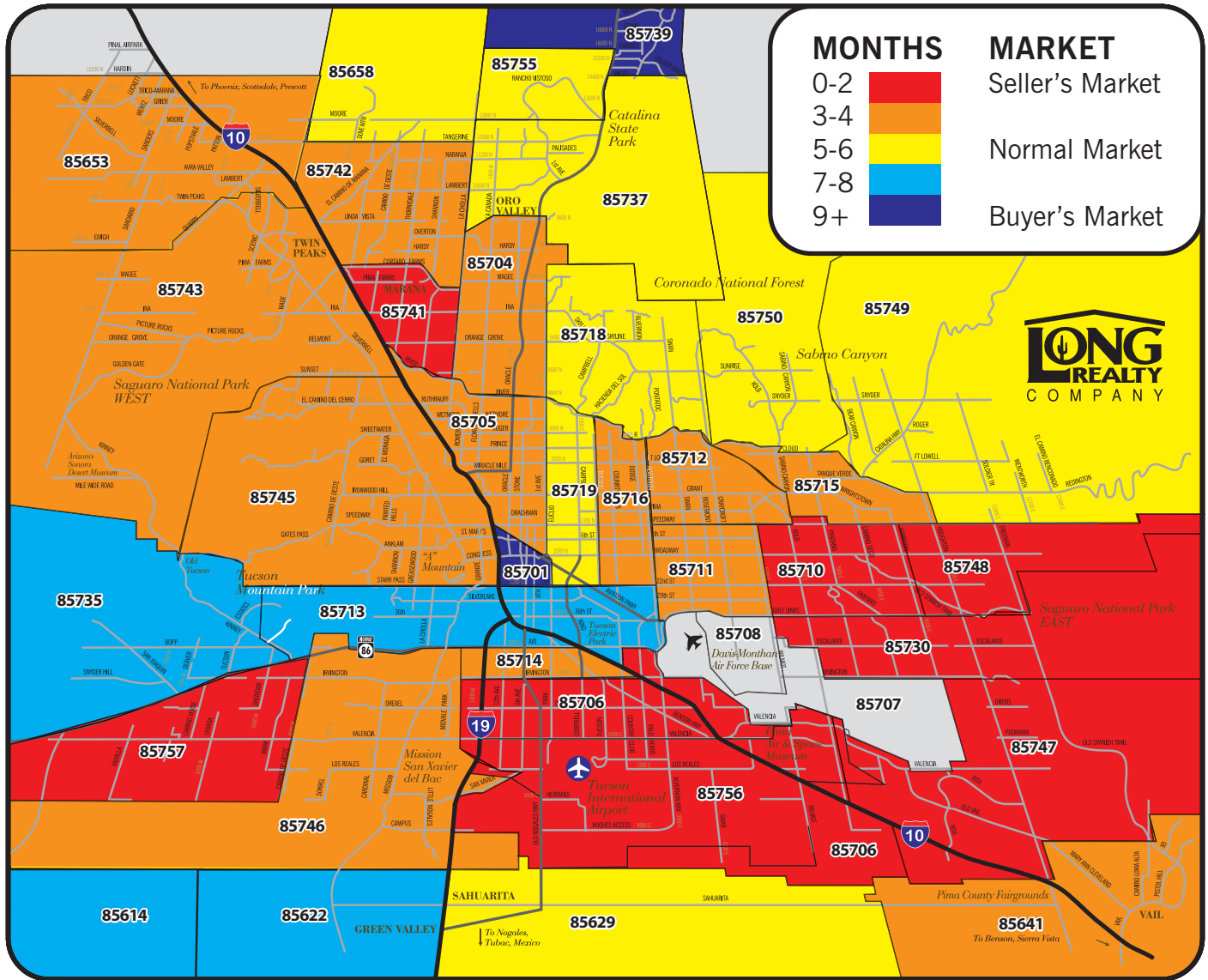
