
As of February 2013 active inventory was 220, a 4% increase from February 2012. There were 18 closings in February 2013, 6% above from February 2012. Months of Inventory was 12.2, down from 12.5 in February 2012. Median price of sold homes was \$264,000 for the month of February 2013, up 12% from February 2012. SaddleBrooke had 28 new properties under contract in February 2013, up 40% from February 2012.




## New Properties Under Contract




