
As of April 2013 active inventory was 48, an 11% decrease from April 2012. There were 19 closings in April 2013, 24% below April 2012. Months of Inventory was 2.5 up from 2.2 in April 2012. Median price of sold homes was \$175,000 for the month of April 2013, up 17% from April 2012. The Continental Ranch area had 31 new properties under contract in April 2013, down 14% from April 2012.




New Properties Under Contract




