

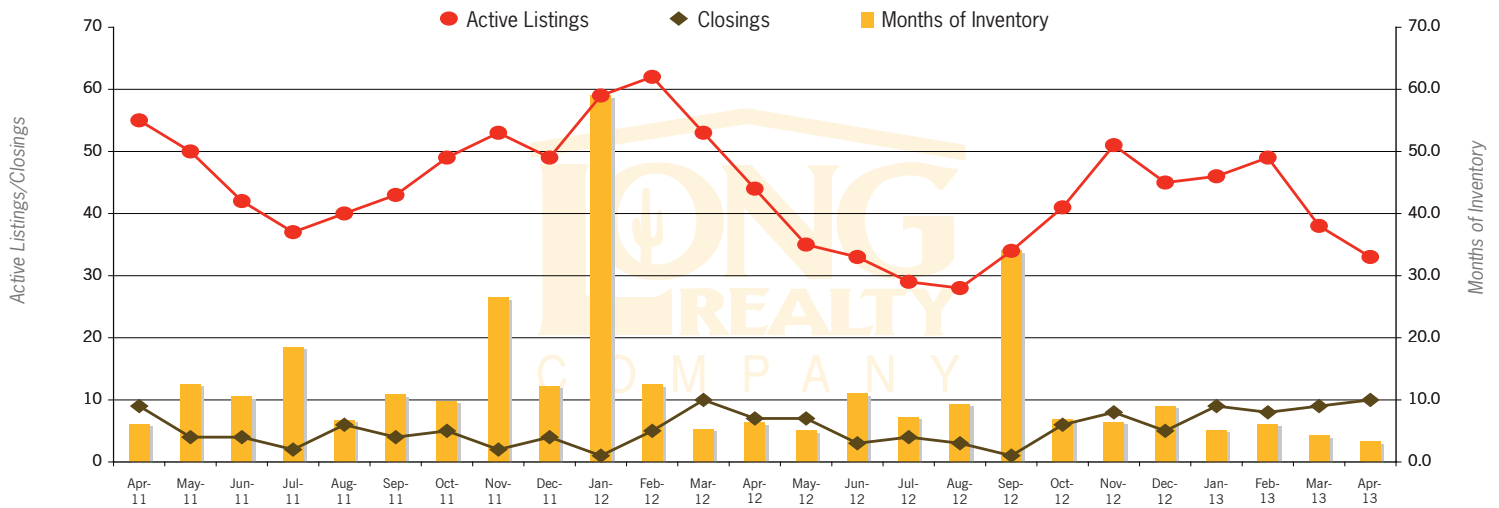

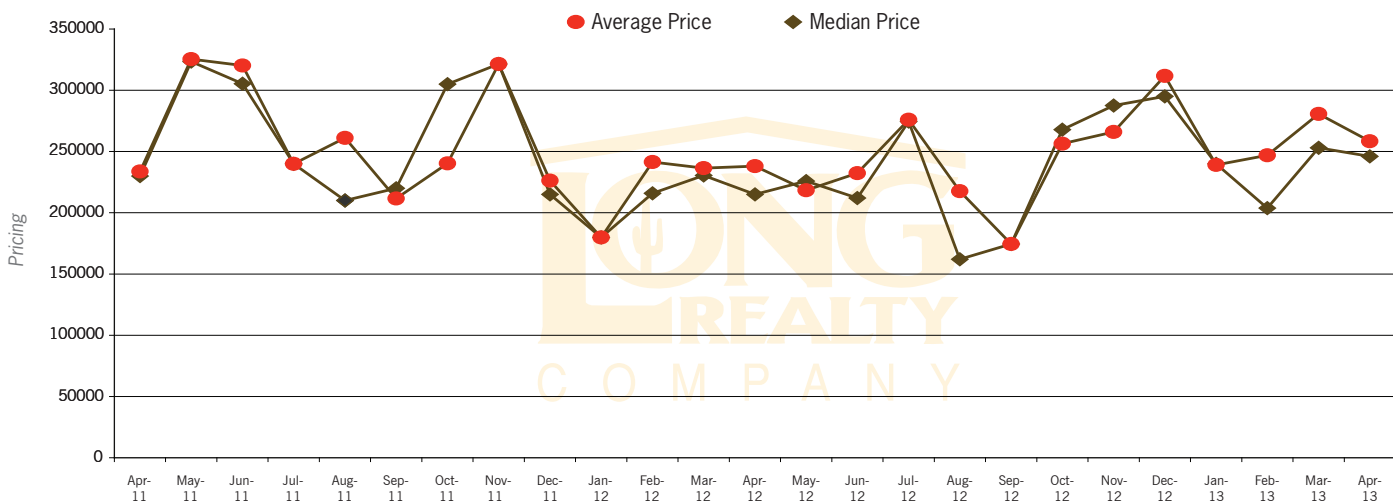
As of April 2013 active inventory was 33, a 25% decrease from April 2012. There were 10 closings in April 2013, 43% above April 2012. Months of Inventory was 3.3, down from 6.3 in April 2012. Median price of sold homes was \$246,000 for the month of April 2013, up 14% from April 2012. Heritage Highlands had 15 new properties under contract in April 2013, up 200% from April 2012.

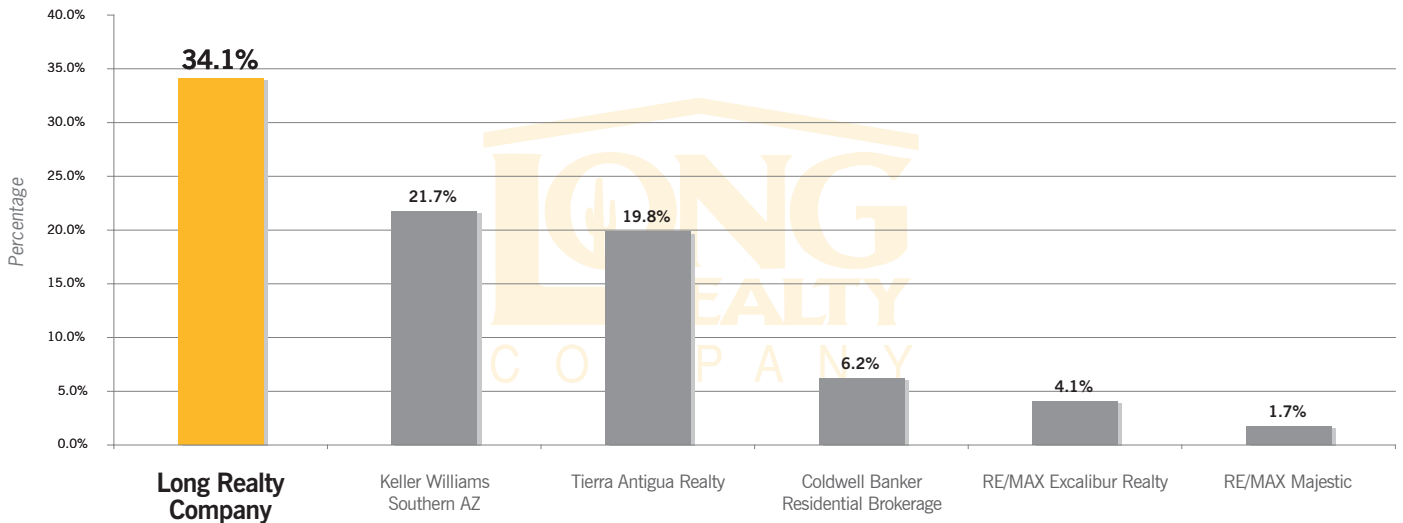
New Properties Under Contract

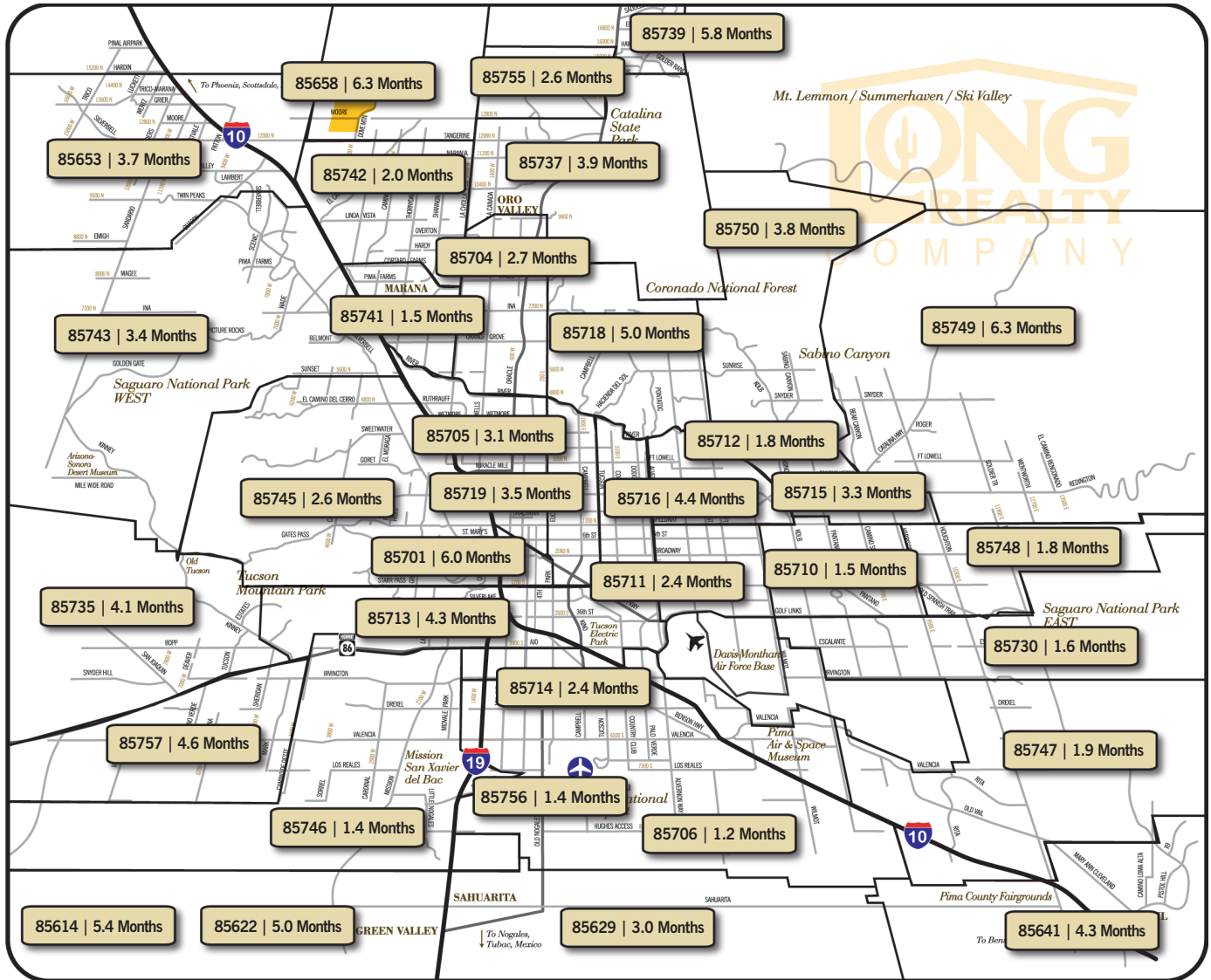

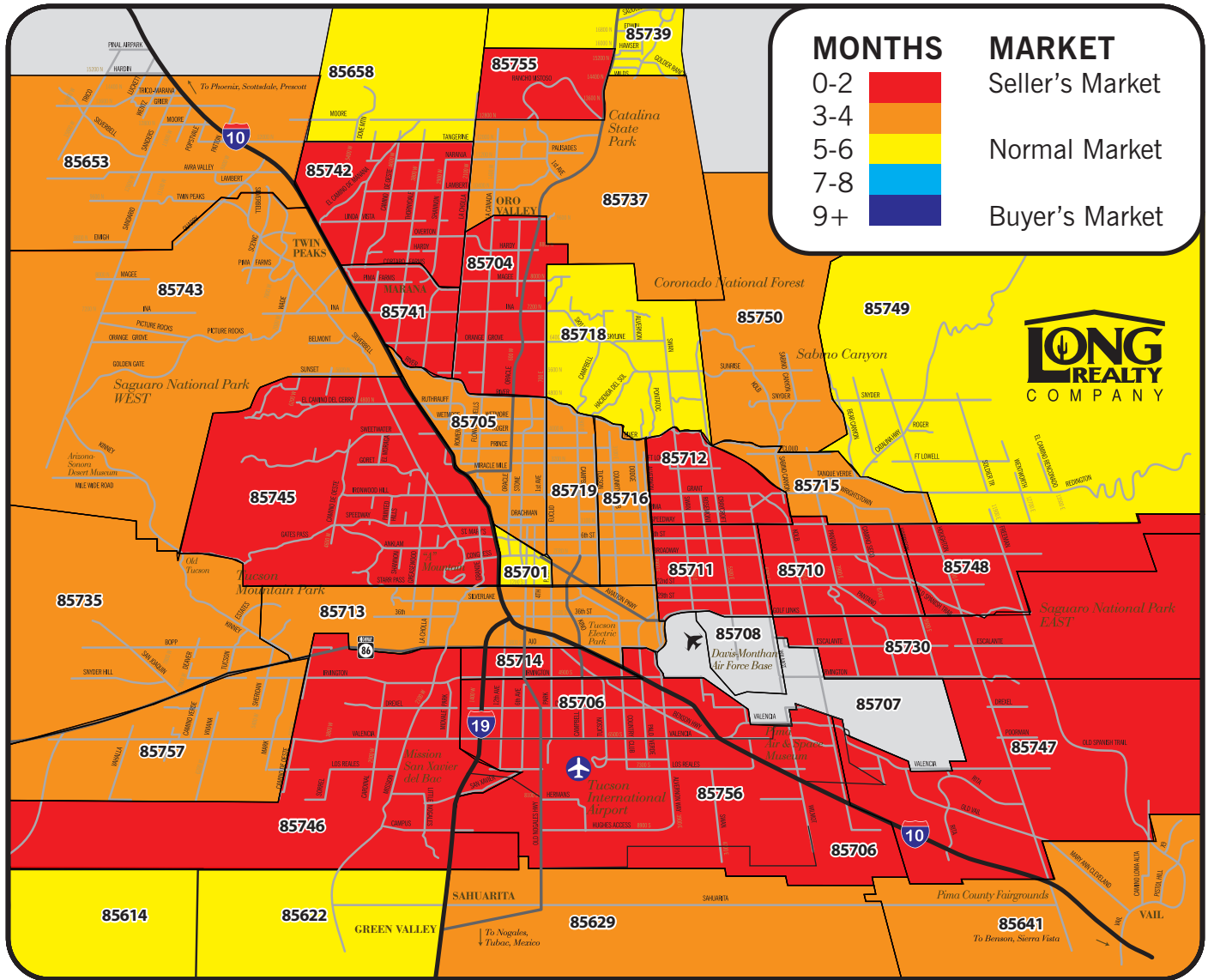
