

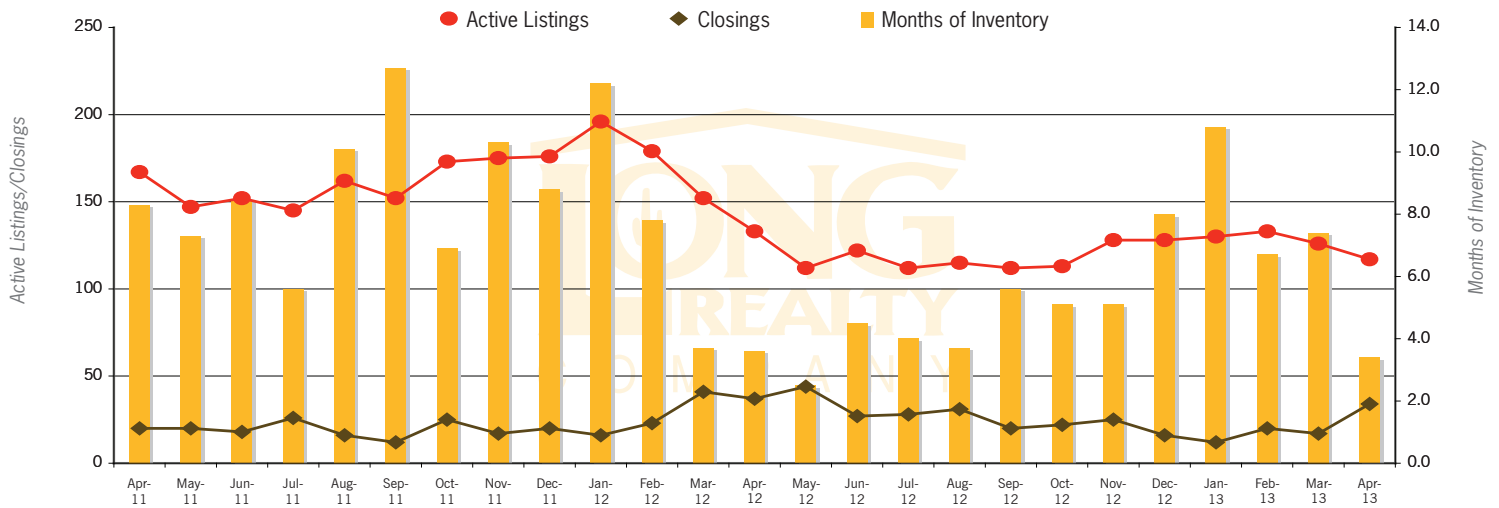

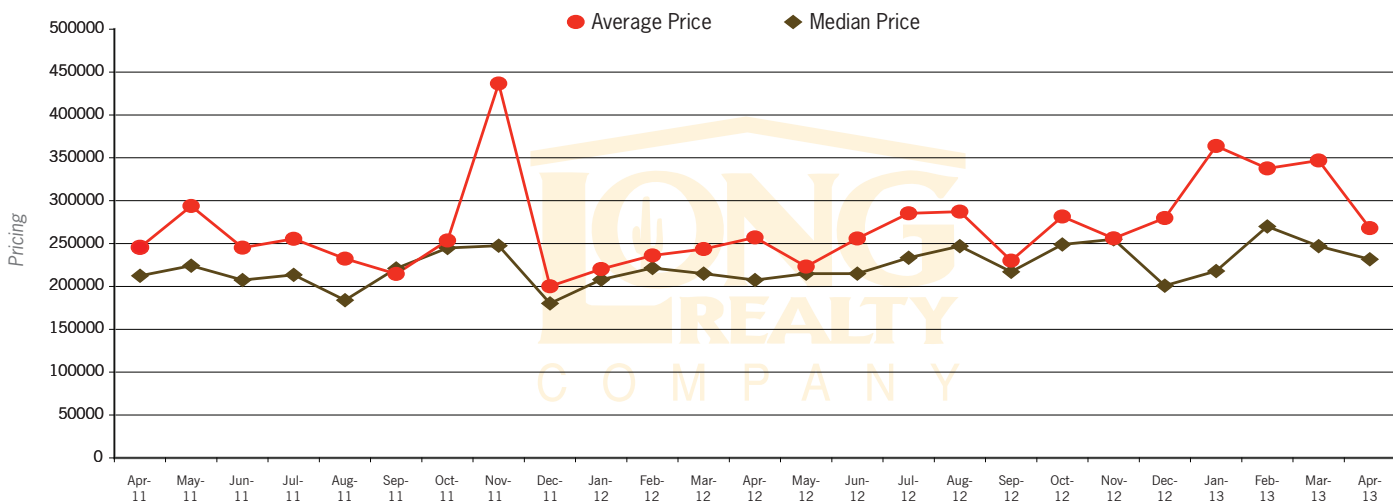
As of April 2013 active inventory was 117, a 12% decrease from April 2012. There were 34 closings in April 2013, 8% below April 2012. Months of Inventory was 3.4, down from 3.6 in April 2012. Median price of sold homes was \$231,700 for the month of April 2013, up 12% since April 2012. Rancho Vistoso had 45 new properties under contract in April 2013, up 36% from April 2012.

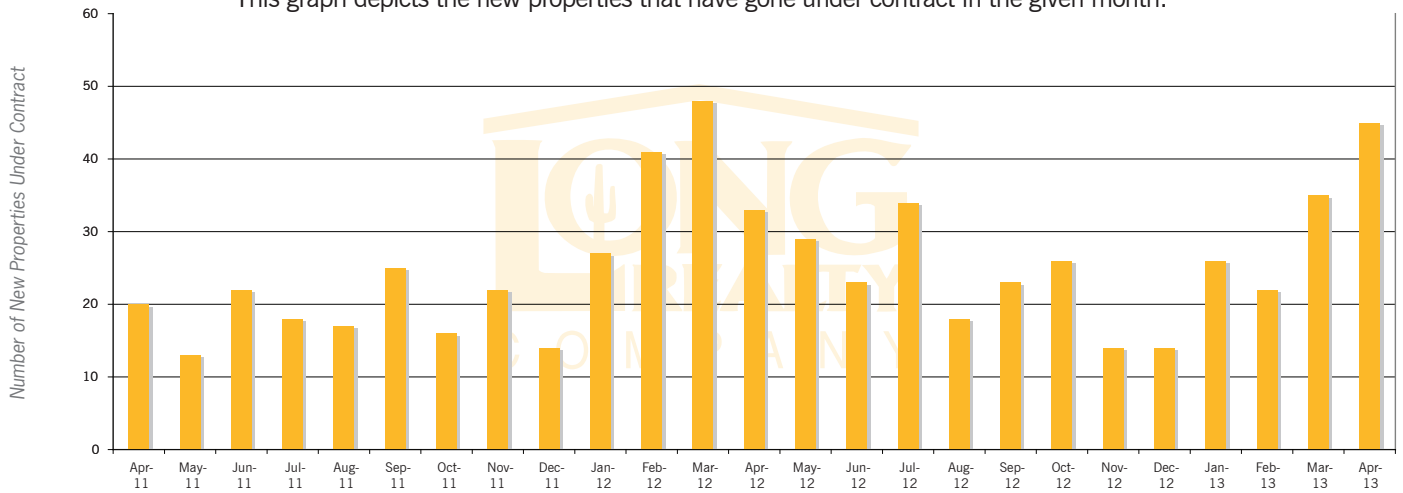

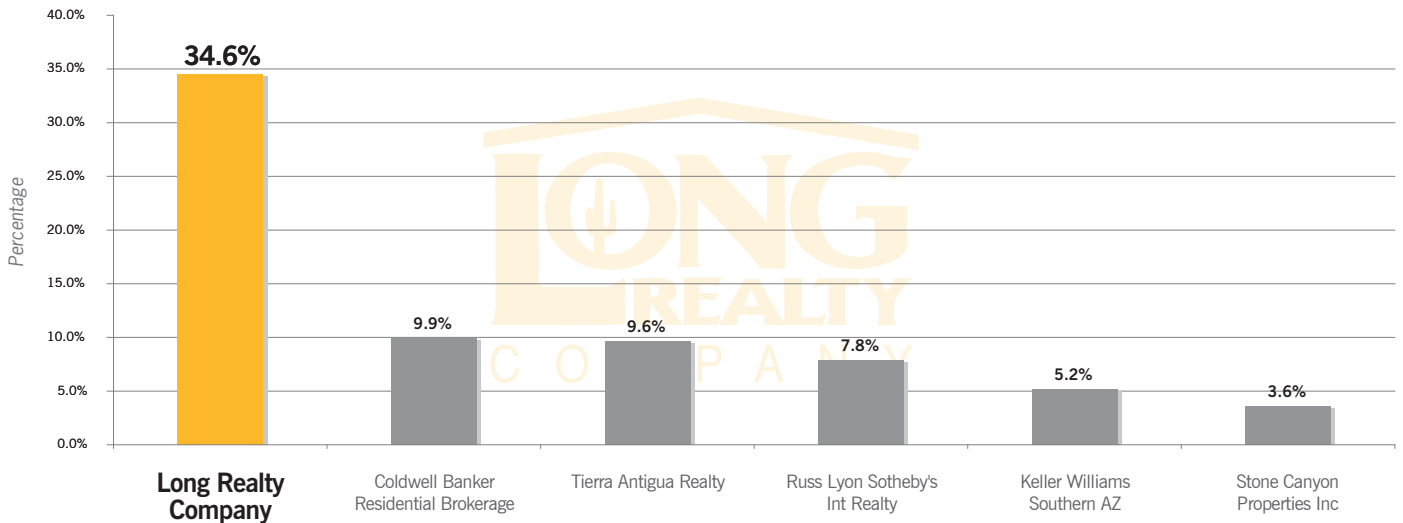
New Properties Under Contract

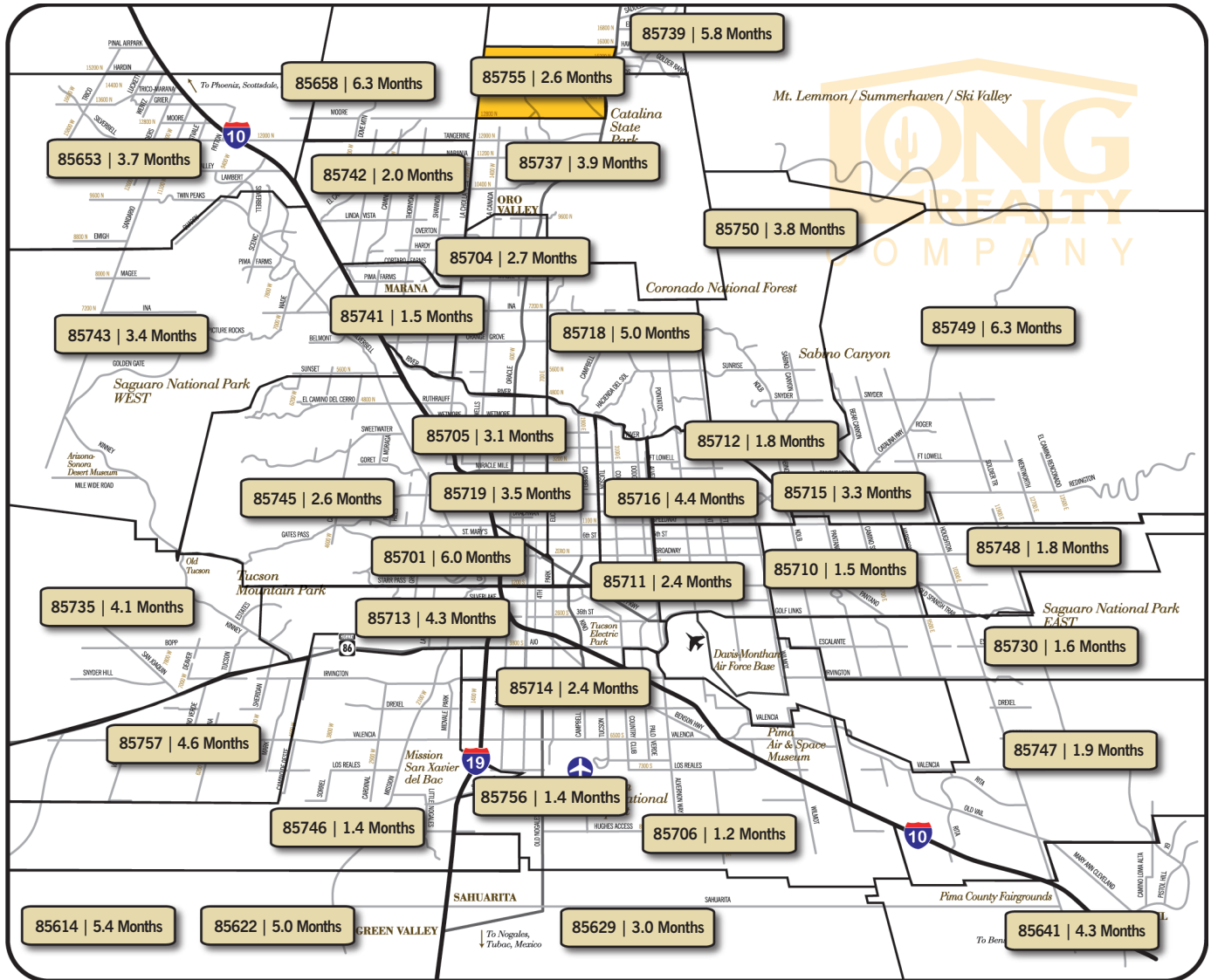

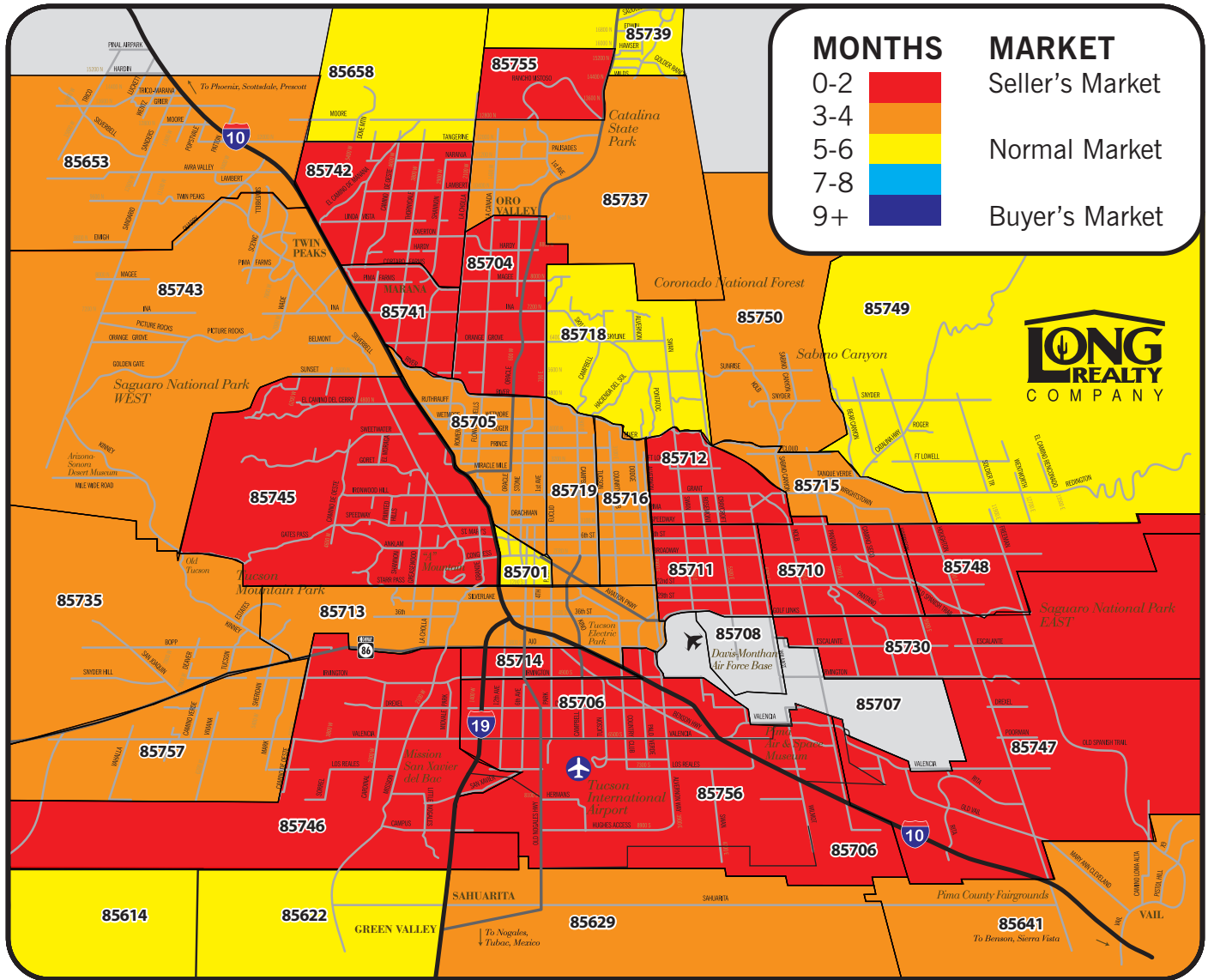
