

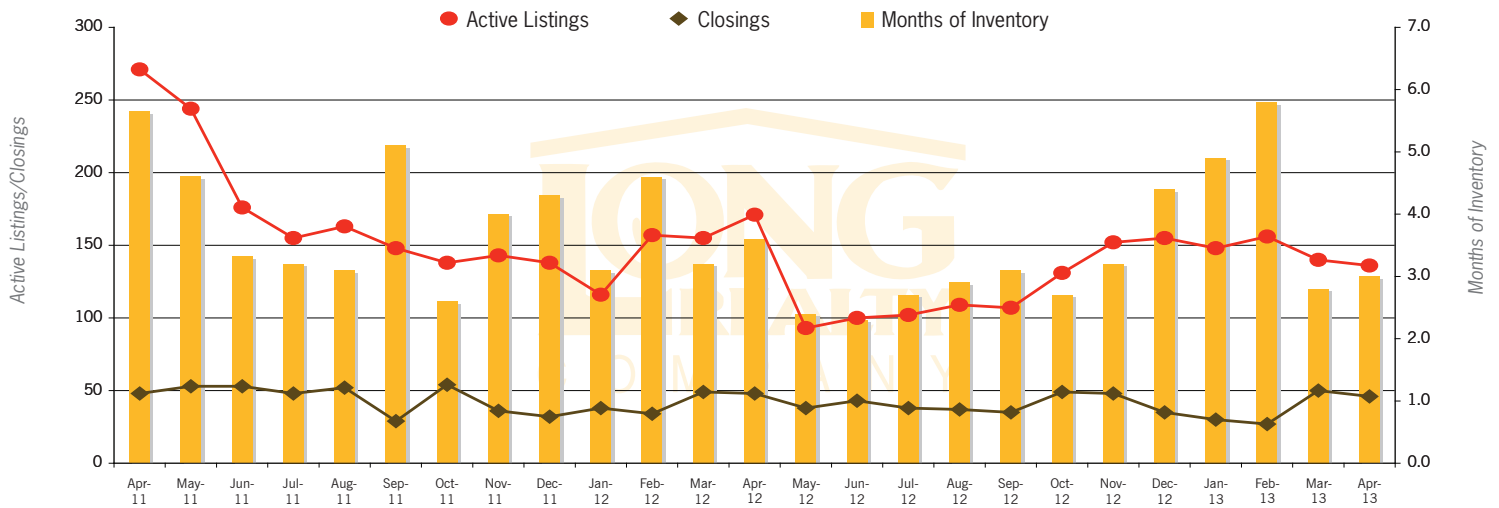

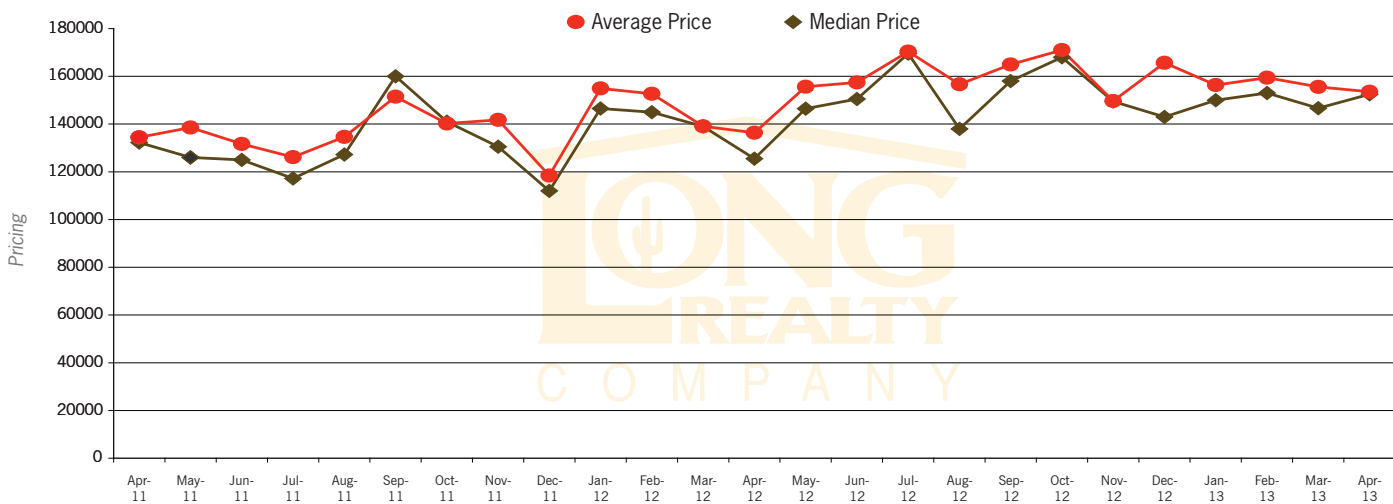
As of April 2013 active inventory was 136, a 20% decrease from April 2012. There were 46 closings in April 2013, 4% below April 2012. Months of Inventory was 3.0, down from 3.6 in April 2012. Median price of sold homes was \$152,500 for the month of April 2013, up 22% from April 2012. Sahuarita had 72 new properties under contract in April 2013, down 8% from April 2012.

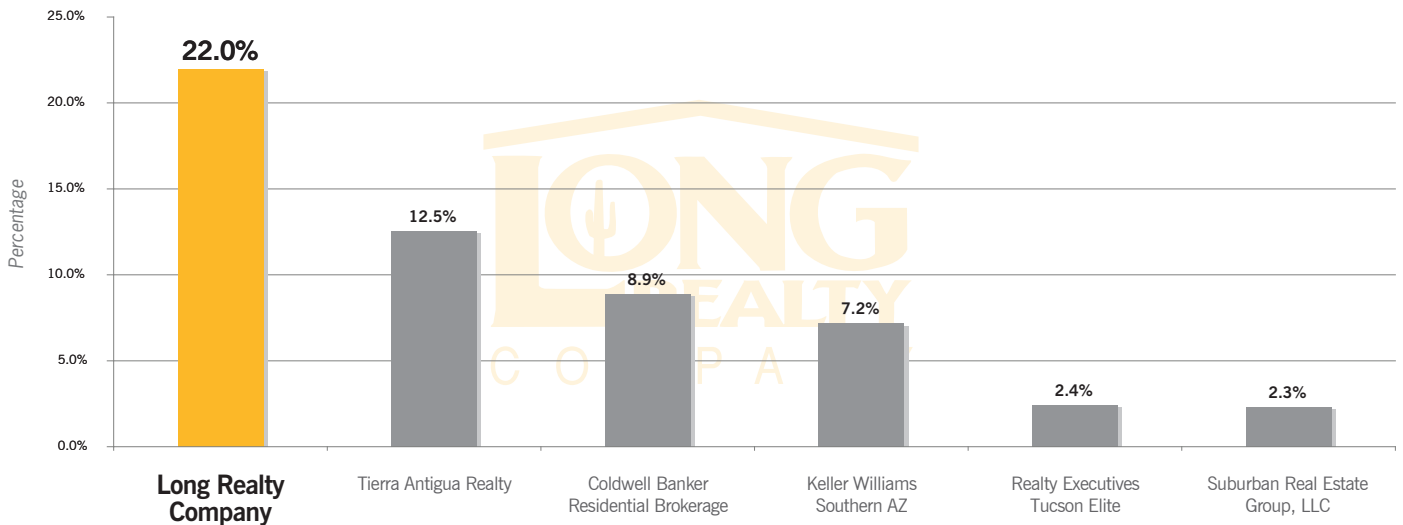
New Properties Under Contract

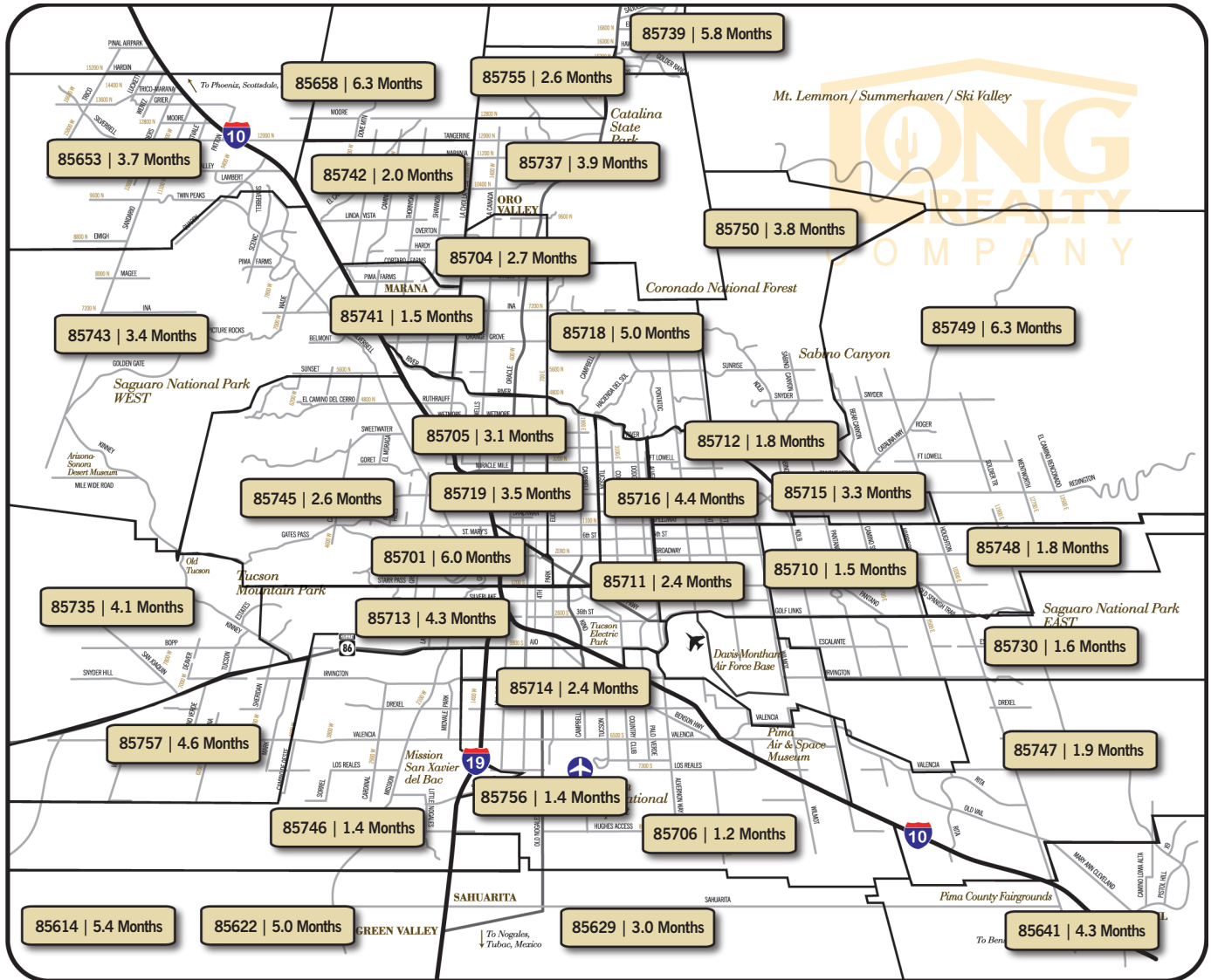

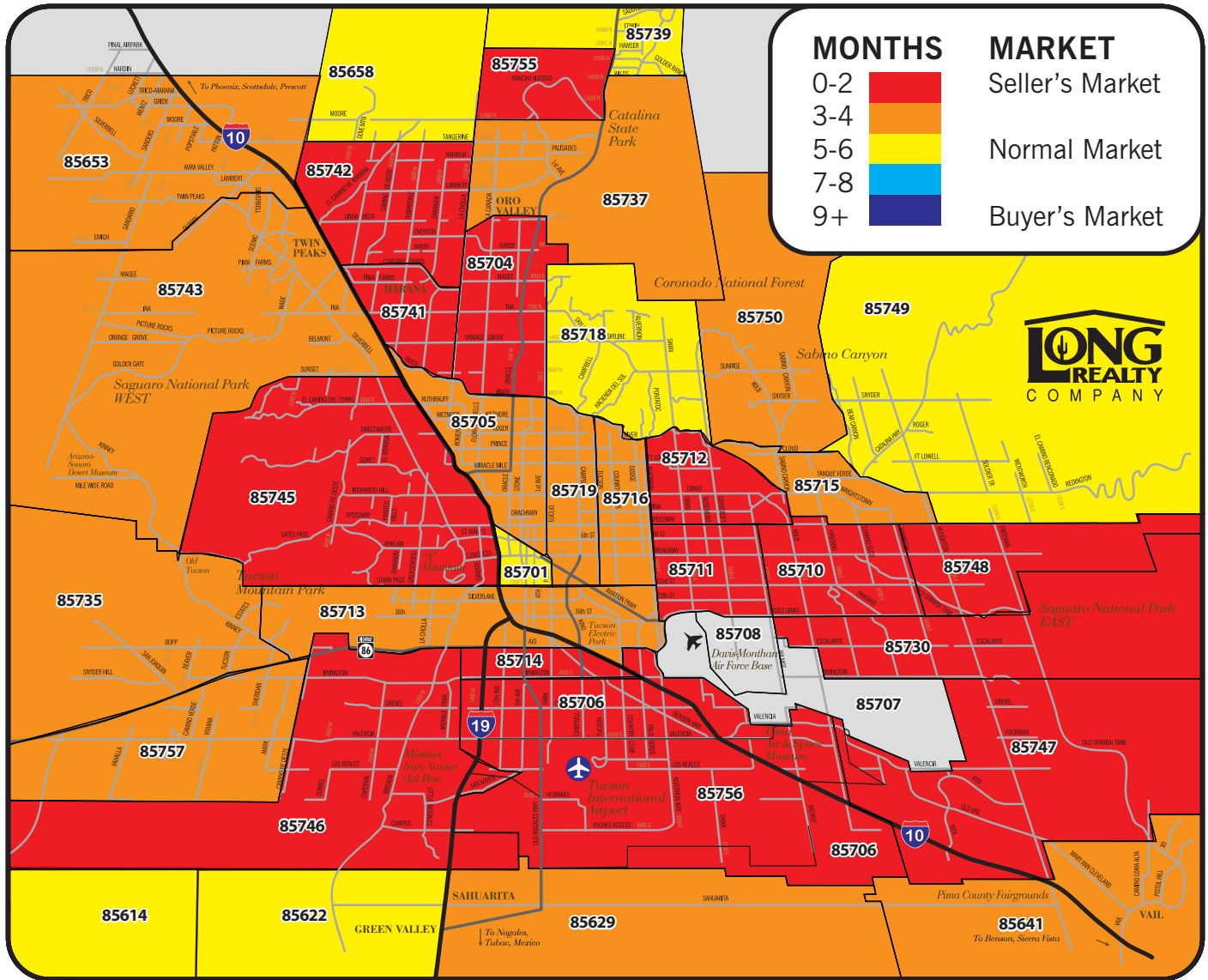
