

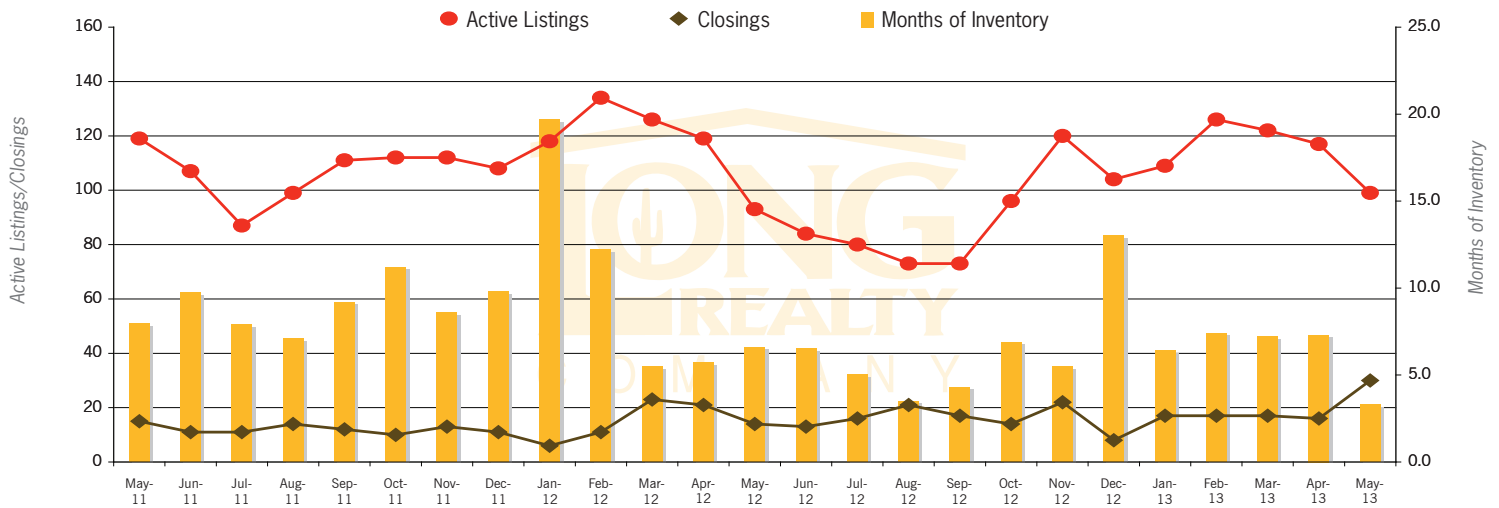

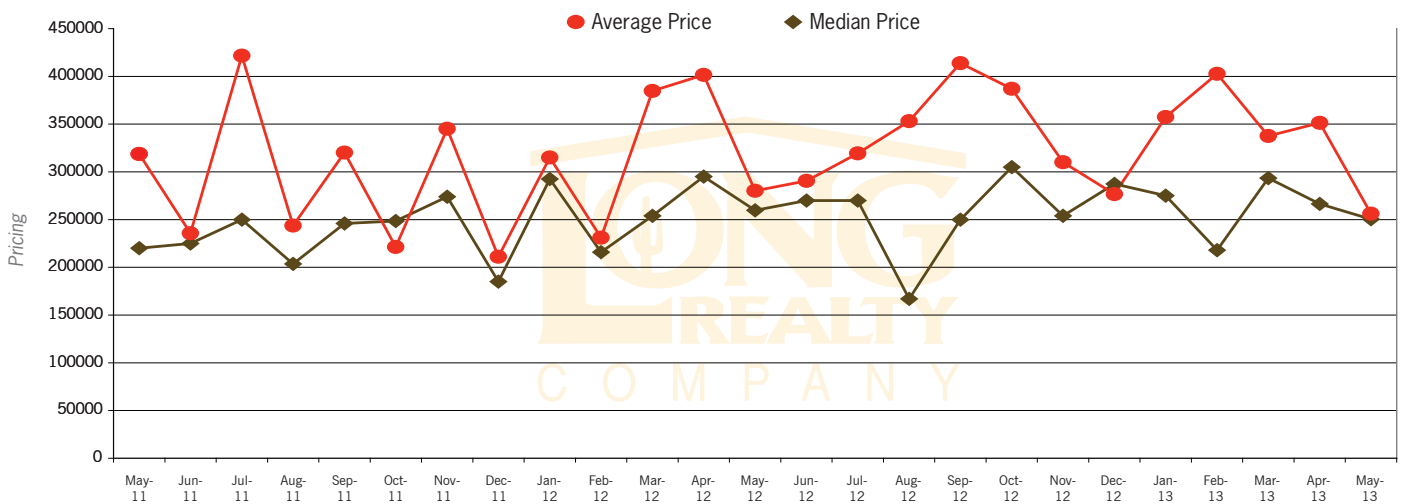
As of May 2013 active inventory was 99, a 6% increase from May 2012. There were 30 closings in May 2013, 114% above May 2012. Months of Inventory was 3.3, down from 6.6 in May 2012. Median price of sold homes was \$250,500 for the month of May 2013, down 4% from May 2012. The Dove Mountain area had 23 new properties under contract in May 2013, up 35% from May 2012.

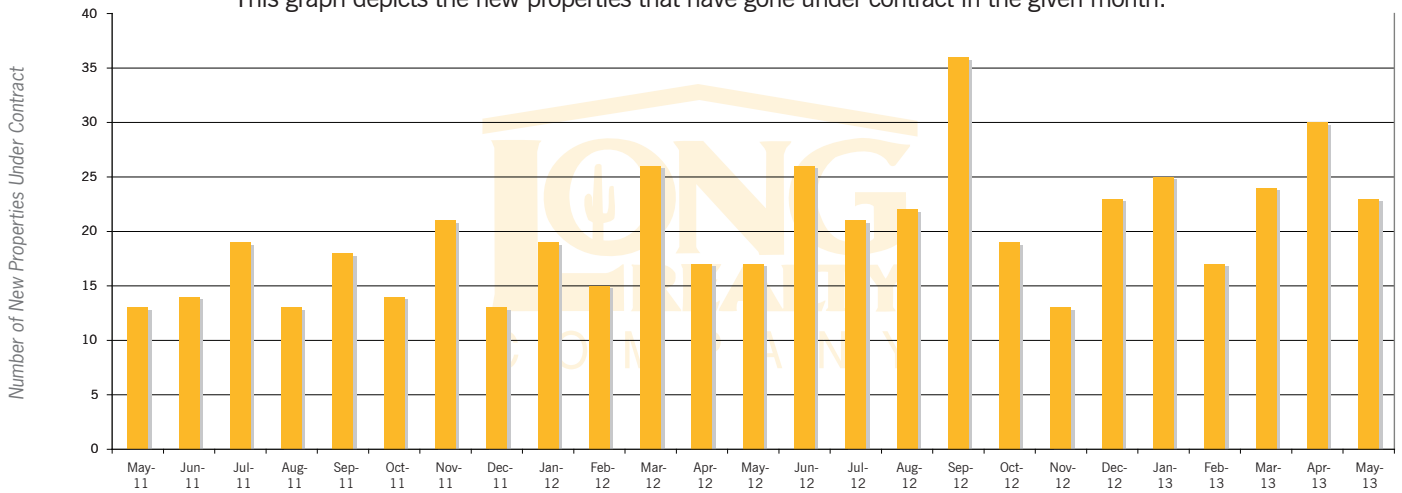

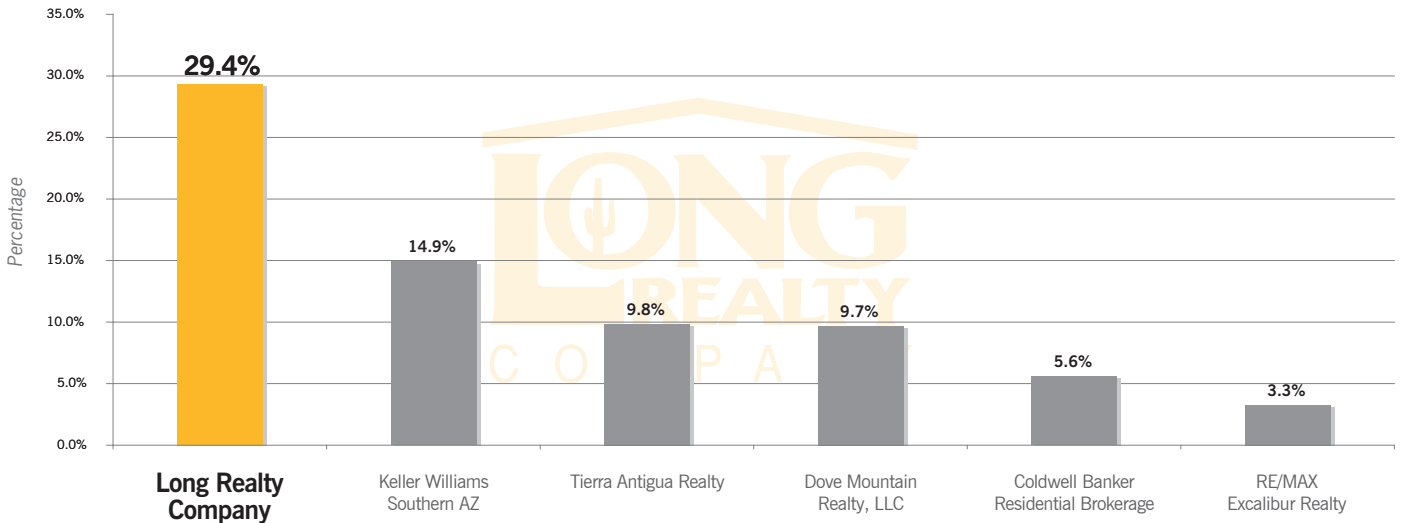
New Properties Under Contract

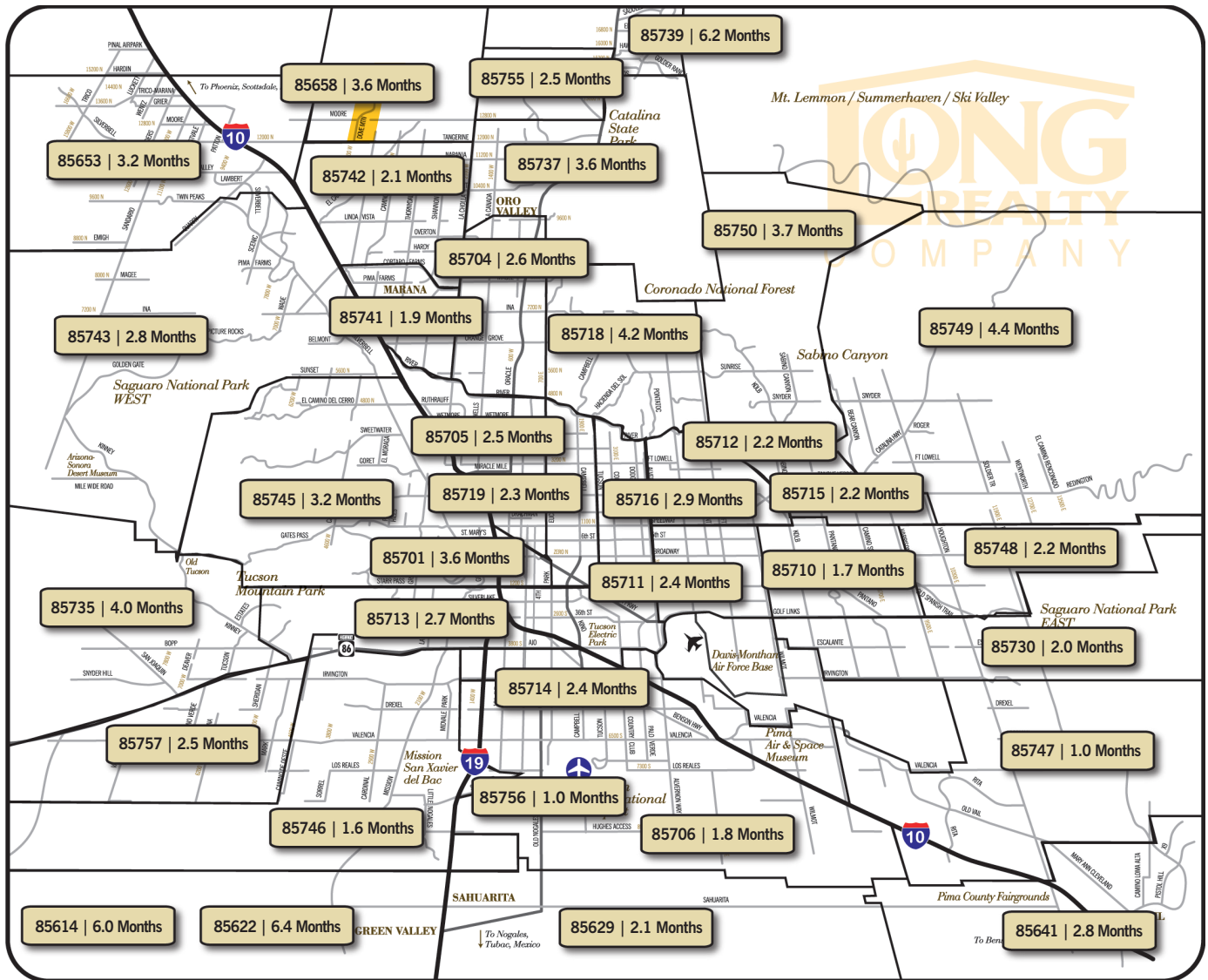

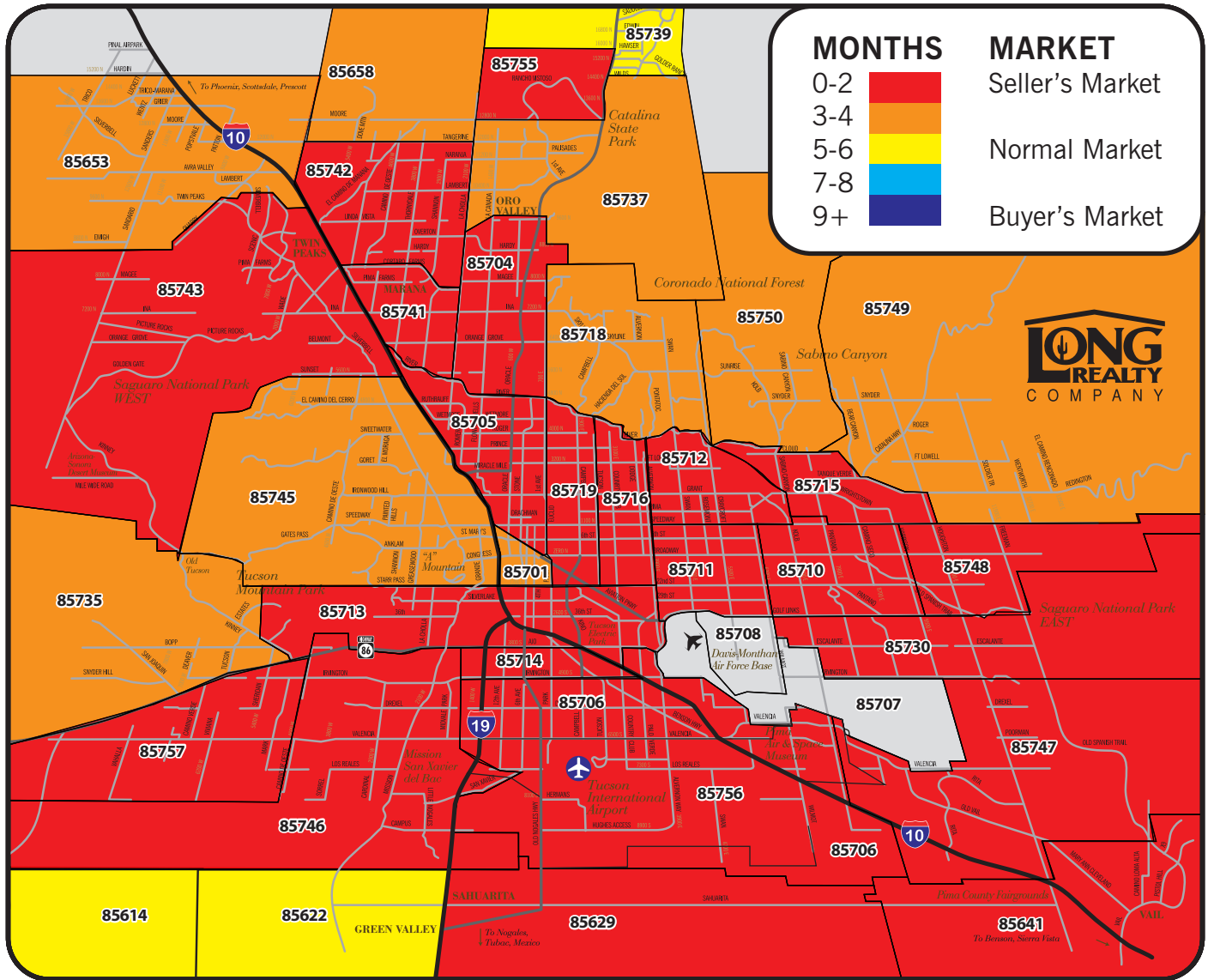
