

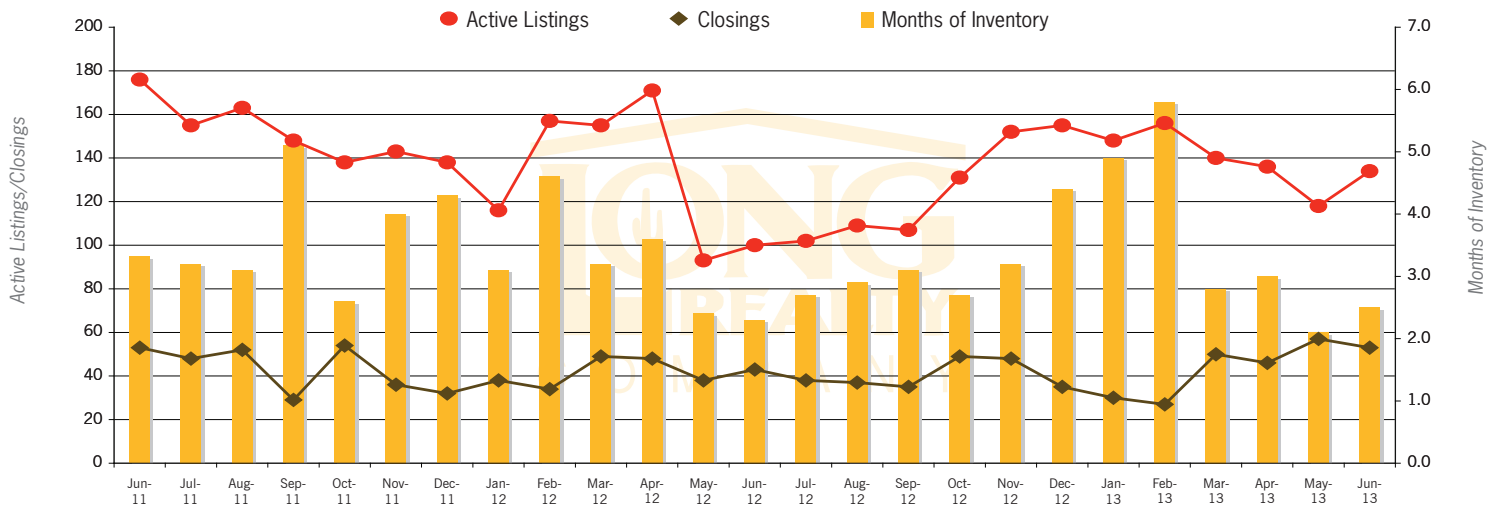

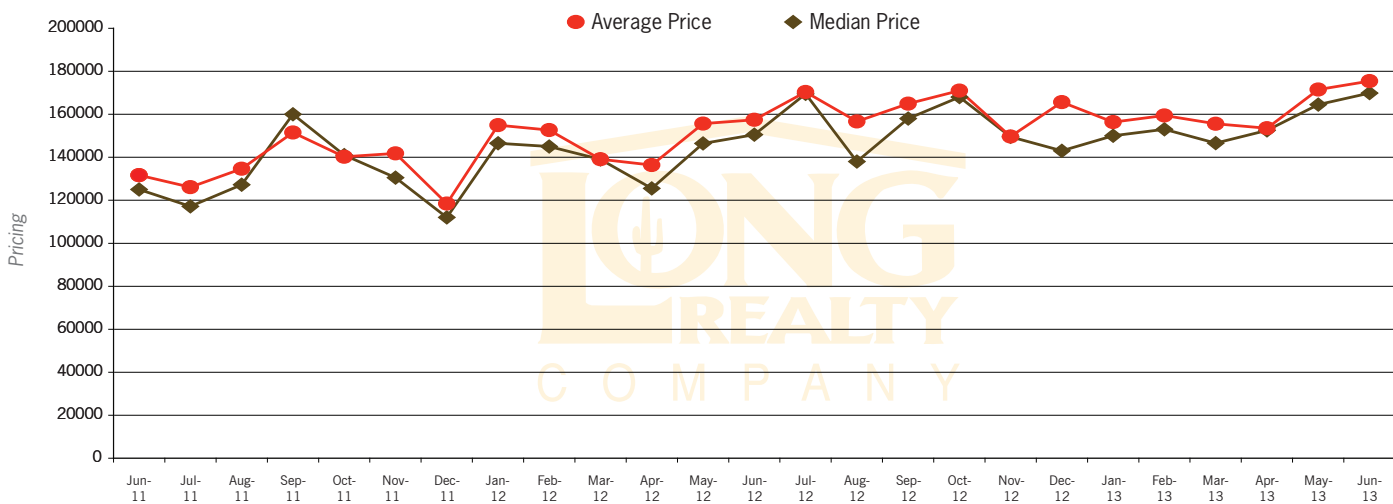
As of June 2013 active inventory was 134, a 34% increase from June 2012. There were 53 closings in June 2013, 23% above June 2012. Months of Inventory was 2.5, up from 2.3 in June 2012. Median price of sold homes was \$169,900 for the month of June 2013, up 13% from June 2012. Sahuarita had 70 new properties under contract in June 2013, up 52% from June 2012.

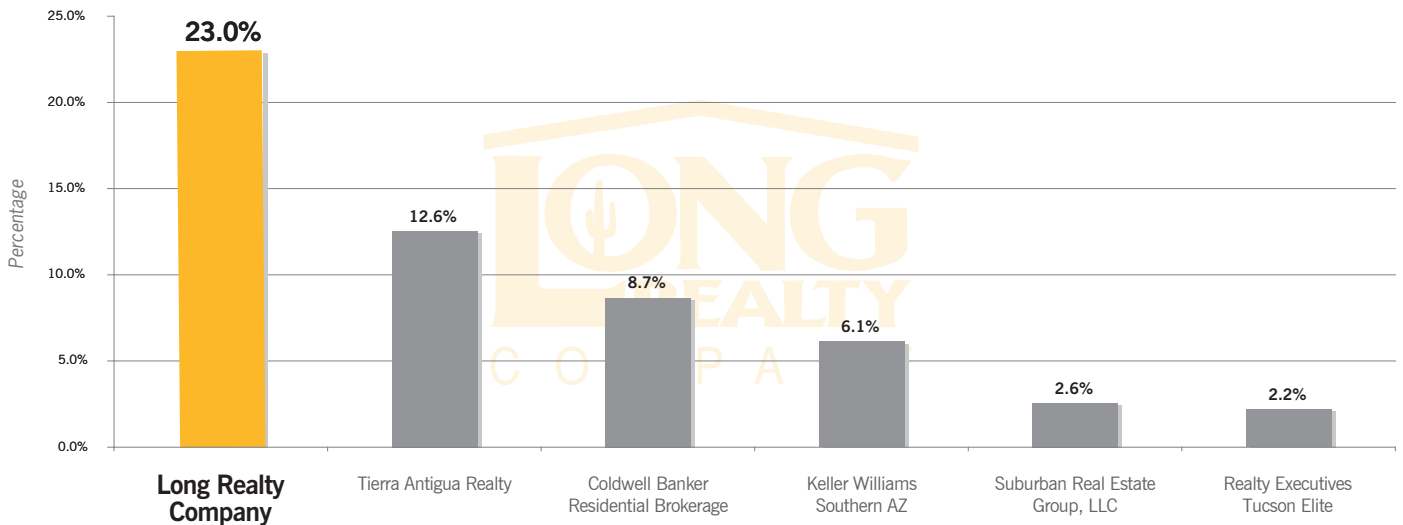
New Properties Under Contract

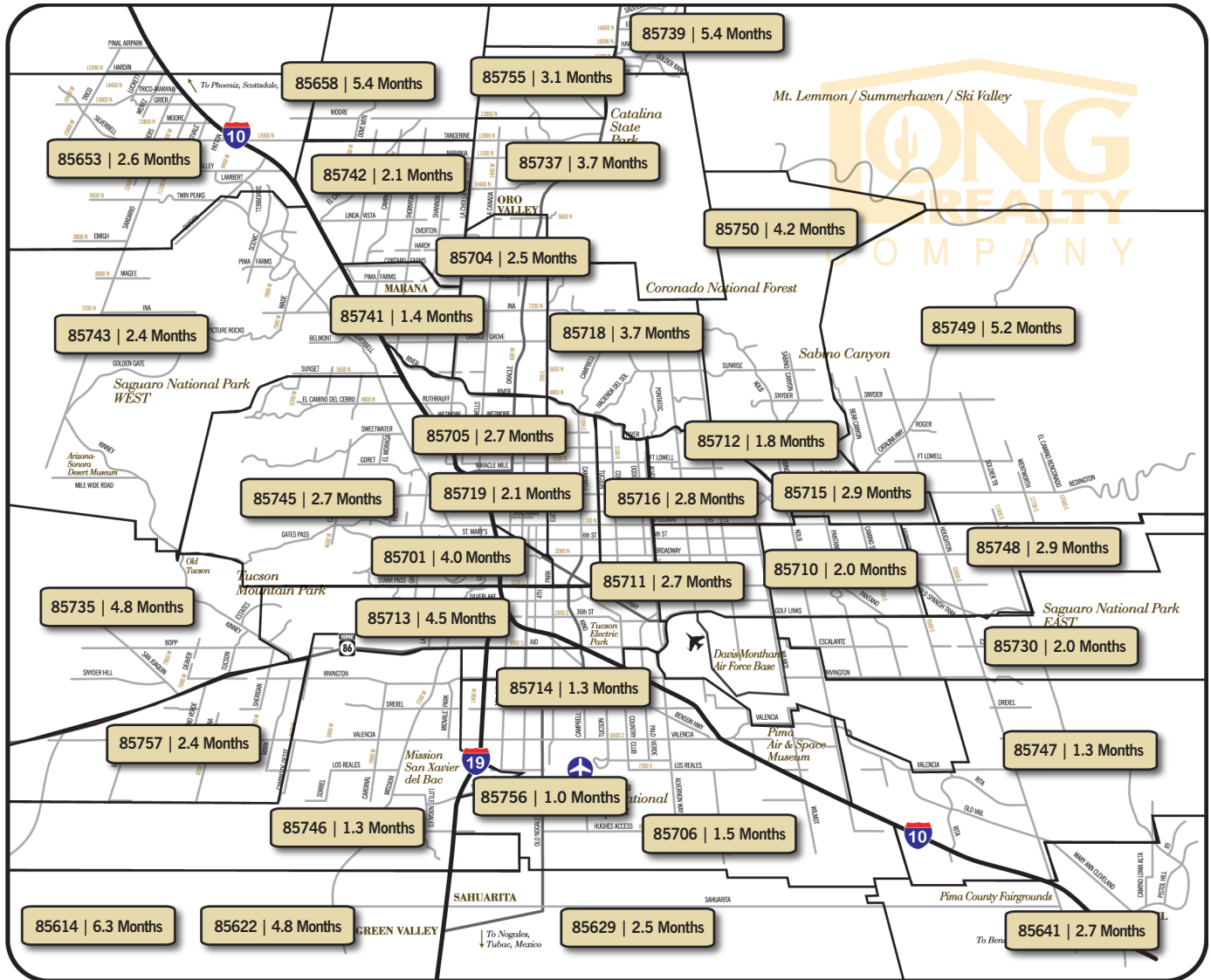

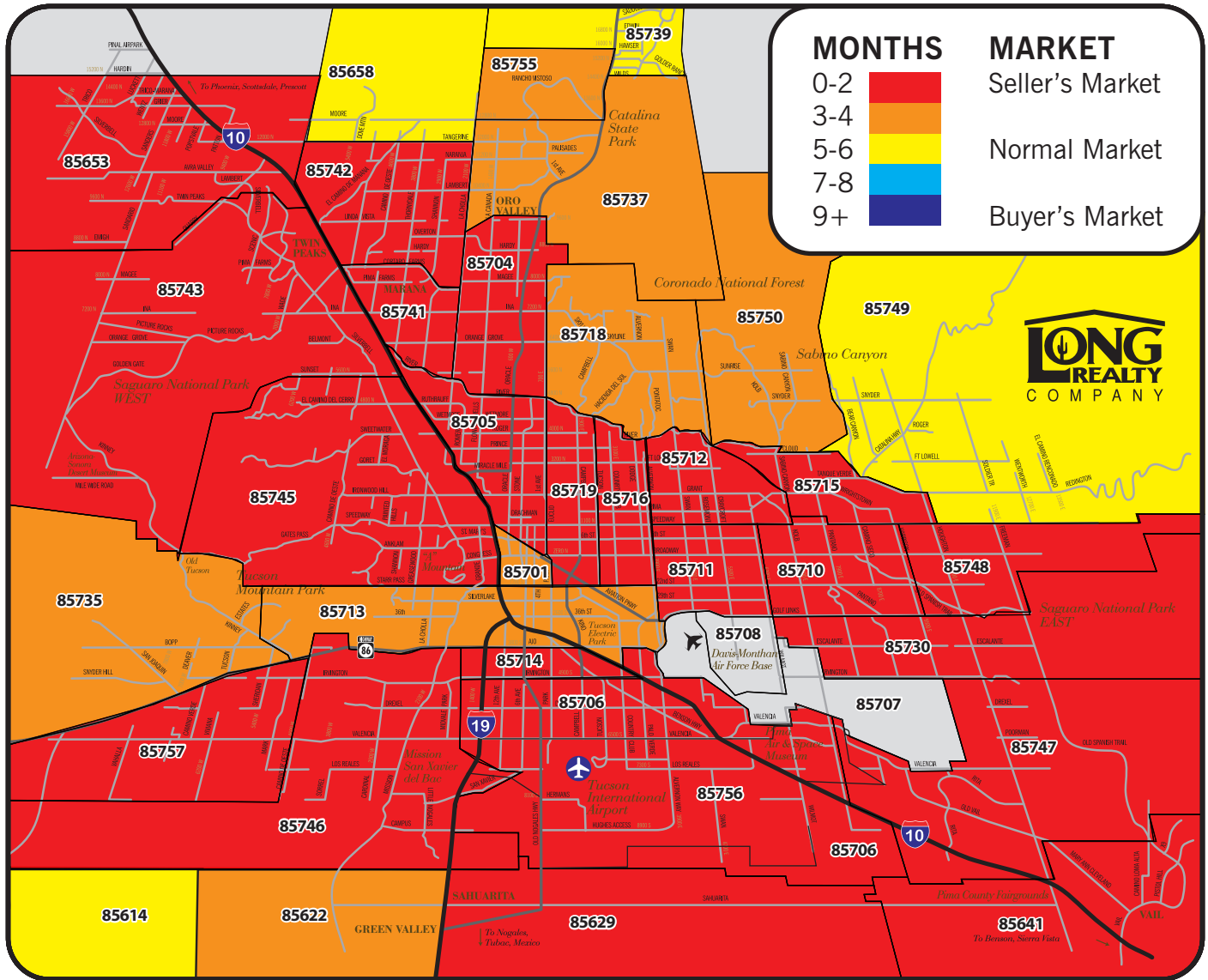
