

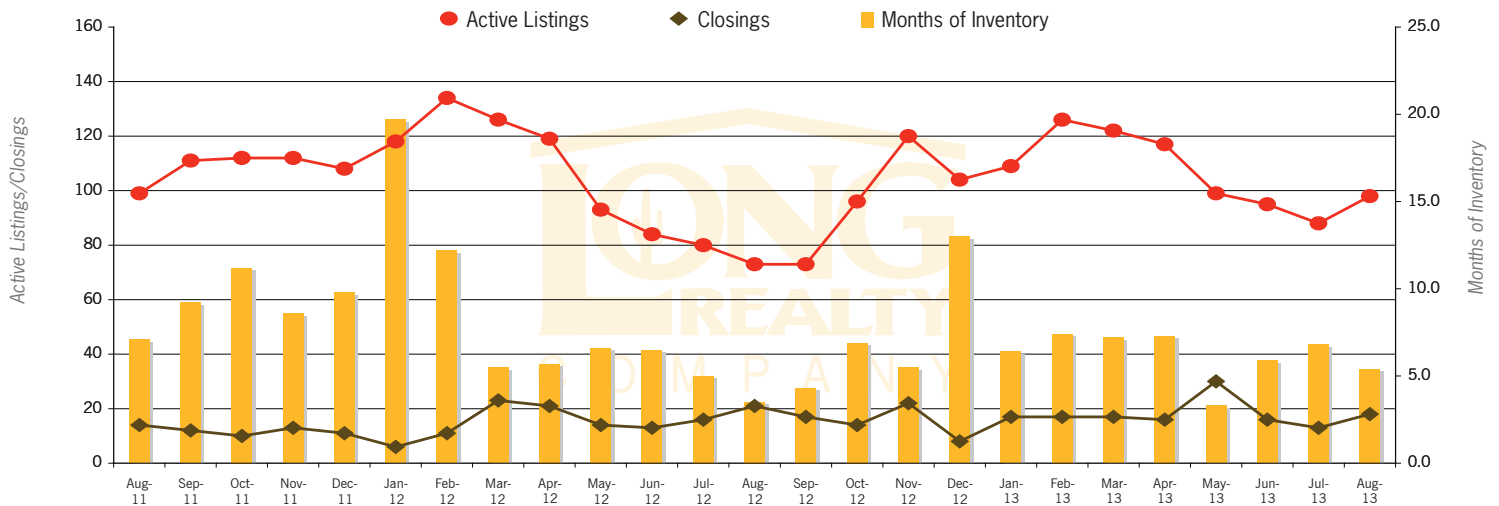

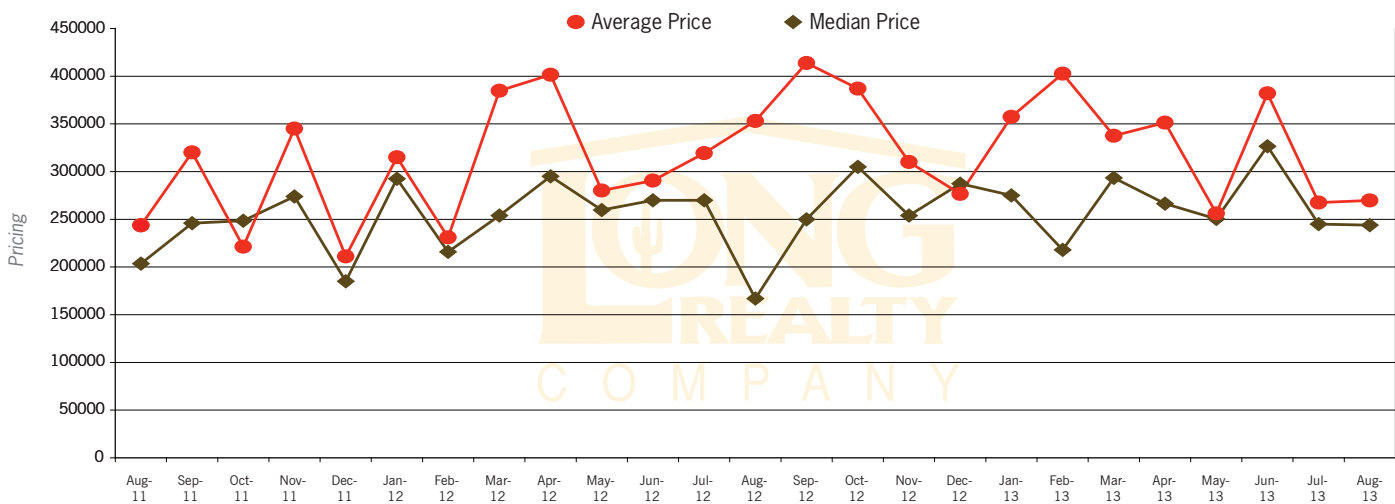
As of August 2013 active inventory was 98, a 34% increase from August 2012. There were 18 closings in August 2013, 14% below August 2012. Months of Inventory was 5.4, up from 3.5 in August 2012. Median price of sold homes was \$243,832 for the month of August 2013, up 46% from August 2012. The Dove Mountain area had 18 new properties under contract in August 2013, down 18% from August 2012.

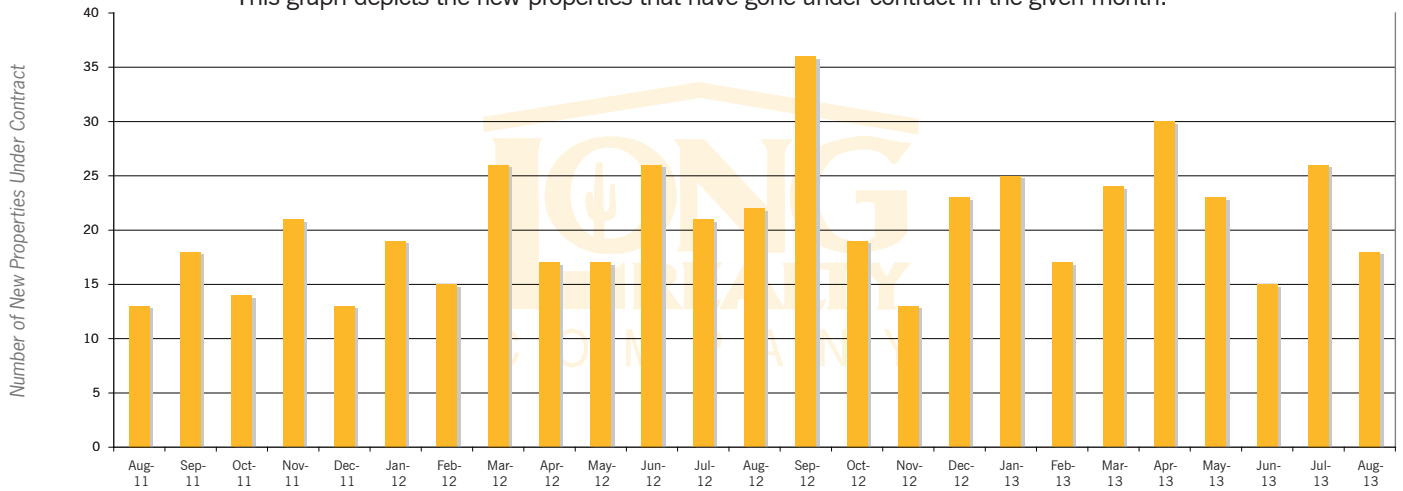

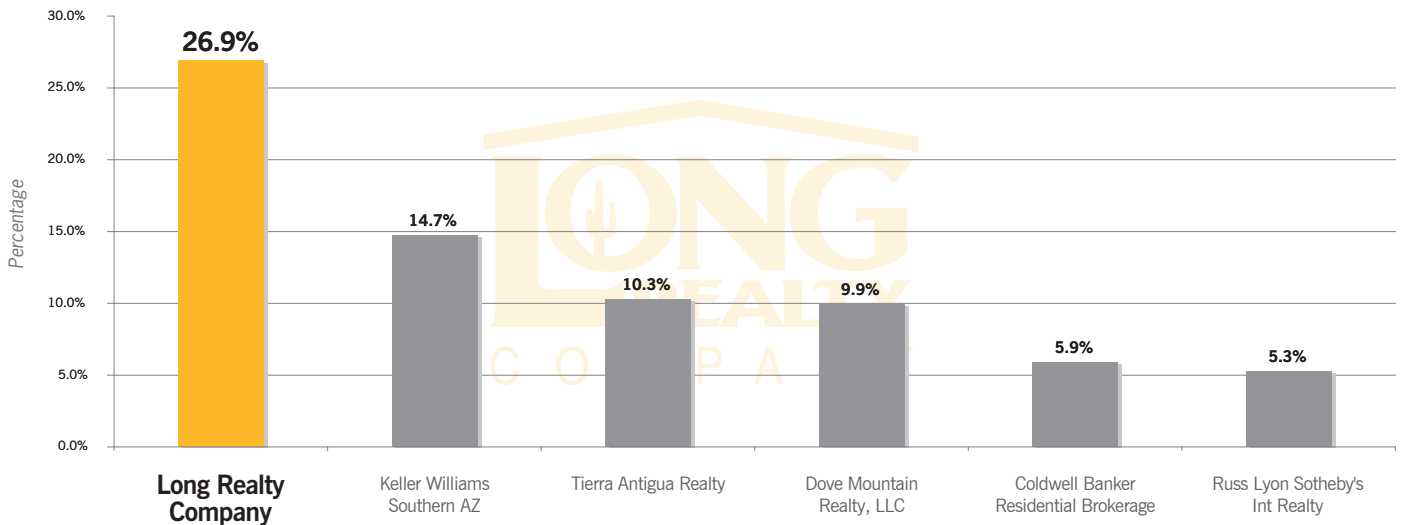
New Properties Under Contract

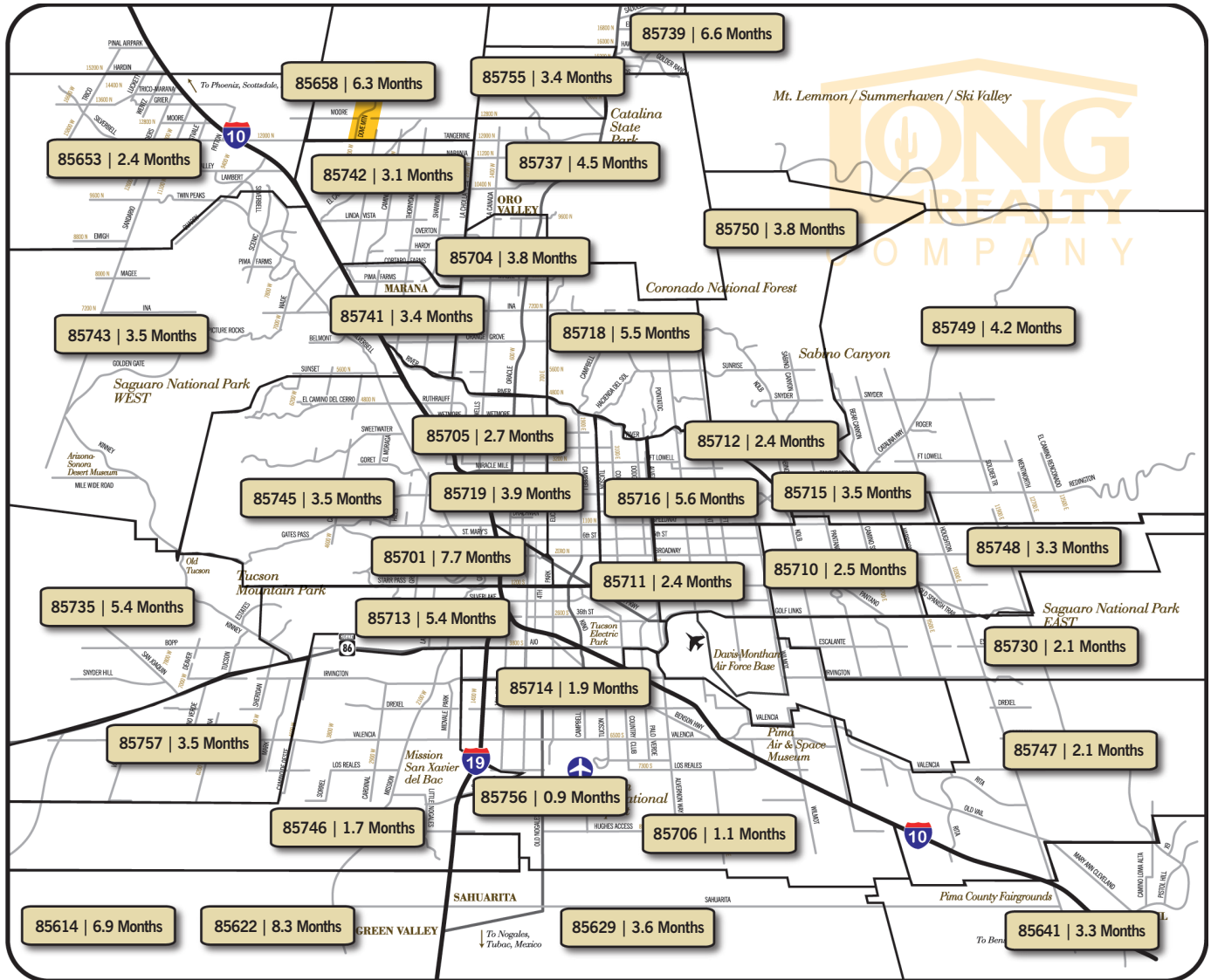

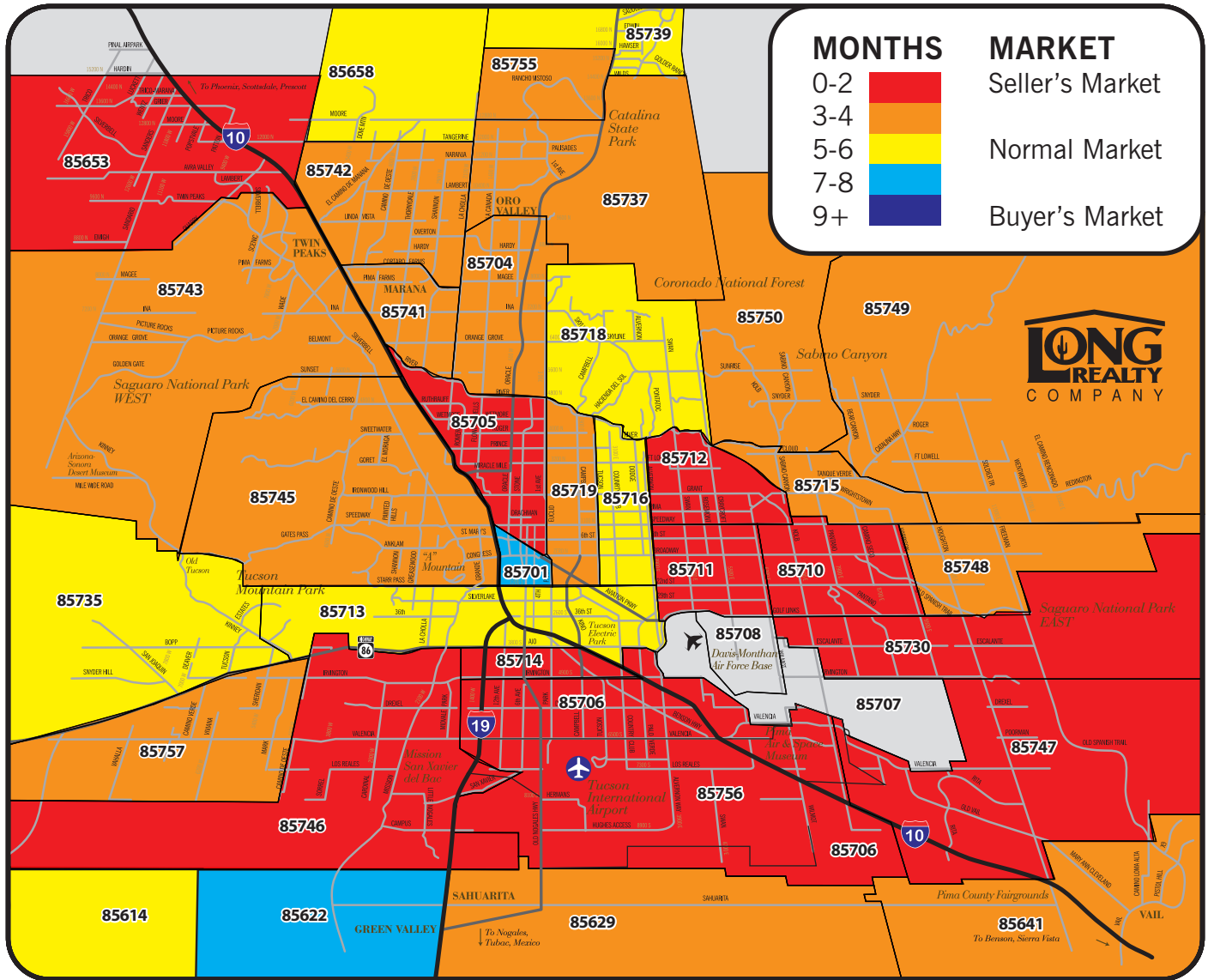
