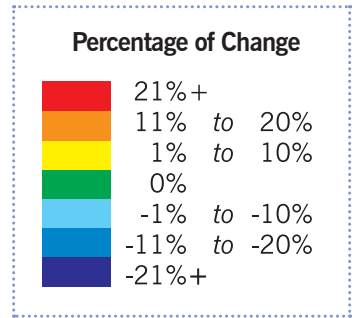
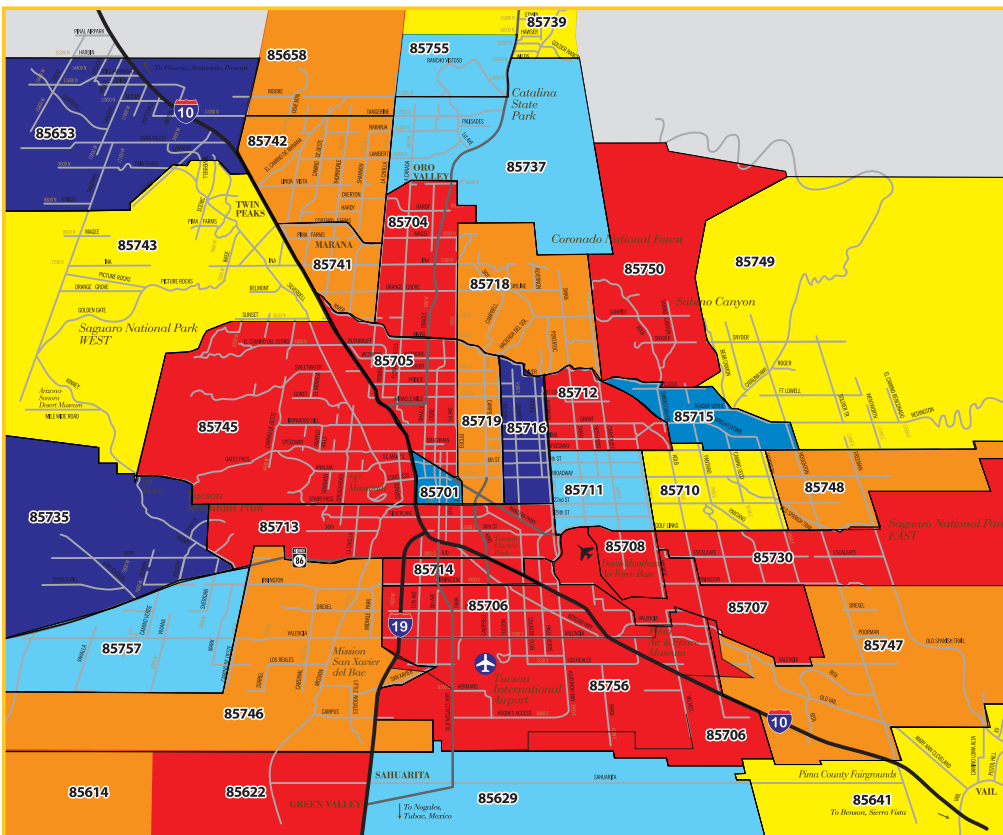

SaddleBrooke | November 2013

In the SaddleBrooke area, October 2013 active inventory was 194, a 2.5% decrease from October 2012. There were 21 closings in October 2013, a 31.3% increase from October 2012. Months of Inventory was 9.2 down from 12.4 in October 2012. Median price of sold homes was \$245,000 for the month of October 2013, down 24.8% from October 2012. The SaddleBrooke area had 25 new properties under contract in October 2013, up 127.3% from October 2012.

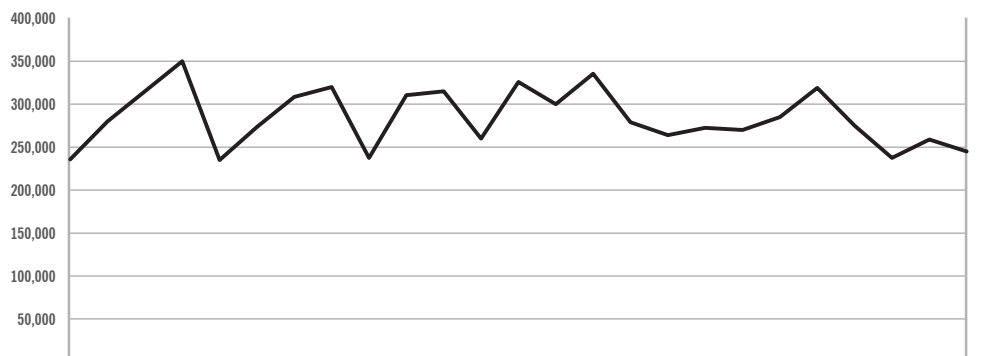
TUCSON METRO HOME SALES PRICES – PERCENTAGE OF CHANGE

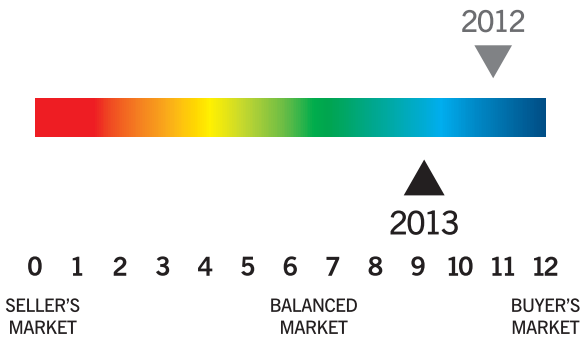

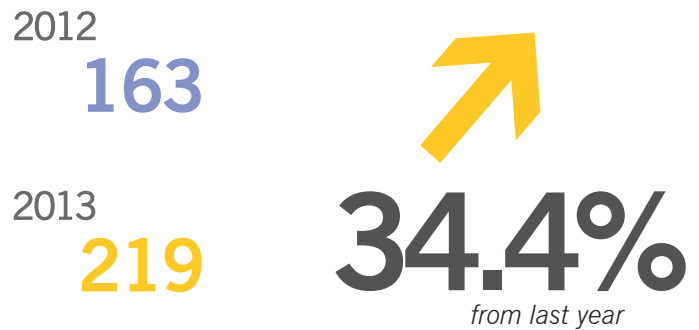
MARKET CONDITIONS – SADDLEBROOKE

Months of inventory is an important indicator of the overall health of the housing market. The balance of supply and demand is reflected by taking into account current inventory levels and the rate of home sales.

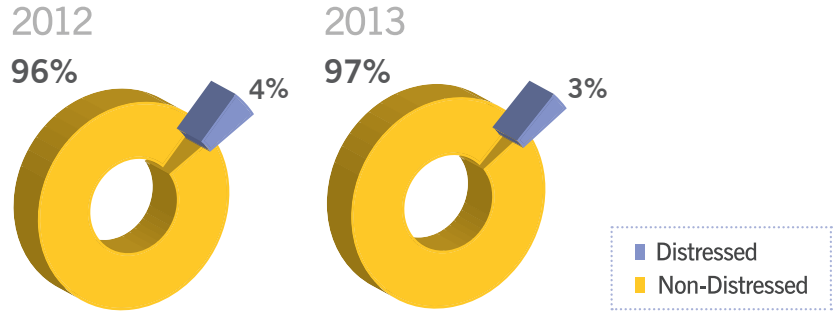

DISTRESSED VS. NON-DISTRESSED SALES – SADDLEBROOKE

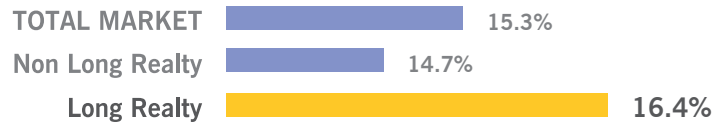

\$Volume - %Change



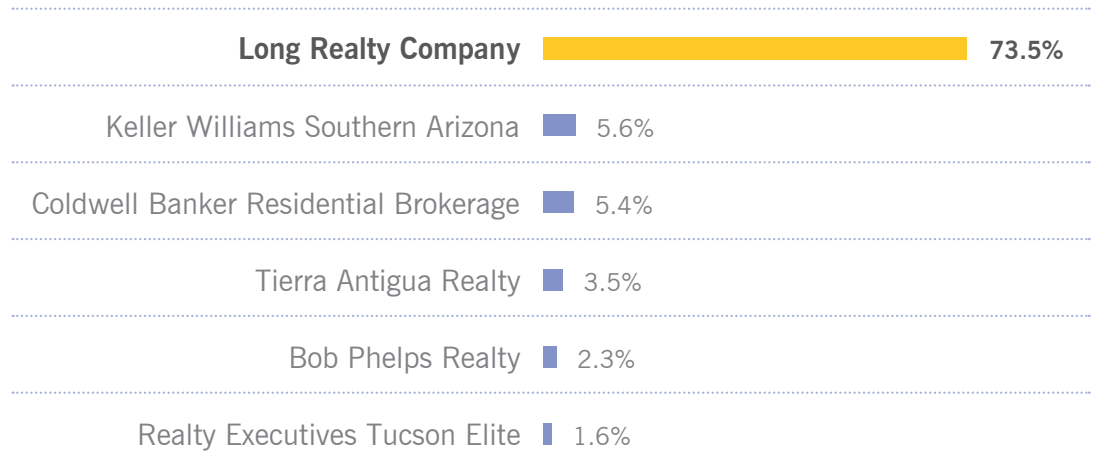
Units - %Change
