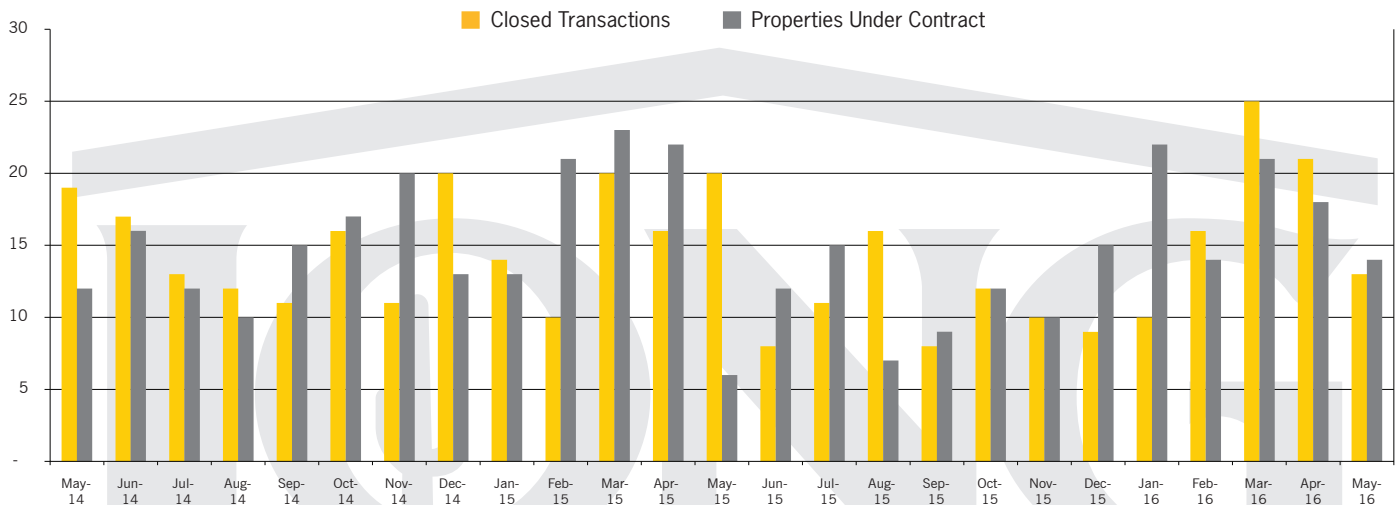




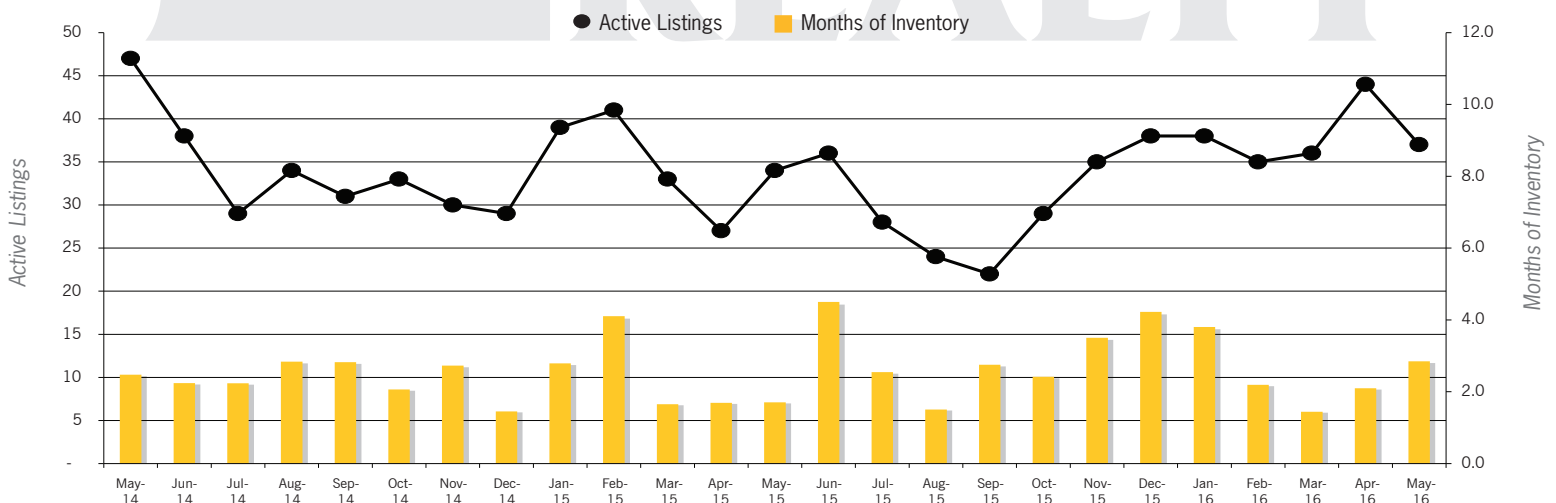
Sun City Oro Valley | June 2016

In the Sun City Oro Valley area, May 2016 active inventory was 37, a 9% increase from May 2015. There were 13 closings in May 2016, a 35% decrease from May 2015. Year-to-date 2016 there were 92 closings, a 7% increase from year-to-date 2015. Months of Inventory was 2.8, up from 1.7 in May 2015. Median price of sold homes was \$230,000 for the month of May 2016, up 5% from May 2015. The Sun City Oro Valley area had 14 new properties under contract in May 2016, up 133% from May 2015.

CLOSED SALES AND NEW PROPERTIES UNDER CONTRACT – SUN CITY ORO VALLEY



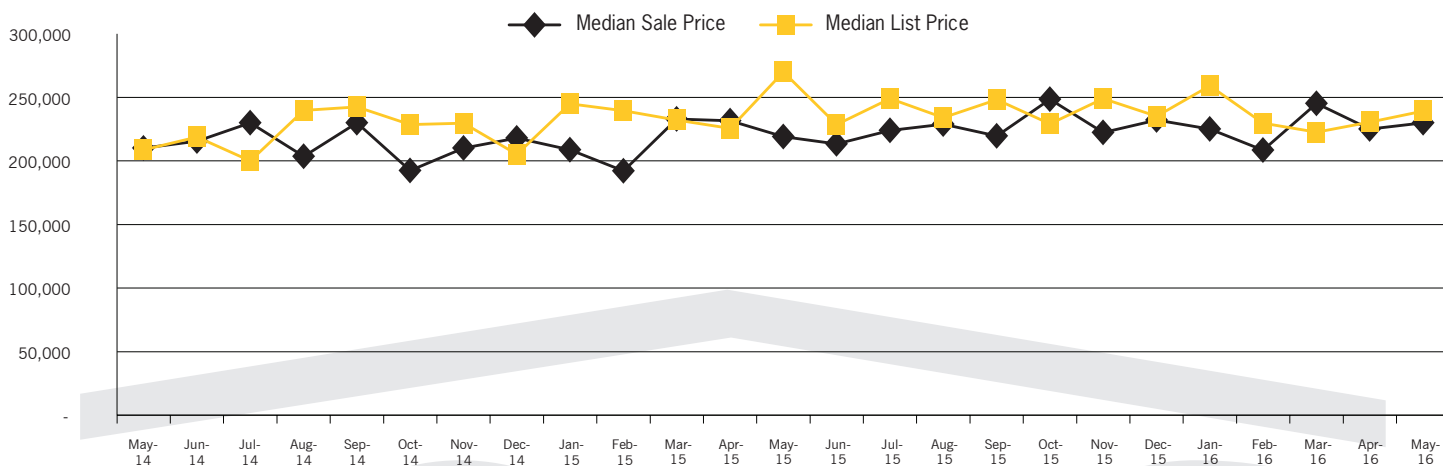
ACTIVE LISTINGS AND MONTHS OF INVENTORY – SUN CITY ORO VALLEY

MEDIAN SOLD PRICE AND MEDIAN LISTED PRICE – SUN CITY ORO VALLEY

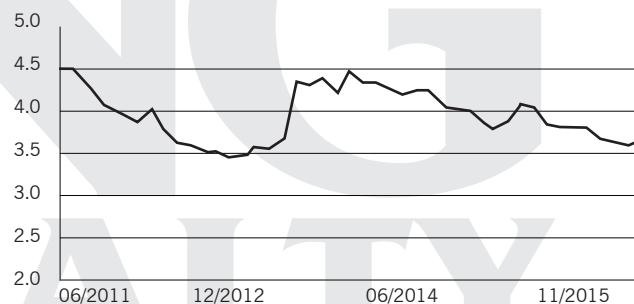

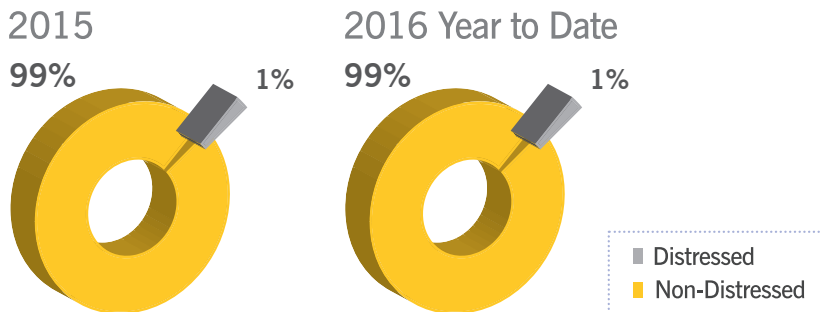
30 YEAR FIXED MORTGAGE RATE

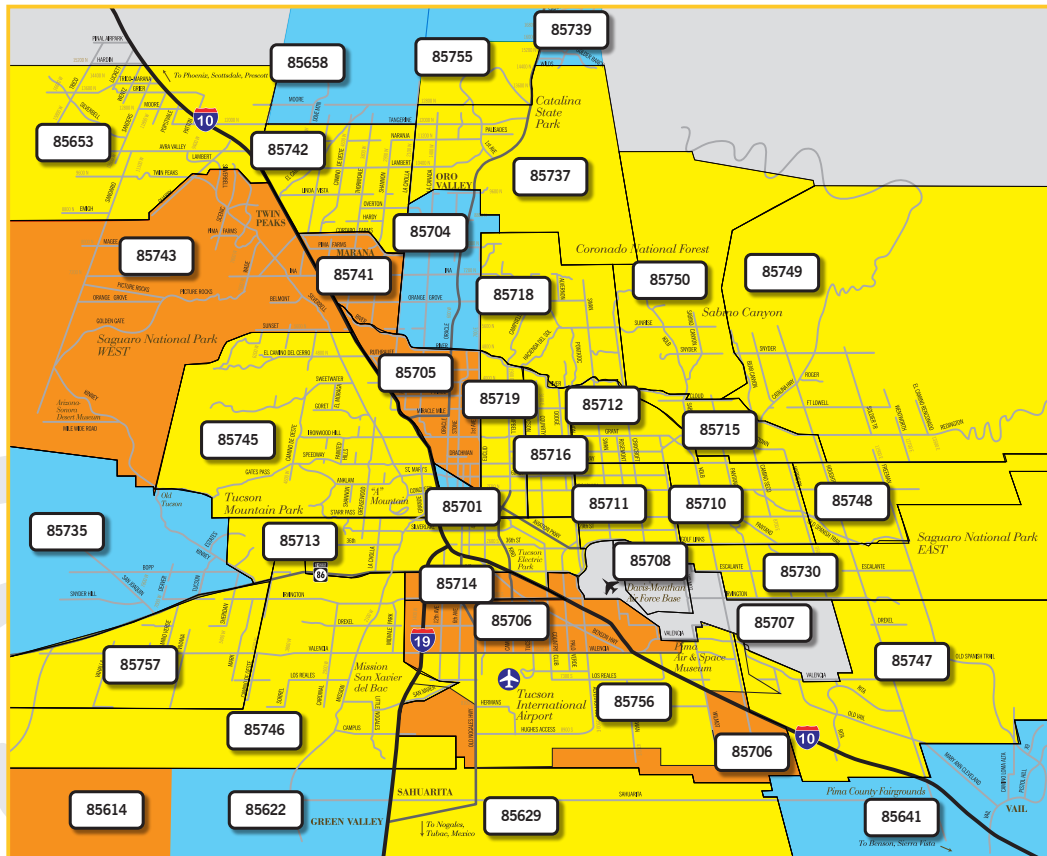
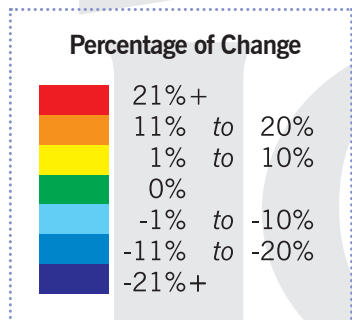

MAR 2015-MAY 2015 TO MAR 2016-MAY 2016

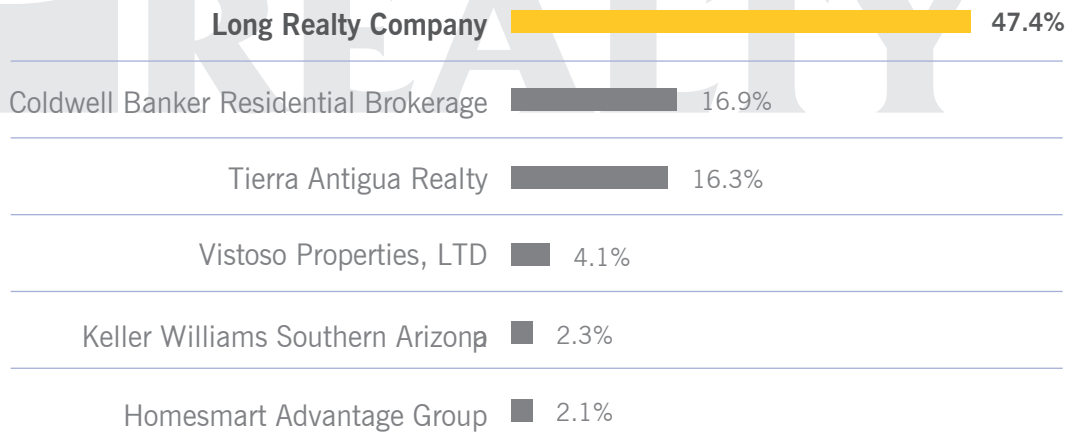
This heat map represents the percentage of change in Tucson metro median sales prices from March 2015-May 2015 to March 2016-May 2016 by zip code.
