


Continental Ranch | December 2012

As of November 2012 active inventory was 48, a 26% decrease from November 2011. There were 10 closings in November 2012, 62% below November 2011. Months of Inventory was 4.8 up from 2.5 in November 2011. Median price of sold homes was \$158,000 for the month of November 2012, up 2% from November 2011. The Continental Ranch area had 22 new properties under contract in November 2012, virtually unchanged from November 2011.


Median and Average Price (Closed Sales)















