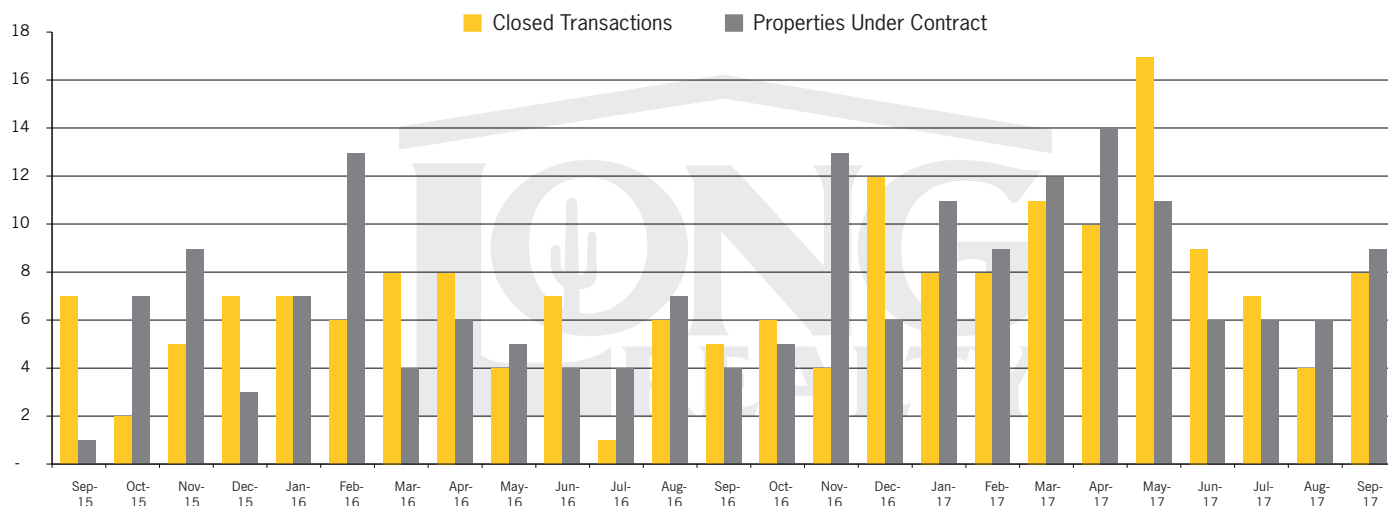




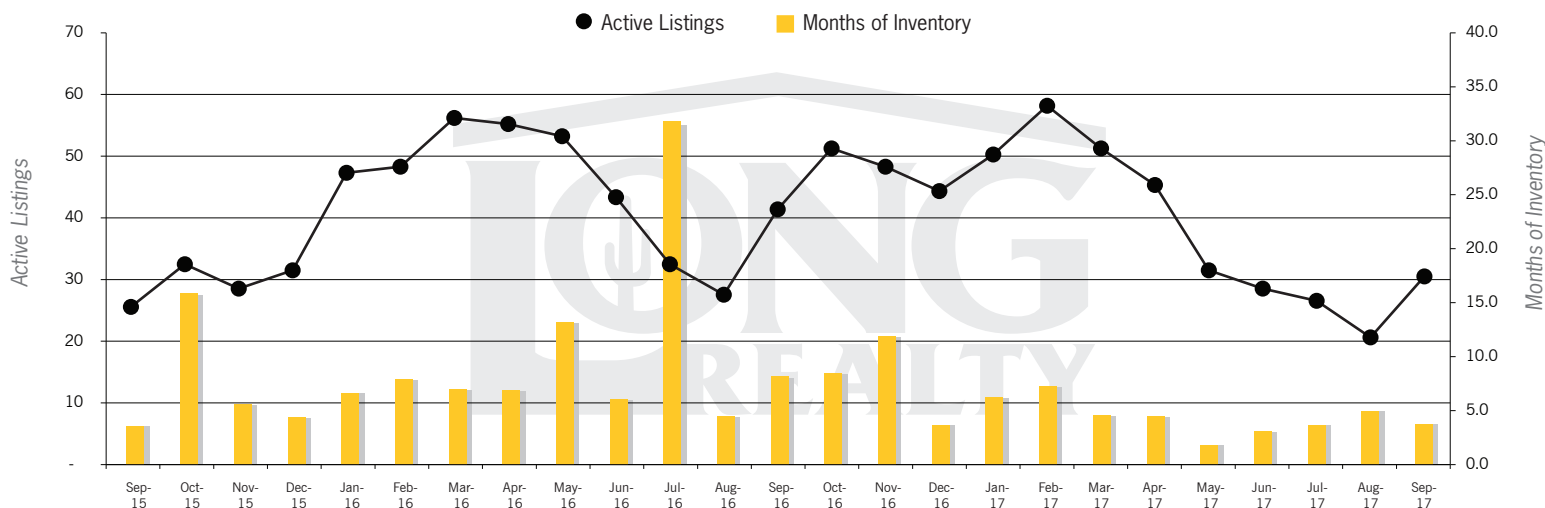
The Highlands at Dove Mountain | October 2017

In the Highlands at Dove Mountain area, September 2017 active inventory was 30, a 27% decrease from September 2016. There were 8 closings in September 2017, a 60% increase from September 2016. Year-to-date 2017 there were 82 closings, a 58% increase from year-to-date 2016. Months of Inventory was 3.8, down from 8.2 in September 2016. Median price of sold homes was \$241,150 for the month of September 2017, down 6% from September 2016. The Highlands at Dove Mountain area had 9 new properties under contract in September 2017, up 125% from September 2016.

ACTIVE LISTINGS AND MONTHS OF INVENTORY – THE HIGHLANDS AT DOVE MOUNTAIN

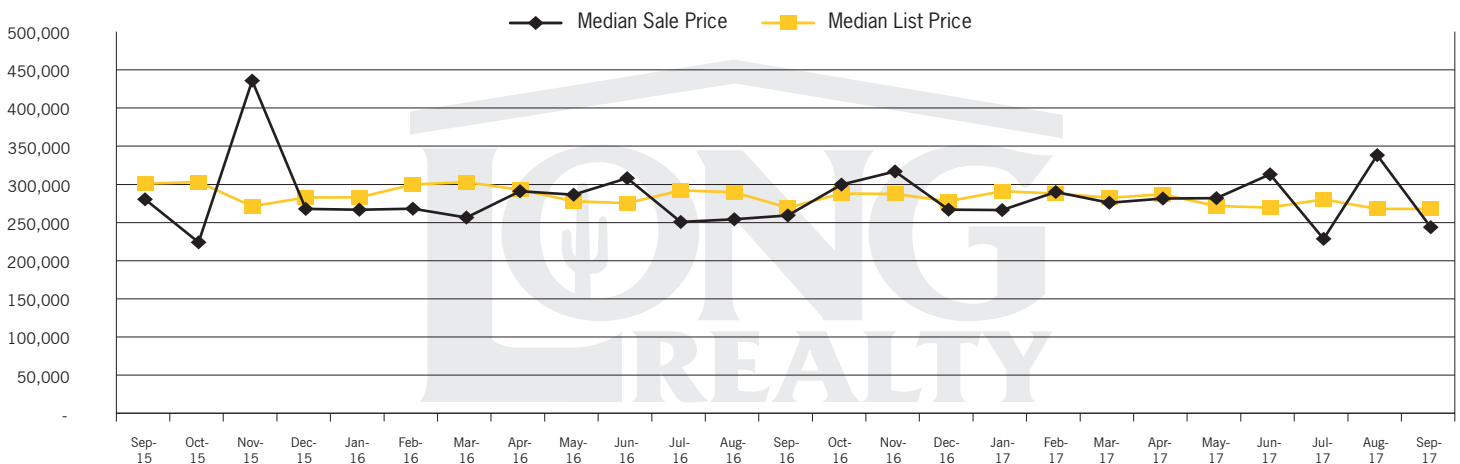

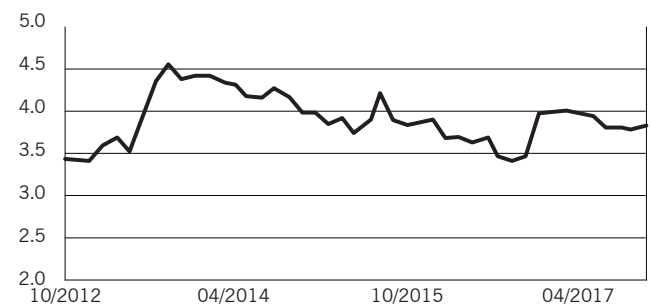
MEDIAN SOLD PRICE AND MEDIAN LISTED PRICE – THE HIGHLANDS AT DOVE MOUNTAIN

30 YEAR FIXED MORTGAGE RATE

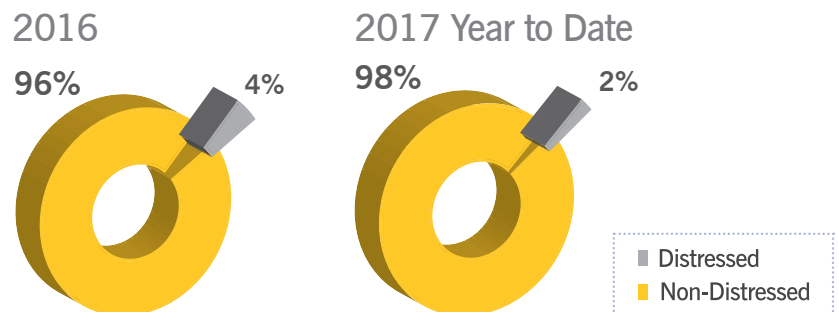

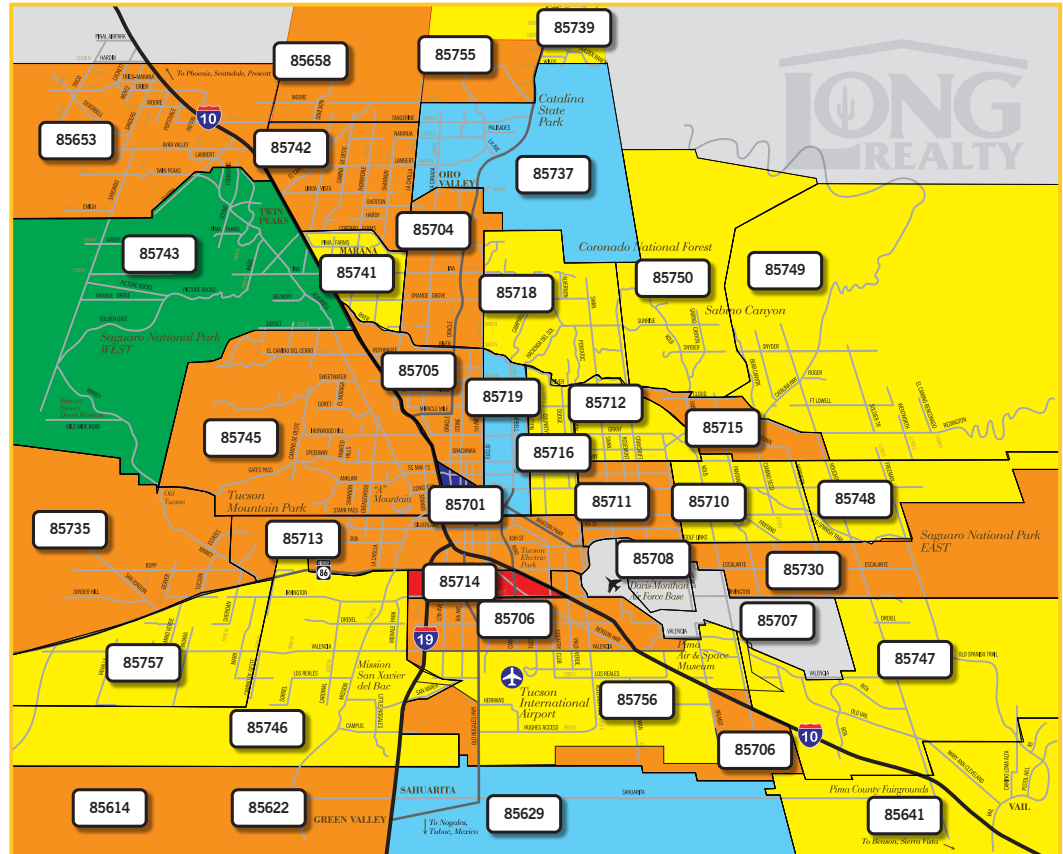

JUL 2017-SEP 2017

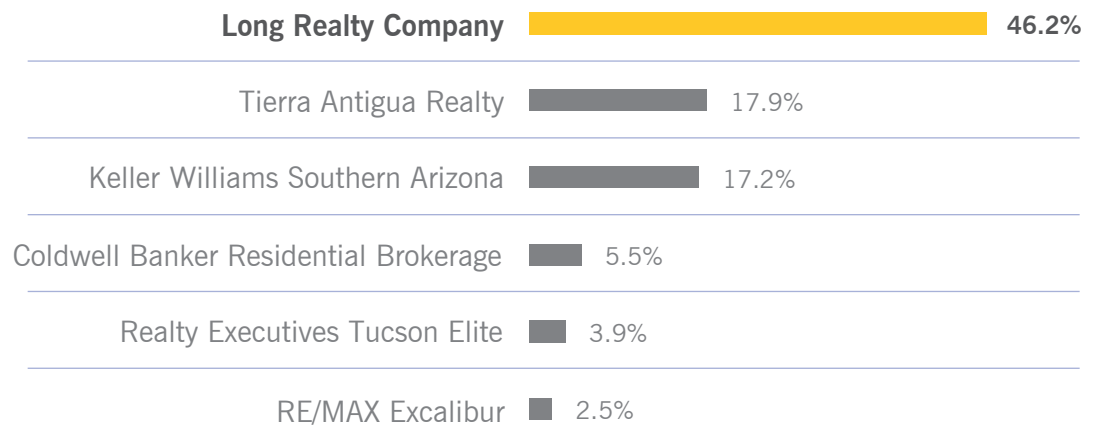
This heat map represents the percentage of change in Tucson metro median sales prices from July 2016-September 2016 to July 2017-September 2017 by zip code.
