




#### The Highlands at Dove Mountain | February 2018

In the Highlands at Dove Mountain area, January 2018 active inventory was 18, a 64% decrease from January 2017. There were 6 closings in January 2018, a 25% decrease from January 2017. Year-to-date 2018 there were 6 closings, a 25% decrease from year-to-date 2017. Months of Inventory was 3.0, down from 6.3 in January 2017. Median price of sold homes was \$319,500 for the month of January 2018, up 21% from January 2017. The Highlands at Dove Mountain area had 10 new properties under contract in January 2018, down 9% from January 2017.





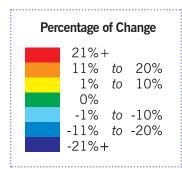



This heat map represents the percentage of change in Tucson metro median sales prices from November 2016-January 2017 to November 2017-January 2018 by zip code.






#### MARKET SHARE – THE HIGHLANDS AT DOVE MOUNTAIN
