

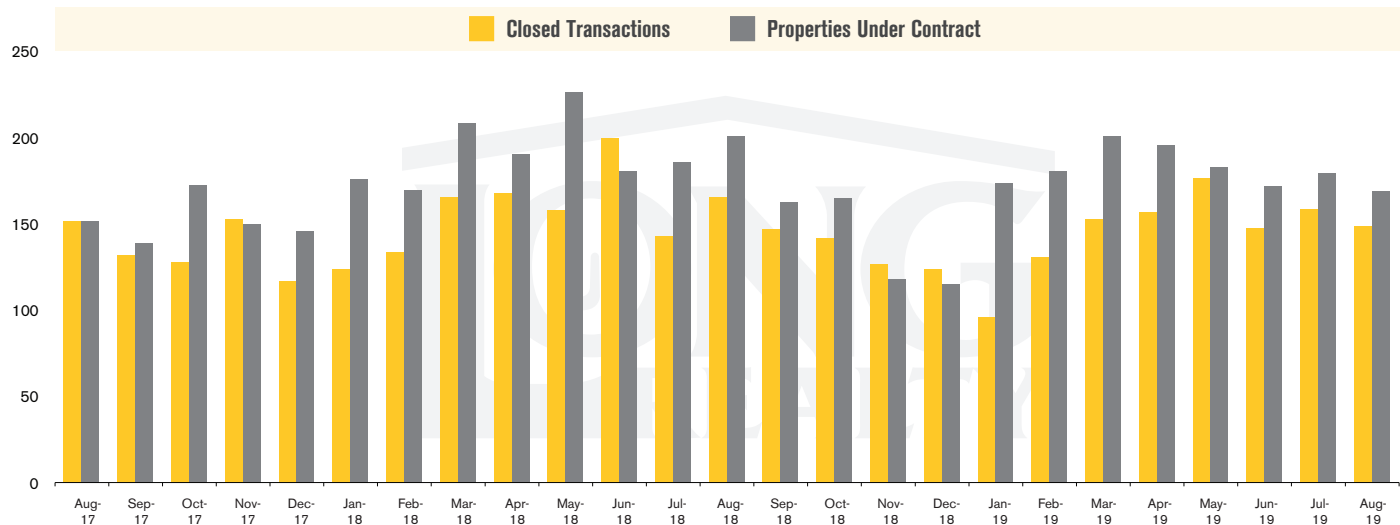

TUCSON EAST | SEPTEMBER 2019

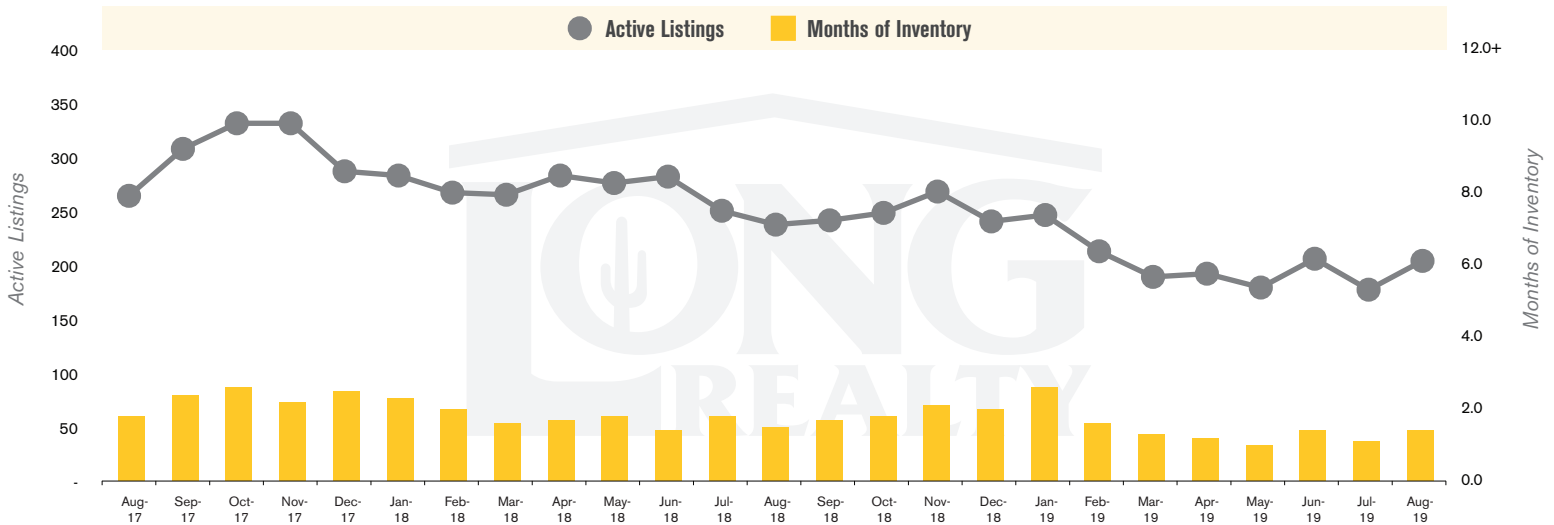


In the Tucson East area, August 2019 active inventory was 207, a 14% decrease from August 2018. There were 149 closings in August 2019, a 10% decrease from August 2018. Year-to-date 2019 there were 1,231 closings, a 7% decrease from year-to-date 2018. Months of Inventory was 1.4, down from 1.5 in August 2018. Median price of sold homes was \$194,900 for the month of August 2019, up 5% from August 2018. The Tucson East area had 169 new properties under contract in August 2019, down 16% from August 2018.

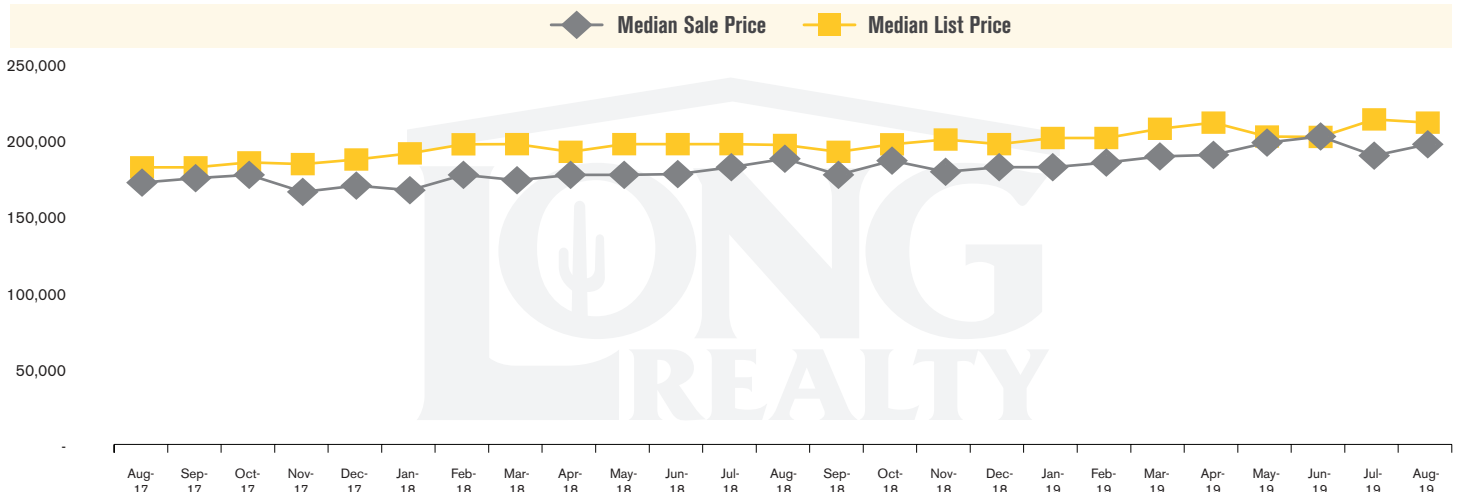

MEDIAN SOLD PRICE AND MEDIAN LISTED PRICE (TUCSON EAST)

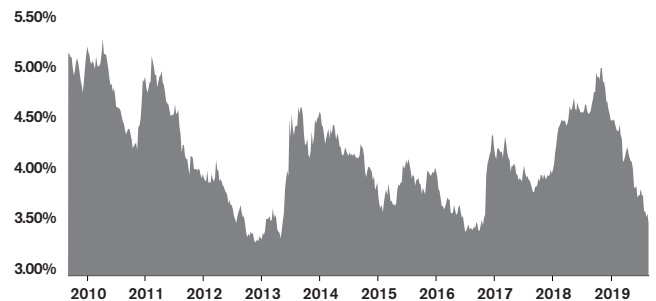

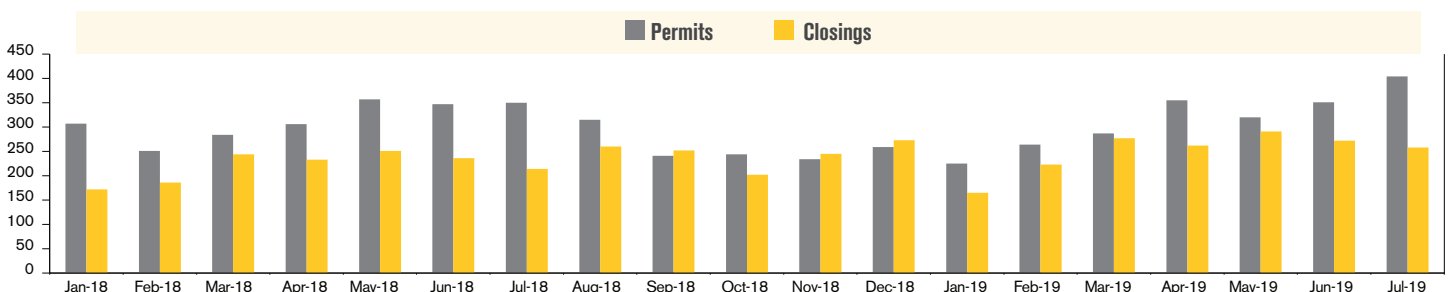

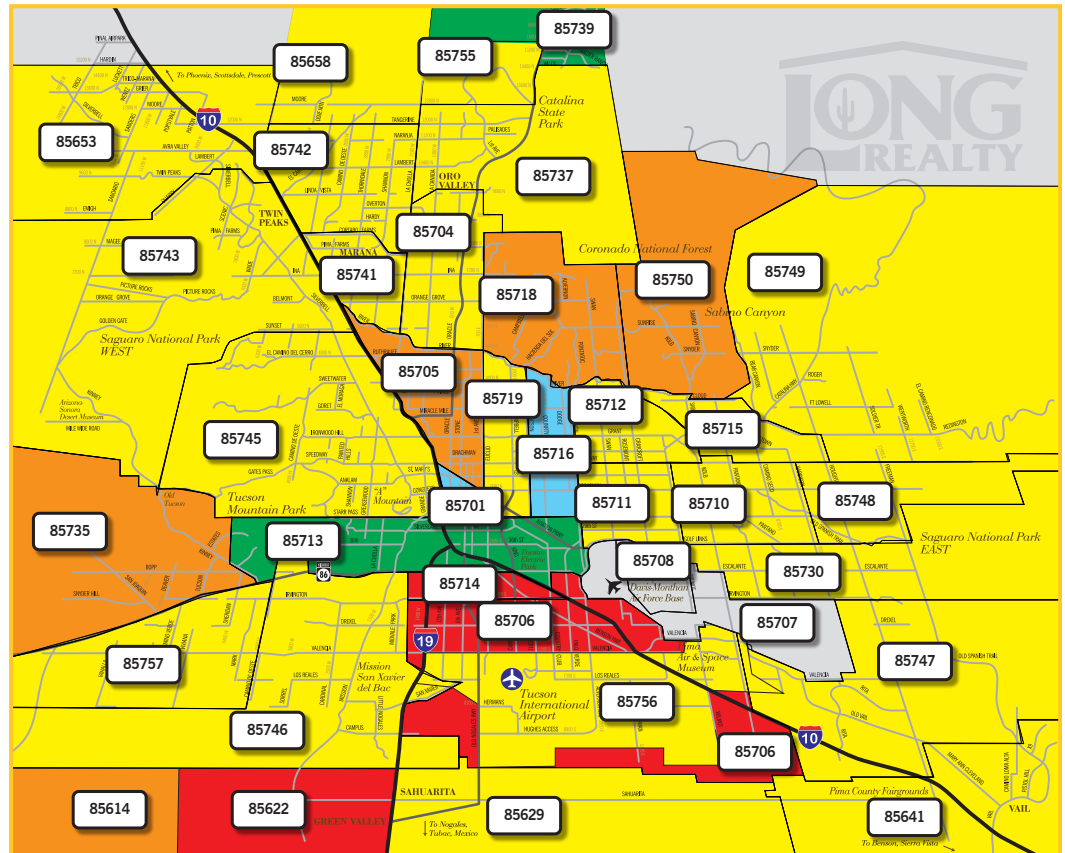
