

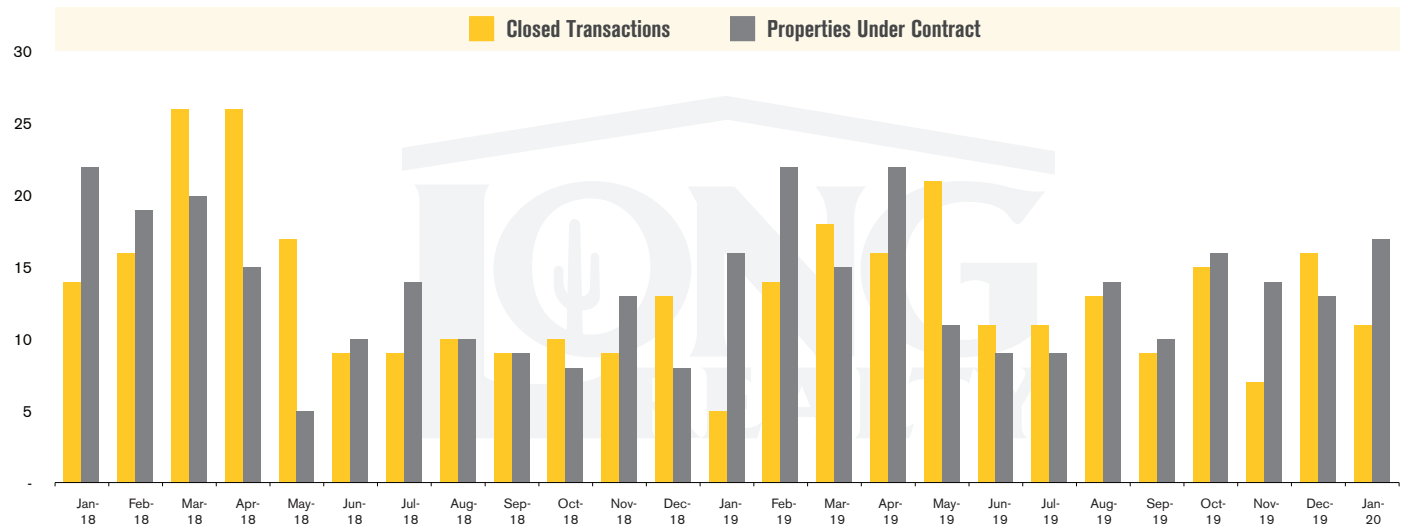

SUN CITY ORO VALLEY | FEBRUARY 2020

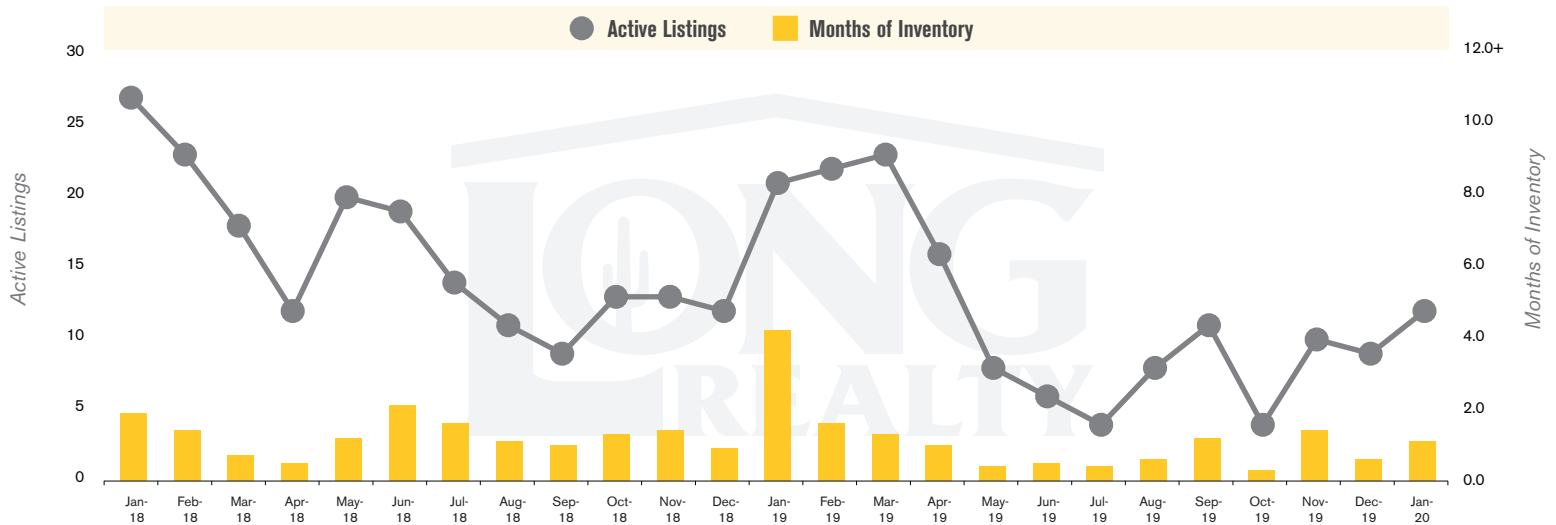


In the Sun City Oro Valley area, January 2020 active inventory was 12, a 43% decrease from January 2019. There were 11 closings in January 2020, a 120% increase from January 2019. Year-to-date 2020 there were 11 closings, a 140% increase from year-to-date 2018. Months of Inventory was 1.1, down from 4.2 in January 2019. Median price of sold homes was \$277,000 for the month of January 2020, up 15% from January 2019. The Sun City Oro Valley area had 17 new properties under contract in January 2020, up 6% from January 2019.

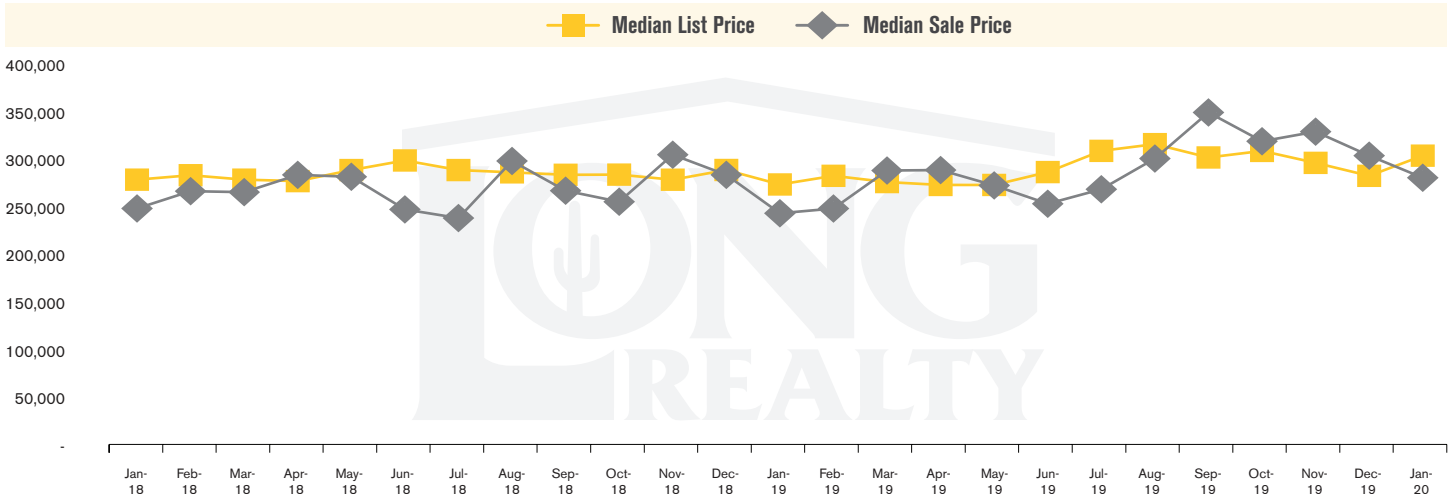

MEDIAN SOLD PRICE AND MEDIAN LISTED PRICE (SUN CITY ORO VALLEY)

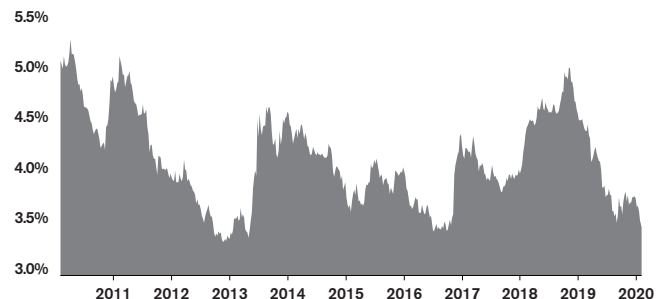

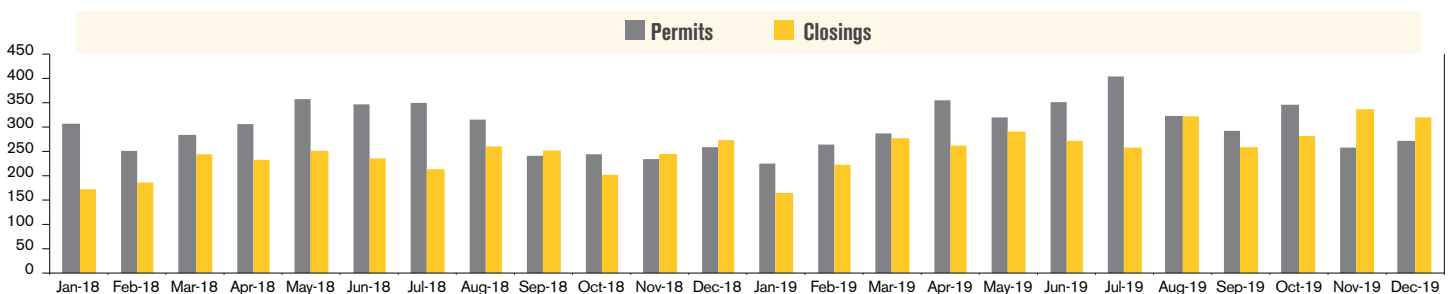

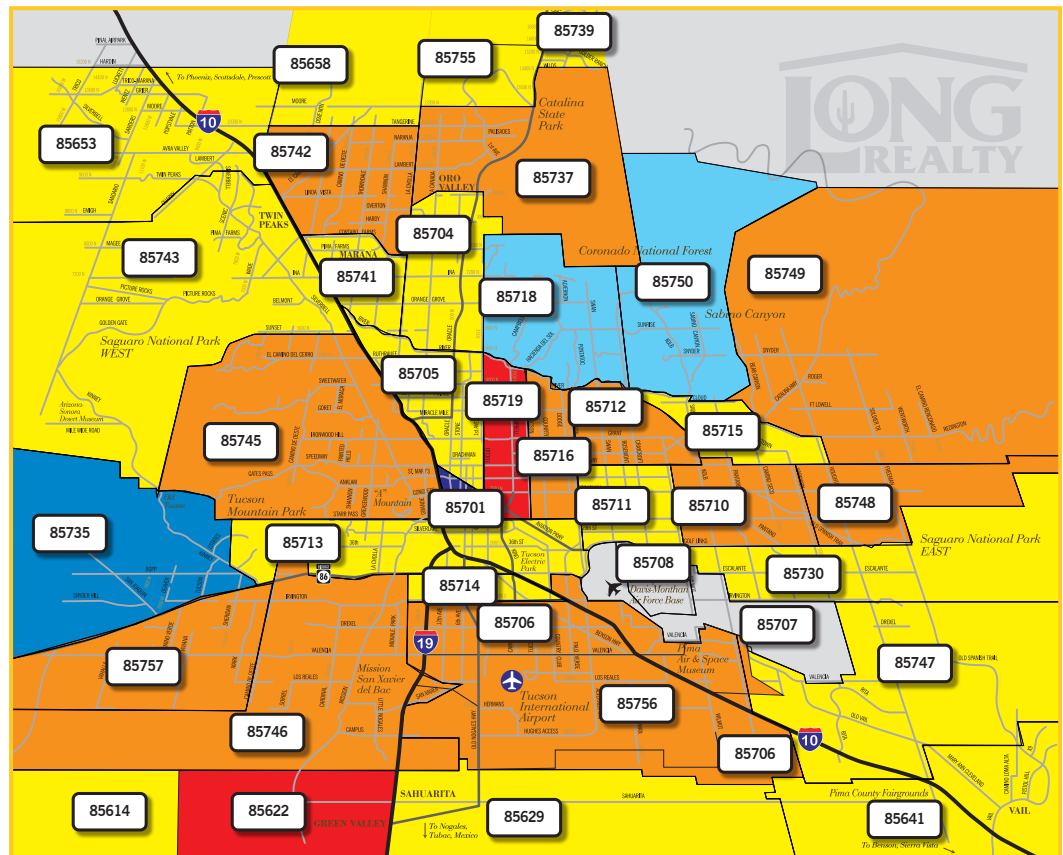
