



CONTINENTAL RANCH | OCTOBER 2020

In the Continental Ranch area, September 2020 active inventory was 9, a 65% decrease from September 2019. There were 24 closings in September 2020, a 4% decrease from September 2019. Year-to-date 2020 there were 226 closings, a 7% increase from year-to-date 2019. Months of Inventory was .4, down from 1.0 in September 2019. Median price of sold homes was \$266,250 for the month of September 2020, up 8% from September 2019. The Continental Ranch area had 32 new properties under contract in September 2020, up 88% from September 2019.

ACTIVE LISTINGS AND MONTHS OF INVENTORY (CONTINENTAL RANCH)







MEDIAN SOLD PRICE AND MEDIAN LISTED PRICE (CONTINENTAL RANCH)





Long Realty leads the market in successful real estate sales.

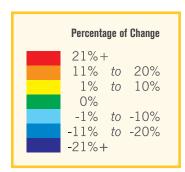




CHANGE IN MEDIAN SALES PRICE BY ZIP CODE
