

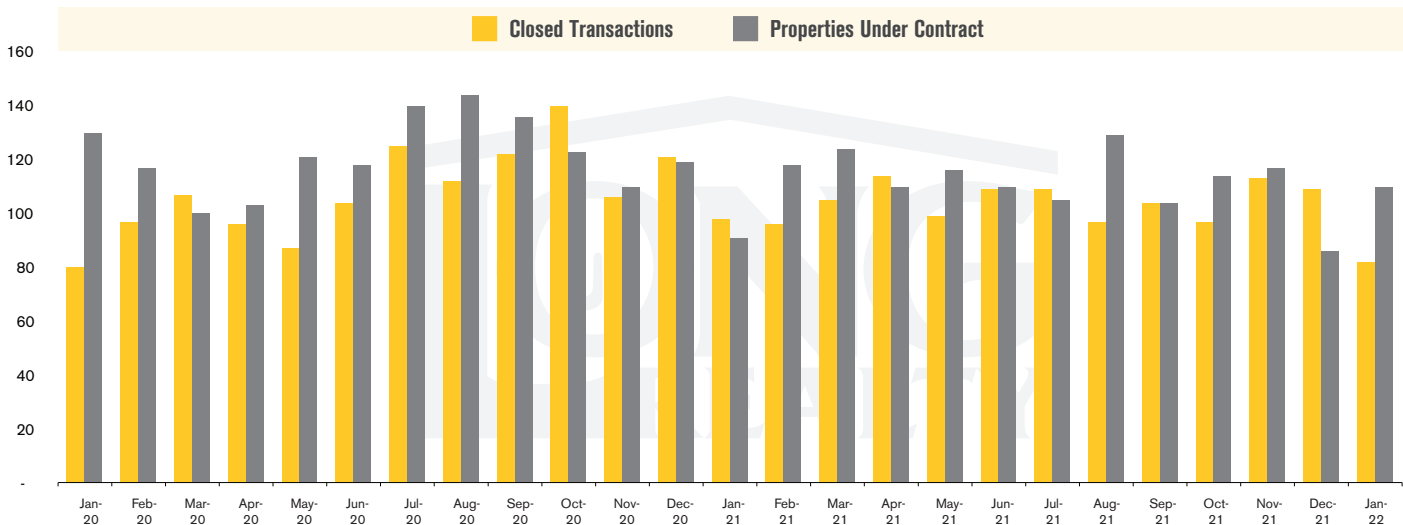

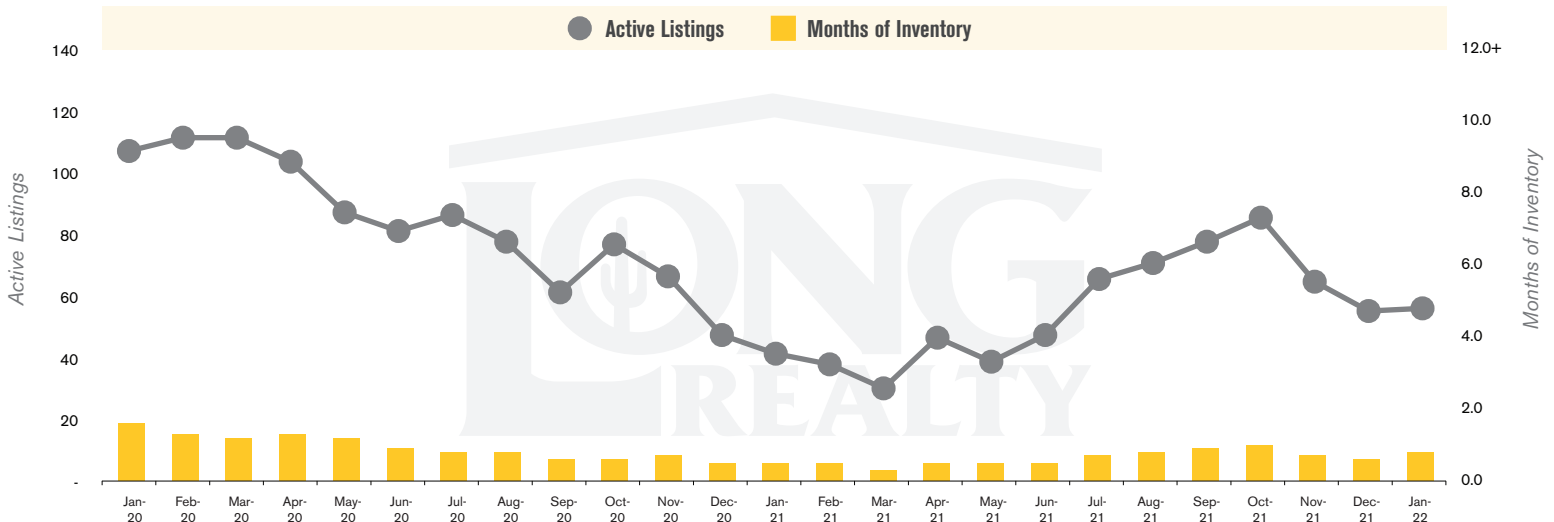


In the Tucson West area, January 2022 active inventory was 65, a 35% increase from January 2021. There were 82 closings in January 2022, a 16% decrease from January 2021. Year-to-date 2022 there were 82 closings, a 16% decrease from year-to-date 2021. Months of Inventory was 0.8, up from 0.5 in January 2021. Median price of sold homes was \$315,000 for the month of January 2022, up 9% from January 2021. The Tucson West area had 110 new properties under contract in January 2022, up 21% from January 2021.

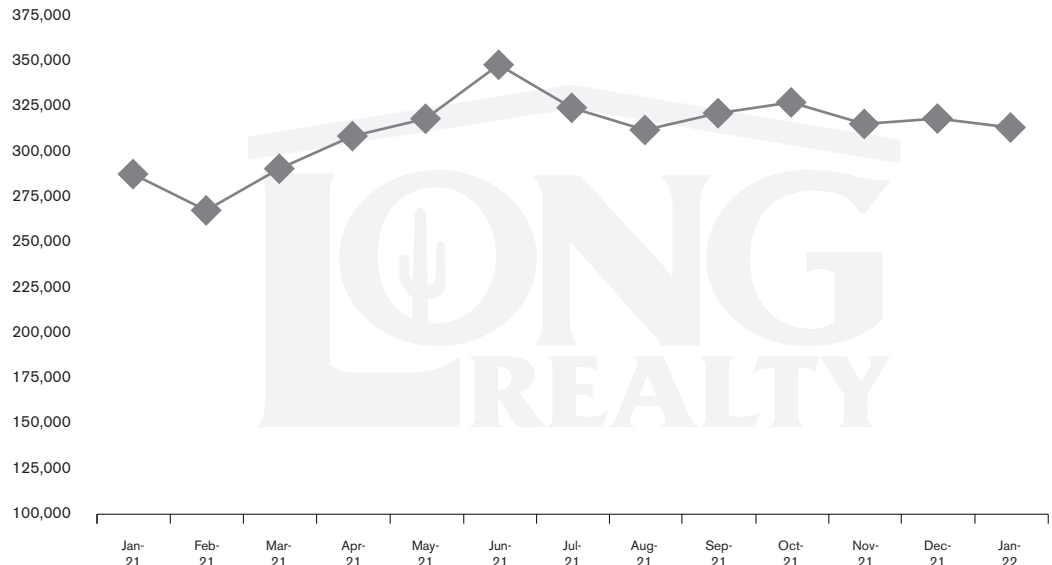

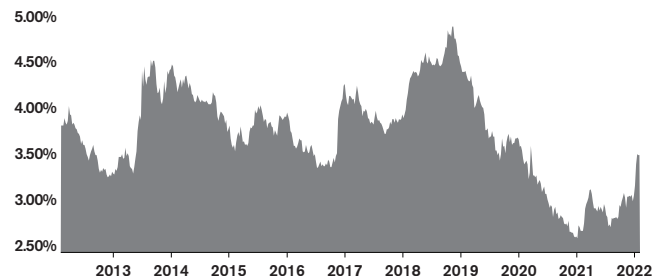

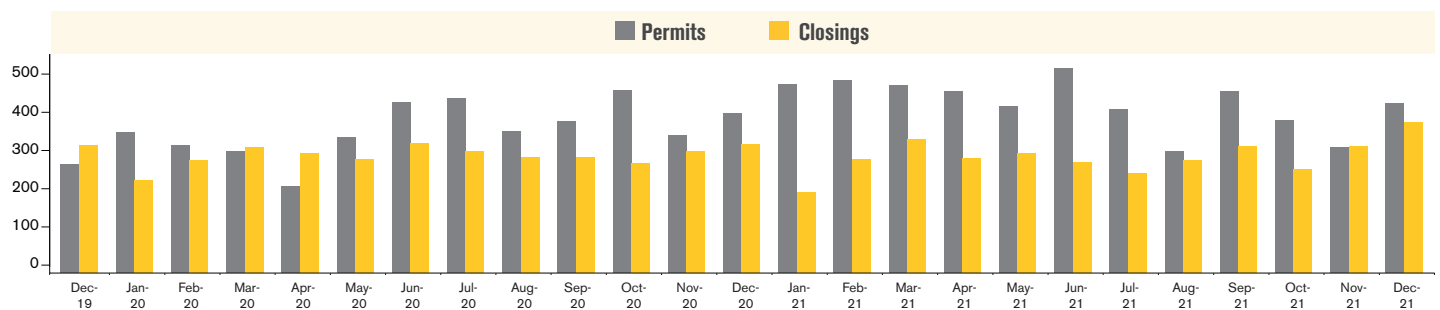

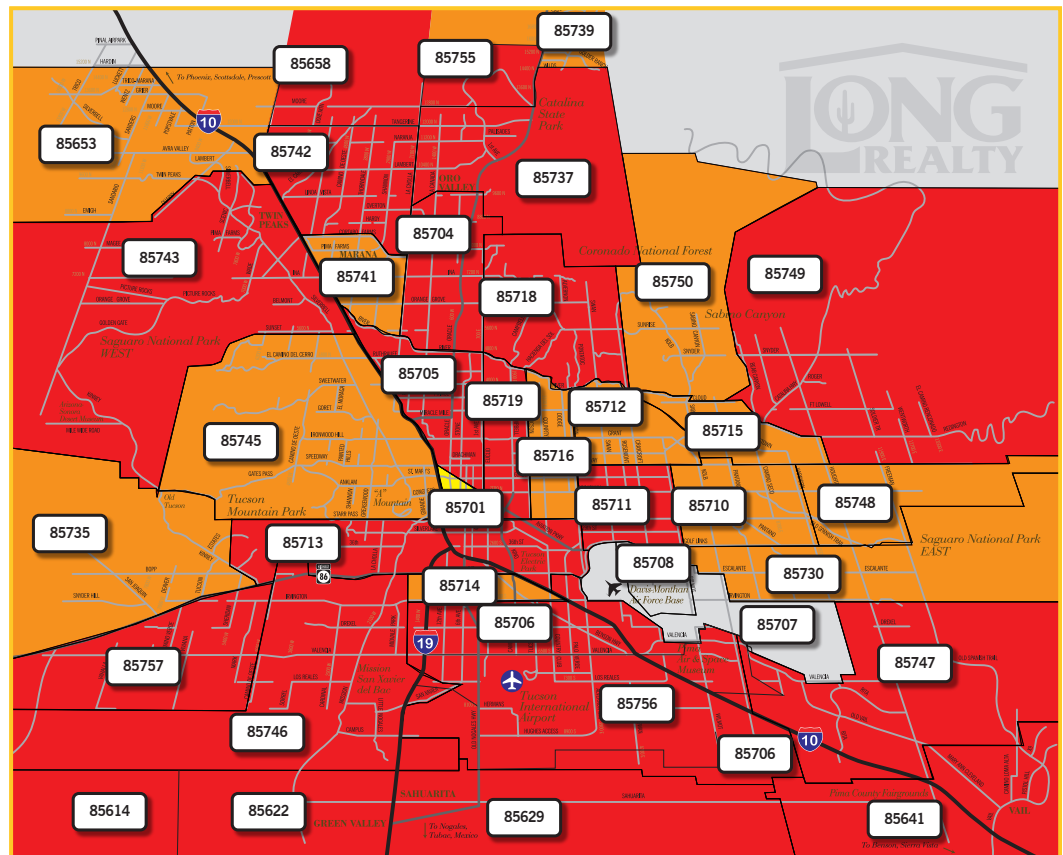
